# **Eastland Co. Outdoor Burn Ban Reinstated**

WHEREAS, the Commissioners Court has determined that circumstances present in all or part of the unicorporated area of the county creat a public safety hazard that would be exacerbated by outdoor burning;

IT IS HEREBY ORDERED by the Commissioners Court of Eastland County that all outdoor burning is banned in the unincorporated area of the county for 90 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 204.906, and other applicable statutes. This order does not prohibit outdoor burning actitivies related to public health and safety that are authorized by the Texas Natural Resources Commission for (1) firefigher training; (2) public utility, natural gas pipeline or mining operations; or (3) planting or harvesting of agricultural crops; or, (4) burns that are conducted by a prescribed burn manager under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047. Natural Resources Code.

In accordance with Local Government Code 204.906(h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.00.

ADOPTED this 24th day of July, 2006, by a vote of 4 ayes and 0 nays.

# **Community Blood Drive Sponsored By Lions Club**

A Community Blood Drive sponsored by the Lions Club will take place on Monday, July 31. The Meek Blood Center bloodmobile will be at the City Park from noon until 6:00 p.m. Those who gave blood at the drive on June 5 will be eligible to give blood. Twenty three pints of blood were donated at the drive on June 5.

"The need for blood is constant" said Frances Baker, donor recruiter. "Hospital patients require medical care every day, regardless of holidays and summer vacations. One out of every ten hospital patients receive a blood transfusion, and most of these patients require at least three pints of blood."

Blood donors must be at least 17 years old, weigh a minimum of 110 pounds and in good health. Those who have questions regarding donor requirements may call Meek Blood Center at 325-670-2798 or visit the website at www.meekbloodcenter.or.

Donors will receive their choice of a T-shirt or a cap and a total cholesterol test. Cholesterol results are available three days after the blood drive.


## **Zelma Sharp**

## **Roy Clark To Perform At 28th Annual Rehab Dinner Show**





## **DWI Defendant Sentenced To Prison For Eight Years**

Jeffery Frank Gordon, 41, formerly of Cisco, Texas, is now an inmate awaiting transfer to state prison to serve an (8) eight year sentence for the felony offense of Driving While Intoxicated. Mr. Gordon was apprehended on May 21, 2005 by a City of Cisco Police Officer on a routine traffic stop. On July 17, 2006, in the 91st Judicial District Court, a jury of twelve citizens were impaneled to hear the case. After hearing the evidence in the case and deliberating for approximately 45 minutes, the jury returned a verdict of guilty.

Gordon had been previously convicted three other times for DWI; in Callahan County in 1988, in Eastland County in 1995, and in Williamson sion and return to regular open session. Joe made a second and motion County in 2001. Because the Williamson County DWI conviction was a felony offense, the District Attorney's Office caused the Eastland County charge to be enhanced from a third degree felony to a second degree felony. On a second degree felony, Gordon faced a potential 2 to 20 year sentence.

The Honorable Judge Steven Herod of the 91st District Court sentenced Gordon to 8 years in the Texas Department of Criminal Justice - Institutional Division after hearing evidence in the punishment phase. Attorney Cade Browning of Abilene represented Gordon at his hearing with District Attorney Russ Thomason prosecuting.

The 52nd Annual Texas A&M Beef Cattle Short Course and Industry Trade Show will be held August 7th-9th in the Rudder Theatre Complex at College Station. The Beef Cattle Short Course has established itself as the focal point for the state's annual beef cattle education and training. There will be seminars, workshops and hands-on training during the three (3) day event.

Monday's featured topics will include: Basic Ranch Management covering what health issues should cow/calf producers be concerned with, cow/calf profitability, reproductive success, and simple management practices to increase value of your calves. Texas Adapted Genetic Strategies discussing cattle types and breeds, breeding systems, sire types for commercial herds, effect of body size and milk production, expected progeny differences, and selection for carcass merit. The Forage and Nutritional Management seminars will include topics on reducing the amount of hay you feed, which winter pasture is right for you...grasses or legumes, what quality hay is needed for your cattle, matching supplements to forage quality, alternative feed sources, and forage allocation. Tuesday's topics include: Beef Cattle Research in Texas, Reproductive Management in the Female with discussion on palpation, pregnancy tests, culling heifers for fertility, and benefits of defined calving seasons. Beef Cattle Health Management will cover biosecurity and the cattle producer, foreign and emerging diseases that may effect beef cattle, and weaning a healthy calf. ### A tax play that works

There's an old story about the politician who started a speech by asking the audience if he could momentarily "tax their memories." At that point, another politician stood and responded, "Why haven't I thought of that?"

The tax burden on Americans has climbed steadily throughout our history. Even so, we've managed to keep taxation and regulation lower than virtually all other industrialized democracies, and that's a major reason why the U.S. economy, year after year, is the economic engine that drives the world.

The decision to tax represents a troubling conclusion: that government knows better how your money should be spent than you do. Of course we must fund national priorities, including national security, infrastructure and a social safety net for those who need it. But we've been reminded recently that low tax levels generate more economic activity which in turn produces even more government revenue.

One of George W. Bush's earliest achievements was a series of tax cuts that has helped produce rapid U.S. economic growth and unprecedented wealth. But the move was politically divisive, and some in Congress have been trying to undo the tax reductions ever since their enactment. It's worth reviewing exactly how much these reductions have helped average Americans.

The President's original plan, in the Economic Growth and Tax Relief Reconciliation Act of 2001, reduced marginal income tax rates, softened the marriage penalty, eased the burden of the alternative minimum tax, phased out the death tax and increased the child tax credit.

Those who paid the most taxes saw the biggest savings. But a typical Texas middle-class family has since benefited more in percentage terms, saving as much as \$2,000 per year - in some cases almost eliminating their income tax liability altogether. What's more, our small businesses have seen tax rates decrease about 13 percent.

Unfortunately, because budget rules prevented the 2001 tax cuts from being made permanent; they are to be eliminated in 2010.

Sound planning, by businesses or individuals, requires certainty. But the uncertain nature of current tax law not only hinders economic growth, but also it occasionally creates personal situations that are profoundly disturbing. For example, an elderly person seeking to distribute his estate among his large family now knows that if he dies in 2010, the entire amount will go to his loved ones. But if he dies a year later, the death tax will claim nearly half for the government.

We in Congress must do everything possible to prevent the looming tax increase - if we fail to do so, the ripples will be felt across our economy. If the tax cuts are allowed to expire in four years, we will see:

\* Increased tax-rate brackets for every socio-economic level;

- \* A \$500 reduction in the child tax credit;
- \* Resumption of the marriage tax penalty;
- \* Higher taxes on dividends and capital gains; and
- \* A dramatic increase in estate and gift tax rates.

## Neugebauer Supports Traditional Definition of Marriage Measure Picks Up Nine More Votes Above 2004 Total

Washington, DC-Congressman Randy Neugebauer voted Tuesday in favor of the Marriage Protection Amendment which would support the traditional definition of marriage as the union between one man and one woman. Although the amendment garnered a strong majority of the votes in the House, it fell shy of the two-thirds majority required for passage.

During House debate over the amendment, Neugebauer defended the traditional definition of marriage. Below are excerpts from Neugebauer's speech on the House floor:

"I rise today in support of the constitutional amendment to protect the traditional definition of marriage. For thousands of years, across many countries and cultures, marriage has been the union of one man and one woman. Here in America, that definition of marriage has been the democratically-established and settled law of the land for more than two centuries.

"But in recent years, a small, but loud, segment of society has pushed to change that definition. As a result, we are here today to debate who gets to define marriage in America. Will it be the people in 45 states that have said - through the democratic process - that marriage should remain the union of one man and one woman? Or will it be a small number of activist judges who take it upon themselves to re-write the U.S. Constitution, arrogantly overturn the democratically-established will of the people, and impose their own personal beliefs on the rest of us? It is my hope that my colleagues in the House will stand up today and represent the will of the people and support the traditional definition of marriage."

The measure, which raised its vote total from 227 to 236 in a two year span, states: Marriage in the United States shall consist solely of the union of a man and a woman. Neither this Constitution, nor the constitution of any State, shall be construed to require that marriage or the legal incidents thereof be conferred upon any union other than the union of a man and woman.

## Public Utility Commission **Passes Emergency Rules**

Last Friday, the Public Utility Commission (PUC) passed emergency measures to give low-income Texans and senior citizens a break, by adopting a rule to stop utility disconnections for the summer. The emergency rule takes effect immediately and contains three main components that strengthen existing prohibitions on disconnections:

Electric providers are prohibited until October 1 from disconnecting all critical care customers (customers in which a suspension of electric service will create a life-threatening situation). These customers will be required to pay at least 25 percent of their outstanding bill starting in October with the remainder due within five months.


Electric providers are prohibited until October 1 from disconnecting all low-income customers who are at least 65 years old. These customers will be required to pay at least 25 percent of their outstanding bill starting in October with the remainder due within five months.

Low income customers under age 65 can prevent disconnection through September with a deferred plan requiring payment of no more than 25 percent of their bill. The deferred amount would be due within five months.

Under current statute, utilities cannot disconnect service on days when the National Public Weather Service issues a heat advisory for at least two days in a row after a heat advisory.

Since 2001, we've experienced major disruptions to our economy the 9/11 attacks, soaring homeland security expenses, a war on terror in Afghanistan and Iraq, a major stock-market slide, corporate management scandals, unprecedented disaster-relief expenses and rising energy prices.

Those who follow Texas high school football know well the old adage: "If you've got a play that works, run it 'til they stop you." The same strategy applies to our economy - we're racing down the field with a low tax policy. Let's keep running that play.

### **USDA Rural Development Announces** \$6.2 Million Available For RCD

USDA Rural Development State Director, Bryan Daniel, announced today the availability of more than \$6.2 million in Rural Community Development Initiative Program (RCDI) grant funds. The RCDI Program provides technical assistance and training funds to qualified intermediary organizations to develop their capacity to undertake housing, community facilities, and community and economic development projects in rural areas

"USDA Rural Development in Texas is dedicated to ensuring that local community leaders have the resources they need to assist their community in creating new economic opportunities and improving their quality of life," said Daniel. "The Rural Community Development Initiative Program is one of the instruments we can utilize to provide them with this service."

The \$6,286,500 in RCDI grant funds are available to intermediaries and have a dollar for dollar matching fund requirement, intended to double the impact of the grants. Qualified organizations can be public or private that have been legally organized for at least three years and have experience working with eligible recipients. Recipients of the funds from the intermediary can be non-profit organizations, low-income communities, or federally recognized tribes.

Electric customers qualifying for the low-income plan have a household income at or below 125 percent of the federal poverty guidelines, or receive Medicaid or Food Stamps from a Texas state agency. Eligible customers are required to contact their electric providers to prevent disconnection. These customers will not be charged late fees on bills dated through Sept. 30.

The new rule applies to residential customers of retail electric providers in competitive areas and to residential customers of regulated investor-owned utilities. It does not apply to municipal electric utilities and electric cooperatives. However, the PUC encourages these providers to consider adopting similar rules.

"People need to be financially responsible by paying their bills, however, utility prices have drastically risen due to the overwhelming heat that hits the pocket book hard," said Texas House Representative Jim Keffer (R-Eastland). "If a person is struggling, I would encourage them to contact their retail electric provider and seek assistance programs that may be offered in helping them pay their electric bill. Also, the utility companies can provide customers with information on low and no-cost measures for saving energy and reducing their electric bill."

U.S. Trade Negotiators Reject Bad Deal for Agriculture

In news that will be of interest to our agriculture industry, World Tra Organization (WTO) negotiations have been put on hold after no agree ment could be reached. Our trade team made the right decision to walk away from the negotiating table at this time. A close look at the proposals from other countries shows that they were full of loopholes and would have resulted in little or no market access gains. We had the most ambitious offer on the table, but the U.S. was still told it was not enough.

I want to commend our trade team for listening to members of the House Agriculture Committee and to American farmers by not committing to a deal that would have been bad for U.S. agriculture. Before these latest negotiations got underway, Agriculture Secretary Mike Johanns and U.S. Trade Representative Susan Schwab met with me and other Committee members. We told them that no deal is better than a bad deal. It is clear from the outcome of the talks that they took our words to heart and stood up for American agriculture.

As of right now, it is unknown when the trade talks will resume. Good trade agreements have potential to open new markets for U.S. farmers and ranchers and break down barriers that deny our producers opportunities to find new customers, and I will continue to support trade when we make good deals. The United States has one of the most open markets in the world, and we should continue to negotiate agreements with other countries willing to work with us.

### Sunset Commission Could Help Reduce Wasteful Spending

Former President Ronald Reagan once stated that "the nearest thing to eternal life we will ever see on this earth is a government program." After serving several years in Congress, I see that there was a lot of truth in that statement. It is for that reason, that I am a strong supporter of legislation that will likely be voted on by the House this week. This legislation, H.R. 3282, establishes a "sunset commission" that would consist of 12 members, with equal representation from both political parties and both houses of Congress. The job of the commission will be to review all federal agencies in order to evaluate the efficiency and usefulness of each agency. Each agency would then be up for review at least once every 12 years. Experience at the state level of government shows that a sunset commission would prove to be a valuable tool in reducing the deficit. In fact, Texas, which is one of 24 states to use this tool, has saved \$750 million by sunsetting 52 obsolete state agencies. I hope that Congress gets behind this common sense proposal that will enable us to reduce the amount of waste, fraud and abuse in the federal government.
