



# FSA County Committee Nominations Start June 15

The USDA Farm Service Agency (FSA) announces that county committee election nominations begin June 15, 2011. Farmers, ranchers and landowners are encouraged to nominate farmer and rancher candidates to serve on their local FSA county committee by the August 1, 2011 deadline.

Elected county committee members serve a three-year term and are responsible for making decisions on FSA disaster, conservation, commodity, and price support programs, as well as other important federal farm program issues.

County committee members are a valuable asset because they are local producers who participate in FSA programs themselves and have a direct connection to farmers and ranchers in the community. We would like to see a high level of participation in this year's nomination and election process.

Producers may nominate themselves or others as candidates. Organizations that represent minority and women farmers and ranchers may also nominate candidates. Nominees must participate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area (LAA) in which the person is a candidate. To become a nominee, eligible individuals must sign form FSA-669A. The form and more information about county committee elections are available online at: www.fsa.usda.gov/elections.

It is important that the county committee reflects the demographics and agricultural interests of the community these individuals represent. We strongly encourage all producers, including women, minority and beginning farmers and ranchers to participate in the nomination and election process.

County committees are comprised of three to five members elected by local producers. All newly elected county committee members and alternates will take office January 2, 2012.

Nomination forms must be postmarked or received in the local USDA Service Center by close of business on August 1, 2011.

This year's election will be held for LAA 3, which is the southwestern portion of the county. LAA 3 has been served by Brandon Geye for the past nine years. Because Mr. Geye has reached his term limit, he won't be eligible for re-election.

MAY 5, 2011

The Gorman City Commission met on the above date. Those present were Mayor Robert Ervin, Commissioners David Stanley, and Durward Webb. Those absent were Commissioners Nathan Files and Joe Casey. Others attending were Jerry Huffman DPS-TDEM, Emit Lopez TDEM, Tera Gortt, Stephen Watson, Phillip Arther, Vicki Seay, Charlie Torrez, Cecil Funderburgh, Mark Pipkin, Ron Holiday, Terry Simmons, Jody Forbus, Jimmy Guthery, Glenn Scitern, Barbara Fenley, and Doyle Rone.

Durward led the opening prayer followed by the Pledge of Allegiance and the Texas Pledge.

Mayor Ervin called the meeting to order at 5:30 p.m. Durward made the motion to approve the minutes with correcting the word opened to opening in paragraph 11. David made

a second. Motion carried.

After looking over the bills and bills report Durward made the motion to approve for payment with a second from David. Reports were submitted by department heads. Curtis and Leland have started the pool repairs.

New and old business, Robert and Curtis will try to get with Bill Miears and look into the sewer line situation at residence. Glenn made note that the line definitely needs to be replaced, but there is also a water line, gas line and a phone line all right there together.

Jerry Huffman DPS-TDEM, Emit Lopez TDEM, Stephen Watson Gorman VFD, Phillip Arther Eastland FD, Charlie Torrez Gorman VFD, Cecil Funderburgh Eastland PD, Mark Pipkin City of Eastland, Ron Holiday City of Eastland, Terry Simmons City of Eastland, Jody Forbus Carbon VFD, Jimmy Guthery Gorman VFD, and Doyle Rone DeLeon VFD were present to express their su port of the City of Gorman being interested in taking the responsibility of being the municipality single point of contact for the Fix Management Assistance Grant Program (FMAG). This is a grant program which will provide funding measures for those affected by the Sid Waynick Fire (323) which took place on April 15, 2011. Funds can be made available to the departments affected by the efforts put forth fighting this fire. After Mr. Huffman, Mr. Lopez and Mr. Watson gave a description of the program and procedures, David made the motion to allow the City of Gorman to be the municipality point of contact and administrator of the FMAG and to have Tacy Warren and Jill Rainey open an account at American State Bank for FMAG proceeds to be deposited for future disbursements. Durward made a second to the motion. Motion carried.

Durward expressed some worries or issues on the heighth of fencing in residential areas in Gorman. State law has no ruling on how tall a fence in the front of a residence can be, but a city can regulate heighth by ordinance. This will be on the next agenda.

No action was taken on the water tower repairs or companies. No decisions, place item on next agenda. No action was taken on the Historical item for school property. This will be on the next agenda also.

The 1st reading of Ordinance #2011-01, an ordinance adopting a budget for the City of Gorman for the fiscal year 2011-12 was read at this time.

At 6:40 p.m. David made the motion to go into Executive Session with a second from Durward.

At 7:03 p.m. David made the motion to go out of Executive Session and return to Regular Open Session. Durward made a

second. Motion carried.

The municipal judge and commissioners talked things over and no action was necessary.

There being no further items for discussion Durward made the motion to adjourn with a second from David. Motion carried, time was 7:10 p.m.

# A Letter To The Editor - Will Jesus Come Again? By Henry A. Buchanan

The Second Coming — the Hope and Fear of the church — has tantalized the minds of believers for twenty centuries. The belief of a return appeared as soon as He died. It was the first thing I heard on my first visit to a Baptist church in Texas. Either because of disappointment, or out of unrealistic expectation, His followers have never accepted His last words "It is finished" when he died on a Roman cross outside the city of Jerusalem. "No!" His followers have insisted. "There must be more."

And the answer to the question about a return must be "Yes, But." He has come; He is here; He will come so long as the Hope is realized historically in the mind of His followers. But mythically because His coming is not an event that can be reported in the newspaper and recorded in the history books, and must always be both imminent and futuristic, an immediate hope yet to be realized but always leaving those who hope with a sense of disappointment because waht they hoped for was not realized in the way they had hoped and expected.

This should not be suprising because when He came and walking and preaching and healing with his close followers, the expected something that did not happen. They expected a Messiah in the form of a Son of David who would overthrow the Roman Empire and instead the Roman power nailed Him to a cross and railed at Him because even Rome believed that what he had come to do was reestablish the Davidic rule.

The belief among His close followers was so strong that they saw Him, heard Him speak, broke bread with Him and wondered at what had happened to them. When a terrific strom coincided with their celebration of Pentecost they were convinced that He had come in Spirit, and certain Christ-like figures — Gandhi, Martin Luther King, Lincoln, and Mother Teresa — have appeared in our history as evidence to the believers that the mythical has become for a moment historical. In most cases society has dealt with those figures the way society dealt with Jesus of Naxareth, and in all caes these figures achieved only a part of what was hoped for and left the scene of history to become mythical figures capable of keeping the Hope alive.

The question now becomes not only what happens to us when a Christ-like person does appear among us? But what happens in the aftermath of such an event in human history?

Such a person is always viewed as both good and evil, depending on who is looking him, as was the case of Jesus of Nazareth. The British did not see Gandhi the way the impoverished people of India saw him. Lincoln is seen as Liberator by the black slaves, but not be those who fought and died to oppose him.

What remains then is that on Easter we the church reenact His appearance on Earth, then we settle down to paying off the building fund of the church and a big drive is put on to build the membership.

But for a few of us, who walk with Him on mythical ways that change history, He has returned and the Glory of His presence shines on our faces.



Separate crescent dough into triangles, and lay on wax paper.
 Spread each with creamed cheese.
 Place three grapefruit seg-

ments on wide end of each triangle; roll each triangle into crescent shape enclosing grapefruit segments.

6. Combine 1/4 teaspoon cinna-

mon and 1 tablespoon sugar on waxed paper; roll grapefruit crescent in cinnamon sugar; Place on a parchment-lined cookie sheet.

7. Bake for 25 minutes or until golden brown.

8. Finely chop remaining grapefruit segments; place in small bowl with three tablespoons sugar, sour cream and maple syrup. Cook in microwave on high for about one to two minutes, or until it starts to boil.

Drizzle sauce over crescents, or serve as a dipping sauce.
