Tides in the Bay of Fundy. Tides in the Bay of Fundy is noted for its high tides. At the head of the bay a samaquoddy bay, which indents New Brunswick near the border of the state of Maine, a rise of 25 feet is not un-formmon. At St. John the rise varies from 20 to 27 feet. At Moncton the tide rushes up the estuary a crest or wave of water from 3 to 6 feet high. At most places the tide rises gradually, but not slowly, each wave rolling up proceeding one. There are two high tides in every 24 hours. For instance, say at 10 o'clock in the forenoon and 10 at hight, and on the following day the two high tides will be one hour later, and so on.




