### Saul Pullman **Announces For** Judge of 91st Dist.

Saul Pullman has announced that he will be a democratic candidate for Judge of the 91st District Court of Eastland County, Texas. He has appointed himself as campaign treasurer at P. O. Box 709, Eastland, Texas 76448.

Saul Pullman, is a native of Eastland, Texas and has spent most of his life in Eastland County, Texas. He was born on November 28, 1940 in Eastland, Texas and grew up in Eastland, Texas. He graduated from Eastland High School in 1958. His parents are Henry and Tillie Pullman.

During his High School days, Saul was both an outstanding student and athlete. In addition to lettering in Football and Track, he was a member of the Eastland High School Band. During his senior year, Saul was selected as a All-State football player and twice attended the Texas State High School Track meet, where he ran the 100, 220 and 440 yard dashes. He was a Boy Scout and obtained the rank of Eagle

After high school, Saul entered Texas Christian University where he graduated with a Bachelor of Science in Commerce degree. He attended college on a football scholarship and participated in football and lettered in each. He is presently active with the TCU Ex-lettermen's Association.

After college Saul attended St. Mary's Law School in San Antonio, Texas for one year and then transferred and attended the University of Texas Law School and upon completion received his law degree. While attending Law School he was a member of the Phi Alpha Delta Law Fraternity and served as student advisor for the University of Texas Legal Aid Clinic. After graduation he was admitted to the State Bar of Texas in 1965.

After being admitted to the State Bar of Texas, Saul worked for the Texas Highway Department as a Right-of-Way Agent. His duties were to acquire title to land for the construction of Interstate Highway 20 through Eastland County, Texas. After serving in this capacity for two years he opened his law office in Eastland, Texas for the private practice of law, which he has maintained until the present.

Saul attained the rank of Captain, with the 1st Judge Advocate General Detachment of the United States Army Reserve. He received a Honorable Discharge after serving eight years.

Saul has long been an active member of the Democratic Party, the Eastland Rotary Club, the American Legion, and the Eastland County Bar Association. In 1988 he was appointed as the Eastland County representative on the Board of Directors of the Central Texas Mental Health and Mental Retardation Center located at Brownwood, Texas. After two years of service he was elected Chairman of the Board, a position which he currently holds. He was appointed and currently serves on the board of the Texas Council of Community Mental Health and Mental Retardation Center in Austin, Texas.


