

These constitutional county courts generally hear the probate cases filed in the county. These courts have original jurisdiction over all class A and class B misdeameanor criminal cases. Article 4.17 of the Code of Criminal Procedure, reference transfer of certain misdemeanors, on a not guilty plea before a non-attorney county judge, the judge may transfer the case to a district court having jurisdiction in the county, or to a county court at law in the county. ## Peanut Referendum

Texas peanut producers subject to paying the assessment may also vote on a proposition to limit the refundable peanut assessment rate not to exceed \$4 per net ton for quota and \$3 per net ton for additionals, farmers stock peanuts. Such assessments to be collected at the point of first processing or sale on a "refund only" basis. Such funds are to be used for funding programs of research, education, promotion and market development. All Texas counties are within the proposed referendum area.

The election and referendum will be held under provisions of the "Texas Commodity Referendum Law." Ballots and return envelopes are available in each peanut-producing county extension office April 16 through April 30, 1998 during regular business hours. Ballots may also be requested from the Texas Peanut Producers Board, P.O. Box 398, Gorman, TX 76454, tele-





declared invalid or unconstitutional for any reason, it shall not invalidate or impair the validity, force or effect of any other section or sections or part of a section or paragraph Section 5: This ordinance shall become effective immediately upon its adoption

and approval, and it is so ordained.

#### HOMESTEAD EXEMPTIONS AVAILABLE

Eastland County property owners wishing to sign up for 1998 property tax exemptions and / or special use valuations may obtain the necessary applications at the office of the Eastland County Appraisal District. The Appraisal District office is located on the second floor of the Eastland County Courthouse, Eastland Texas. The necessary application may be requested by telephone by calling the Appraisal District office at 629-8597.

There are numerous property tax exemptions and / or special valuations available through the Texas Property Tax Code. A partial list of those available is given at the end of this article. If a property owner has a question as to his or her eligibility; they should contact the Eastland County Appraisal District for assistance.

Home owners can take advantage of the partial homestead exemptions available. As much as \$15,000 in value can be applied to your school district taxes if you qualify for the residential homestead exemption. The completed exemption application must be filed by May 1, 1998. This exemption does not have to be re-applied for each year. If the residential home owner still resides in the same house for 1998 that he or she lived in last year; and they received a homestead exemption for 1997; they do not need to re-apply for 1998

An exception to this would be a person who received the regular homestead exemption in 1997; but has turned sixty-five (65) years of age during the 1997 year. This person would need to re-apply as he or she would now be eligible for an additional or increased exemption in an amount available to those over sixty-five (65) years of age. Due to recent changes in the tax code, you should contact the Appraisal

District for information if you turn 65 years of age during the year. You may be eligible for an increased exemption amount for the current year.

If you have a question as to whether you are receiving a homestead exemption or as to your eligibility for one of the available exemptions or special valuations; please contact the Eastland County Appraisal District for information and assistance.

Among the partial exemptions and / or special valuations available are: Residential Homestead, Over-65 Residential Homestead, Residential Disabled or Disability Exemption, Disabled Veteran and Special Valuation of Open Space Land (Ag-Use)

#### SPECIAL AGRICULTURAL VALUATION AVAILABLE

The following information is provided to property owners within Eastland County in compliance with publication requirements of the Texas Property Tax Code.

If you are the owner of land that is being currently used for some type of Agricultural use or activity; you may qualify your land for a special use valuation for Ad valorem tax purposes.

Landowners who have not already filed must file for special use valuation with the Eastland County Appraisal District by April 30, 1998. The Texas Constitution provides for two (2) types of Agricultural productivity appraisal. Article 8, Sec. 1-d-1 allows what is known as Open Space Land appraisal; while Article 8, Sec. 1-d allows agricultural use appraisal. The requirements for applying and qualifying both the land and the owner are different for each of the two types.

Most property owners apply for the 1-d-1 or Open Space appraisal. This special appraisal requires that the land's use in a qualifying agricultural endeavor meets the degree of intensity generally accepted in the area. The owner must show that the land's use is devoted principally to agricultural use and that it has been for at least five (5) of the preceding seven (7) years.

Landowners should be aware that the law does require a rollback to be incurred when the qualified land is taken out of agricultural use. The rollback tax includes the difference between the taxes paid under agricultural appraisal and the taxes that would have been paid if the land had been on the tax roll at market value. The law also requires that the rollback tax include interest charges of seven (7) percent per year.

The application must be submitted on a form prescribed by the Property Tax Division of the State Comptrollers office. The application must contain the information necessary to determine the validity of the application.

To apply for the Open Space Land valuation or the Agricultural Appraisal use valuation on your land; you should contact the Eastland County Appraisal District.

The filing deadline for this and other available special valuation is April 30, 1998.
