



#### A&M chemists tackle nuclear waste clean-up

COLLEGE STATION - The federal government has a problem what to do with 65 million gallons of nuclear waste, enough to fill 2,000 swimming pools.

Texas A&M University chemists may have a solution. They have developed a way to remove the most potent radioactive elements from the waste, making disposal easier and cheaper. The waste sits at the Hanford Processing Site in Washington state, and it has started to cause problems.

"A lot of the tanks are starting to leak into the environment," said Elizabeth Behrens, a Texas A&M. doctoral student. "The government is looking for ways of economically reducing the volume of waste and disposing of it in a safe manner, so it won't create any more environmental damage or harm to the pub-

The production of nuclear weapons at Hanford left behind highly radioactive forms of the elements strontium and cesium. This waste was dumped into steel tanks and half-buried on the processing site. The tanks have started leaking. Strontium is slowly contaminating groundwater, Behrens said, posing a threat to humans and wildlife.



### WHY SOCIAL SECURITY NEEDS SAVING

(Part I of II)

he looming Social Security crisis is more than a financial crisis — it is a potential human tragedy which will force us to choose between economic opportunity for our children and retirement security for our parents.

If allowed to run its course, the exploding cost of the program will become the greatest financial crisis in American history. If Social Security solvency is preserved sim-

ply by raising taxes and cutting benefits, the bill will exceed the combined cost of all the wars fought in America's history.

gram from a system based on taxes and debt to a system based on investment and wealth. But before we get to the solution, let me outline the problem.

At the heart of the impending crisis is the fact that fewer and fewer workers are available to finance the retirement of more and more retirees. In 1937, 42 workers contributed two percent of their first \$3,000 of wages to pay benefits for each retiree. By 2028, two workers will each have to pay 17.6 percent of their wages to fund Social Security benefits for a single retiree. At that point, the economic opportunity of children and grandchildren will be pitted against the financial security of their parents and grandparents and everyone will lose.

Americans were told that they would build up an investment fund that would be used to finance their retirement. Senator Pat Harrison of Mississippi, Chairman of the Committee on Finance, which wrote the Social Security Act, said that "besides the saving to the Nation as a whole, the annuity system will give to the worker the satisfaction of knowing that he himself is providing for his old age."

Unfortunately, the legislation never matched the rhetoric of the politicians who sold it. No investments were ever made. No wealth was ever Washington to announce his government is launching a publicity campaign created. No interest was ever earned.

to pay future retirement benefits to the worker who is paying the taxes. Most customs officials to fully implement the \$400-a-month allowance. of the money is used to provide benefits to today's retirees and government spends the rest on unrelated programs.

In the past, the solutions have been simple: raise taxes or cut benefits. Now, if we choose higher taxes, a tax rate that was two percent on our grandparents will be 18 percent for our children. With Medicare added in, the

payroll tax will almost certainly exceed 30 percent. Choosing higher taxes means our children and grandchildren's future will be marked by crumpled resumes, rejection notices and pink slips. It will be jobs they hoped for but didn't get, raises they needed but were denied and new system fully operational by the end of the year. The publicity campaign advancements they earned but co uldn't achieve.

And cutting benefits means our parents' future will be filled with discarded financial plans and bill collectors. It will be dream vacations canceled allowance for alcohol and tobacco products for residents of its border zone and simple enjoyments abandoned.

There is a better way. It requires doing what Social Security promised but never achieved. It requires that we employ one of the fundamental principles outlined by Franklin Roosevelt for Social Security: "Compulsory contributory annuities which in time will establish a self-supporting system for those now young and for future generations."

It requires that we save and invest now rather than tax and borrow later. But it is not just money at stake here. Save today and we save our children's citizens to buy American products and take them home will make free trade dreams tomorrow. Invest today and we invest in our parents' security.

> In contrast, American shoppers returning to the United States from Mexico are allowed to bring in \$400 worth of duty-free goods per month. So, it is fair to say, import-export parity along the border was a matter of theory rather than practice.

> The \$50 rule was one of the first issues I tackled when I came to the Senate four years ago. I am happy to report that finally, we have made some headway toward achieving equitable treatment of goods on both sides of the border. But it was very slow going at first.

After lengthy negotiations with the Mexican government, and a personal meeting with the President of Mexico, the first break came in 1995, when Back in 1935, when Congress passed the Social Security Act, the debate Mexican law was changed to allow Mexican nationals a \$400-a-month dutyfree allowance — the same allowance Americans returning from Mexico

Trouble was, word never got out. News of the more generous law never reached Mexican customs stations along the border. Mexican shoppers returning from El Paso to Juarez, from Brownsville to Matamoros or from Laredo to Nuevo Laredo were still being charged duty on what they purchased in the United States if worth more than \$50.

But on April 22, we saw a real break in that border commerce logjam. Mexican Customs Administrator General Luis Carlos Moreno came to to get the word out on the new, more generous duty-free allowance, and to Today, none of the taxes paid into the Social Security system are set aside unveil a new duty-free electronic tracking system which will allow Mexican

The card-and-scanner system will allow Mexican customs officials to track individual and family purchases for Mexicans who cross into the United States to shop. It will expedite the ability of Mexican border residents to utilize their \$400 monthly personal duty exemption as provided for by

Merchants on the American side should experience a real boost once this system is completely on line. Pilot projects already are under way in Juarez

I expect the Mexican government to honor its commitment to have this advising Mexican citizens of their rights has already begun.

In addition, Mexico has agreed, beginning in June, to create a duty-free Mexicans living within a 25-kilometer area adjacent to the border. U.S. citizens currently can return home with one liter of spirits and two cartons of cigarettes duty free. Previously Mexico did not provide any parallel benefits for its border residents, citing legitimate concerns about smuggling. To address those concerns, the United States has agreed to work to provide specific information required by Mexico, through cooperative programs and the creation of a common trade data system, to detect and prevent smuggling.

Today it looks like the \$50 rule is on its way out. Parity for Mexican a reality — at last — for ordinary consumers and border retailers.


