## Desdemona Thanksgiving Panthers Edged by Tolar; Play Bronte On Saturday

The Gorman Panthers played their hearts out at Tolar on Friday night in terrible weather but came up short at the end of the battle when they were forced to try and convert a 2 point play from the 18 yard line after being hit with an untimely penalty for celebrating in the end zone after Blake Guthery had raced for 68 yards for a TD to get the Panthers to within 2 points. This untimely call assessed the penalty on the points after play, which was a very bad call by the official. According to a new rule celebrating is marked off on the extra point instead of on the ensuing kickoff.

Gorman moved 59 yards on 4 plays after getting a Rattler fumble on the Tolar 41. Following an incomplete pass, Cody Foster tossed a 35 yard pass to the Tolar 6. They Guthery get 4 to the 2 yard line. Then with 9:44 left in the first, Margarito Sanchez ran it in from 2 yards out and Gorman led 6-0. But the Panthers failed on the point after as was the case all evening with the wet and slick ball.

Following a Panther fumble on the Gorman 25 the Rattlers moved for the tying score on 4 plays with the rattlers completing a pass for 15 yards with 6:02 left. The kick try failed and the score was tied.

Then following a short punt and a 10 yard runback by the Rattlers. Tolar completed a 16 yard pass play to Layne in the end zone with 7 seconds left in the half. The kick for point after also was good and Tolar was up 13 to 6.

Gorman came back on the first series after intermission and set the ball up at their own 39 and cranked up a drive of 61 yards in 8 plays with Cody Foster scoring from 16 yards out with 7:53 left in the third. The drive featured runs of 9, 3 and 6 by Sanchez and a 28 yard blast up the middle by Guthery. Again the point after kick

failed and the score was 13 to 12. Following the Gorman score the Rattlers came back with a 75 yard drive in 6 plays when they scored from 10 yards out with 5:27 left in the third. The drive featured one run of 25 and a pass play for 20. The point after kick made the score 20 to 12.

Bad luck hit the Big Red again when they started a drive from their own 33 and moved to the Rattler 5 yard line before the snap was fumbled at the 5. The drive featured a 40 yard run by Guthery, 3 runs of 7, 4 and 2 by Sanchez. The fumble came on third down at the Tolar 5.

Then after a run of no gain, the Big Red defense recovered a fumbled pitch out in the end zone by David Seaton and Gorman moved to within 2 at 20 to 18. The Panthers tried a 2 point play but the try failed with 1:44 left in the 3rd.

Again Tolar answered with Panther score with a drive of 64 yards in 7 plays with an 18 yard run with 10:05 left. The kick failed for point after and Tolar was up 26 to 18.

The Panthers came back with a fantastic bruising run of 68 yards following a Rattler punt at the Gorman 32. Guthery hit the middle, escaped a Rattler linebacker, then raced the distance score. This was when the Panthers were hit with the untimely penalty after the score. The score was 26 to 24 and the Panthers had to try for 2 point play to tie. But the referee hit the Big Red with a 15 yard penalty and the Panthers were forced to try the 2 point conversion from 18 yards out. The try failed and the final score was 26 to 24 and gave the Rattlers the 14-A Championship and a tie with Gorman, who will represent District 14-A as the runner-up and will meet the Bronte Longhorns, winner of District 13-A, this Saturday night at 7:30 at Wylie Stadium, just off of Buffalo Gap Road in Abilene. This should be a real battle as the Longhorns have a very good team and an 8-2 season mark, same as the Panthers at 3:45 on Saturday. the Panthers.

Guthery led the Panthers with 157 play.





#### USDA Pays Texas **Farmers**

Eastland County FSA-David Martin As of Nov. 5th, the USDA began making \$254.6 million in payments to

Texas farmers to help offset heavy losses resulting from low commodity prices.

The payments will be issued only to those farmers who were eligible under the 1996 Farm Bill for fiscal year (FY) 1998 final Production Flexibility Contract (PFC) payments, sometimes called market transition payments.


A total of \$2.8 billion is being provided in relief payments to farmers across the country. Although \$3.057 billion was appropriated for the payments, Congress mandated that \$200

million be made available for assistance to dairy farmers. As a result, individual farmers will receive about 49.72 percent of their total FY 1998 PFC pay-

"Farmers don't have to file an application to receive these payments," said Martin. They will be automatically paid to eligible farmers."

USDA intends to make announcements about other provisions in the relief package, including disaster relief, in the upcoming weeks.

AN ORDINANCE ADOPTING CURFEW HOURS FOR MINORS; DEFINING TERMS; CREATING OFFENSES FOR MINORS PARENTS, AND GUARDIANS OF MINORS, AND BUSINESS ESTABLISHMENTS PROVIDING FOR ENFORCEMENT BY THE POLICE DEPARTMENT, PROVIDING FOR WAIVER BY THE MUNICIPAL COURT OF JURISDICTION OVER A MINOR WHEN REQUIRED UNDER THE TEXAS FAMILY CODE; PROVIDING FOR REVIEW OF THIS ORDINANCE TWELVE MONTHS AFTER THE DATE OF INITIAL ENFORCEMENT; PROVIDING A PENALTY; PROVIDING A SEVERABILITY CLAUSE; PROVIDING N EFFECTIVE DATE; PROVIDING AN OPEN MEETING CLAUSE; WAIVING THE RULE REQUIR-ING THE READING OF ORDINANCES ON TWO (2) SEPARATE DAYS; AND DECLARING AN EMERGENCY.

ORDINANCE NO. 004-97

Organizational Float

WHEREAS, the City Commission has determined that there has been an increase in juvenile violence, juvenile gang activity, and crime by and against persons under the age of 17 in the City of Gorman.

WHEREAS, persons under the age of 17 are particularly susceptible by their lack of maturity and experience to participation in unlawful and gang-related activities or are likely to be victims of crime committed by adults or other youths;

WHEREAS, the City of Gorman desires to provide for the protection of minors from each other and from other persons, to promote parental control over and responsibly for children, in order to protect the general public, and reduce the incidence of juvenile criminal

WHEREAS, a curfew for those under the age of 17 is in the interest of the public health, safety, and general welfare and will help to attain the foregoing objectives and to diminish the undesirable impact of such conduct on the citizens of the City of Gorman. NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GORMAN, TEXAS, THAT:

Part 1: The following curfew requirements for minors are hereby adopted:

**CURFEW HOURS FOR MINORS** 

(a) Definitions: In this ordinance, the words and phrases listed below have the meanings provided herein: (1) CURFEW HOURS means:

(A) 11:00 p.m. on any Sunday, Monday, Tuesday, Wednesday, or Thursday until 6:00 a.m. of the following day; and (B) 12:01 a.m. until 6:00 a.m. on any Saturday or Sunday; and

(C) while school is in session, 8:30 a.m. until 2:30 p.m. on Monday, Tuesday, Wednesday, Thursday, and Friday. (2) EMERGENCY means an unforeseen combination of circumstances or the resulting state that calls for immediate action. The term includes, but is not limited to, a fire, a natural disaster, an automobile accident, or any situation requiring immediate action to prevent serious bodily injury or loss of life.

(3) ESTABLISHMENT means any privately owned place of business operated for a profit to which the public is invited, including by not limited to any place of amusement or entertainment.

(4) GUARDIAN means:

(A) a person who, under court order, is the guardian of the person of a minor, or

(B) a public or private agency with whom a minor has been placed by court. (5) MINOR means any person under 17 years of age.

(6) OPERATOR means any individual, firm, association, partnership, or corporation operating, managing, or conducting any establishment. The term includes the members or partners of, an association or partnership and the officers of a corporation.

(7) PARENT means a person who is:

(A) a natural parent, adoptive parent, or step-parent of another person; or (B) at least 18 years of age and authorized by a parent or guardian to have the care and custody of a minor. (8) PUBLIC PLACE means any place to which the public or a substantial group of the public has access and includes, but is not

limited to, streets, highways, and the common areas of schools, hospitals, apartment houses, office buildings, and shops. (9) REMAIN means to: (A) linger or stay; or (B) fail to leave premises when requested to do so by a police officer or the owner, operator, or other person in control of the

(10) SERIOUS BODILY INJURY means bodily injury that creates a substantial risk of death, serious permanent disfigurement, or protracted loss or impairment of the functions of any bodily member or organ. (1) A minor commits an offense if he or she remains in any public place or on the premises of any establishment within the city curfew

(2) A parent or guardian of a minor commits an offense if he or she knowingly permits, or by insufficient control allows, the minor to remain in nay public place or on the premises of the establishment during curfew hours.

(3) The owner, operator, or any employee of an establishment commits an offense if he or she knowingly allows a minor to remain upon the premises of the establishment during curfew hours.

(1) It is a defense to prosecution under Subsection (b) that the minor was:

(A) accompanied by the minor's parent or guardian;

(B) on an errand at the direction of the minor's parent or guardian, without any detour or stop;

(C) in a motor vehicle involved in interstate or intrastate travel; (D) engaged in an employment activity, or going to or returning home from an employment activity, without any detour or stop;

(E) involved in an emergency;

(F) on the sidewalk abutting the minor's residence or abutting the residence of the next door neighbor if the neighbor did not complain to the police department about the minor's presence;

(G) attending an official school, religious, or other recreational activity supervised by adults and sponsored by the City of Gorman a civic organization, or another similar entity that takes responsibility for the minor, or going to or returning home from, without any detour or stop, an official school, religious, or other recreational activity supervised by adults and sponsored by the City of Gorman, a civic organization, or another similar entity that takes responsibility for the minor,

(H) exercising first amendment rights protected by the United States Constitution, such as the free exercise of religion, freedom of speech, and the right to assembly; or

(I) married or had been married or had disabilities of minority removed in accordance with Chapter 31 of the Texas Family Code. (J) a student in a private or parochial school, including a home school, or any other student, who is exempt from the compulsory attendance requirement under section 21.033 of the Texas Education Code.

(2) It is a defense to prosecution under Subsection (b) (3) that the owner, operator, or employee of an establishment promptly notified the police department that a minor was present on the premises of that establishment during the curfew hours and refused to leave.

Before taking any enforcement action under this section, a police officer shall ask the apparent offender's age and reason for being in the public place. The officer shall not issue a citation or make an arrest under this section unless the officer reasonably believes that an offense has occurred and that based, on any response and other circumstances, no defenses in Subsection (c) is present. In assessing punishment for either a minor or a parent, the Municipal Court Judge may consider a community service

(1) A person who violates a provision of this ordinance is guilty of a separate offense for each day or part of day during which the violation is committed, continued, or permitted. Each offense, upon conviction, is punishable by a fine of not more than \$500.

(2) When required by Section 51.08 of the Texas Family Code, the municipal court shall waive original jurisdiction over a minor who violates Subsection (b) (1) of this section and shall refer the minor to juvenile court.

Part 2: The declarations, determinations, and findings declared, made and found in the preamble of this ordinance are hereby adopted, restated and made a part of the operative provisions hereof.

Part 3: If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or

application, and to this end the provision of this ordinance are declared to be severable. Part 4: This ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Gorman, Texas, and it is accordingly so ordained.


Part 5: That twenty-four months after the effective date of this Ordinance, this Ordinance shall expire and be of no further force and

effect. That twelve months after the effective date of this Ordinance, the Chief of Police shall review this ordinance and make a report of his or her recommendations to the City Commission concerning the effectiveness of and the continuing need for, a curfew ordinance. Part 6: It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as

required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act. Part 7: That the requirements imposed by the Charter of the City of Gorman that this ordinance be read on two (2) separate days shall be waived by the affirmative vote of four (4) members of the City Commission to pass this ordinance through more than one reading on a single vote.

Part 8: That an emergency is apparent and is hereby declared to exist for the immediate preservation of the public health, safety, and general welfare, which emergency requires that this ordinance become effective immediately upon its passage.




