USDA Announces Price Support Levels For '99

The U. S. Department of Agriculture today announced the average price support levels by type, quality, and location for the 1999 peanut crop. These levels are based on national price support levels of \$610.00 per short ton for quota peanuts and \$175.00 per short ton for additional peanuts.

The quota price support level by type for an average grade ton of 1999 crop peanuts will be:

\$602.68 for Virginia-type peanuts

\$613.87 for Runner-type peanuts

\$572.18 for Spanish-type peanuts

\$602.68 for Valencia-type peanuts from the southwest area which are suitable for cleaning and roasting, and, \$572.18 for other Valencias.

The method of computing the price support levels for 1999-crop peanuts and the grades within the types is the same as last year.

For each percent of sound mature kernels in a ton, including sound split kernels, the price support level will be:

Virginia-type peanuts, \$8.735;

Runner-type peanuts, \$8.564;

Spanish-type peanuts, \$8.521;

Valencia-type peanuts in the Southwest area which are suitable for cleaning and roasting, \$8.943; Other Valencias, \$8.521.

The loan value for additional peanuts is 28.69 percent of the applicable quota price support level. The factor represents the ratio of the \$175.00 per short ton average national price support level for additional peanuts to the \$610.00 per short ton average national price support level for quota peanuts.

The deductions and discount schedules that were applicable to the 1998 crop peanuts will be generally applicable to the 1999 crop. Further, if the producer fails to certify that Monosodium Methanearsenate (MSMA) or Disodium Mathanearseante (DSMA) were not used in the production of peanuts for the current crop year, the producer will not be issued a peanut marketing card. Even if the producer makes the above certification and it is later determined that the peanuts have been adulterated with MSMA or DSMA, the price support loan value for either quota or additional peanuts in that load will be zero dollars per ton.

The actual price support level for an individual lot of peanuts will depend on the percent of the various sizes of the kernels in each ton of peanuts and other factors.

Up to this point, there has been some controversy concerning the St. Jude's Ranch for Children to be located here in Gorman. Here are some things I would like for you to consider, like

Child abuse and neglect are escalating at an alarming rate. In 1997, 3,195,000 children were reported as abused and neglected to the National Committee for the Prevention of Child Abuse; this number is up 41% since 1988. How many cases go unreported? In 1997, 1,054,000 children were confirmed by Child Protective Services alone as victims of child maltreatment. This represents 15 out of every 1,000 U.S. children. You can choose to ignore these statistics, but the horrible truth is, this happens everyday, everywhere in America. It probably is happening to someone you know.

Studies today show a direct correlation between child abuse (including physical, sexual and neglect) and children with emotional and behavioral problems sometimes leading to criminal activity. This is exactly what has happened to these St. Jude's children at the hands of adults they knew and

St. Jude's has offered these children an alternative. A chance for a change. A chance for trust and honesty. An opportunity to change their destiny and return to the rightful path they should have been given long ago but were denied. What we have taken for granted, these children have never even dreamed of: security, a warm bed, home cooked meals, the love of friends and family. This community has a chance to help St. Jude's make a difference in these children's lives. However, with the animosity they have received since the beginning. I realize now we may have become so numb as a society and as human beings that we don't think these children deserve a second chance. This is ironic considering these children never had a chance in the first place.

All that has been voiced up until now is all of the horrible things that will happen if we allow these children into our community. The sad realization is that these things can and WILL happen whether these children are here or not. As much as we would like to believe, our community is not immune to drugs, crime or violence. Just because you chose to ignore it, doesn't mean it doesn't exist.

In helping to change these children's lives, we just might change ourselves and our community for the better. If you do not give St. Jude's an opportunity to help these children, we will pay in the long run. Without change and a positive influence in their

Ms. Spivey

We currently have three (3) treatment facilities located in Lampasas County. One center is designed as a TYC Facility where juveniles charged with criminal offenses are housed. This facility is located in Rural East Lampasas County.

Two other newer facilities are located in the small town of Lometa in Northwest Lampasas County. One is designed as an emergency holding facility for juveniles and the other is designed to house juveniles for longer periods of time. These facilities hold juveniles placed by the state and who fall into levels 4 & 5.

We currently have less problems from the TYC Facility because the children are more closely monitored and supervised. The major problem with the TYC Facility is reported run-aways (Escapees). In the past, however, we have investigated in house criminal acts, assaults on staff members and teachers, criminal mischief in the area of the facility, stolen vehicles, sexual assaults and illegal drug possession.

The two facilities in Lometa are responsible for approximately 90% of the complaint calls that we respond to in Lometa and the Lometa area. In the past four months alone, we have responded to over 30 calls to the treatment facilities. The calls have ranged from reported run-a-ways, which occurs very frequently, assaults on staff members as well as assaults between juveniles, drug possession, vehicle thefts, sexual assaults, two reported riots where the juveniles have physically taken control of the facility, and other criminal offenses outside the facility that the juveniles have committed.

Since their existence in Lampasas County, juveniles assigned to these treatment facilities have stolen numerous vehicles, a dump truck, a school bus, multiple sexual related offenses, drug possession, burglarized both homes and businesses, committed criminal mischief to private property, public property and to school property with consolidated amounts into the thousands of dollars.

We have found that juveniles who commit criminal acts where damage or restitution should be paid to a victim is never collected. We found that the Treatment facility owners are not responsible for acts committed by the juveniles nor will they pay restitution when criminal acts occur even though they have promised to do so.

We have found that once a facility is licensed, it is impossible to get the license revoked or the facility moved, nor can we control the growth or the impact of that growth.

We have found that there is a big impact on the school district. Even though compensated by the state to a certain extent, once established, the school district is required to hire more teachers, add additional class rooms as well as alternative class rooms for those juveniles who can not function in a normal setting.

You asked why these types of facilities seem to appear in small rural towns. We found that most larger cities, such as the city of Lampasas, rejected the request to have a facility located within their city limits. We also found that there was a lot of promises of local jobs, children who would benefit the community and the school, as well as making the citizens feel that they would be helping under privileged and abused children.

We have found that many children who are placed in these facilities are from large cities such as Houston, Ft. Worth and Dallas. Many are gang members and many times in the past these juveniles have had a very nega-

One facility has had a continual running add for help because they can not keep qualified workers. We find most employees are under paid and under trained to deal with the type of juveniles problems found in these facilities.

In my personal opinion, the only persons who benefit from these type facilities are the owners. They make a tremendous amount of money from the State to hold these juveniles.

A short time after the treatment facilities in Lometa were established, problems and criminal acts began to occur. The Citizens of Lometa attempted to have the license revoked. The vast majority of the Citizens agreed that they did not want the facility located in Lometa and signed petitions to that effect. Public meetingswere held and some Citizens even testified before a Legislative committees voicing their complaints. As a result, no license were revoked. Since that time, all facilities have expanded to additional homes within the City of Lometa and the number of juveniles in these facilities have increased along with a rise in the calls and reported criminal acts.

The facts expressed in this letter is based on documented calls and reported criminal activity to the Lampasas County Sheriff's Department and complaints reported to the State Licensing Board.

In my personal opinion and observation, these facilities have impacted my department, the Juvenile Probation Department, our court system and related offices, the schools, as well as the Citizens of this county and the town of Lometa who fall victim to criminal acts committed by the juveniles housed at the treatment facilities.

A little about myself. I am currently serving my 20th year as Sheriff of Lampasas County. I have 26 years experience as a Peace Officer and two years as a Judge.


