Mr. Publisher, may I extend a few comments to Press points in which I so proudly display my name and your town on several Eighteen Wheeler doors. It is difficult for me to comprehend your throughts as your subject matter appears to vary in this article. First you quote, "Truckers can do almost anything they want and folks seem to think it's okay." Periodically, my records are checked by five auditors and I do comply by all regulations. If this was not true, my father would not have completed fifty years of service in October, 1978. Sufficient taxes are paid by all truckers to compensate their use on the public highways. An invitation to check with Eastland County Tax Assessor to confirm my statement on the amount of revenue Eastland County has received derived upon the number of trucks we have operated from our Gorman Terminal may be confirmed. Also, I would like to mention this was our choice, however, this tax money could have been paid to Anderson County instead of Eastland.

Recently, an operating ratio filed in Austin compiled by seven competitive Specialized Carriers indicated statistical increases in the last twelve months as follows:

Insurance 23% Repairs 21.4% Tire 26.8% Equip. 20.8% Wages 34.1%

During this study period, our individual ratio analysis was computed at 99.6%.

You do have my assurance the day we reach an operating ratio of 100%, our equipment will be parked.

There hasn't been any contributions from our Corporation nor have any of our employees participated in Strikes. As we continue our economic survival to render services, it appears more criticism prevails. Joe, I ask you to consider the safety factor of our personal drivers as they attempt to deliver agricultural commodities. Our efforts to remain in your Area depends upon our governed regulatory agent, the Railroad Commission.

Financial problems have arisen abruptly in all transportation divisions. Constantly, proposed deregulation is mentioned. This cut-throat competition will only revert to less freight being transported and services to remote areas, such as Gorman, deferred. Accounting Departments would be in mass-turmoil attempting to pay each non-regulated driver. Managements of various transportation divisions would require additional employees to allocate their loads in order to maintain production.

Please be informed this is independent truckers. The news media continues their broad coverage on minor or less important issues. These asinine statements contributes to more controversy. This matter will be resolved legally as so many other strikes have in the past.

I conclude in stating that trucking is a part of my life. Without transportation our modern society could not exist. May I suggest a reconciliation as the next truck driver passes you on his designated route. It would be most appreciative to see a note of recognition to all those truckmen who help provide the American People with their needs. My apologies to those of you, Easley Trucks has offended in establishing a terminal in your Fair City. I trust the derogative statements in your publication will not discourage the employees living in your Area. The experiences obtained during the past few days with some of the nations largest agricultural shippers and buyers have been overwhelming. Keeping on Trucking, Easley drivers, there are people who need and appreciate us.

I have always felt close to truckers because my Dad raised produce (hundreds of acres) when I was a kid and we hauled produce north in the spring and summer and cotton to Houston in the fall. In my retirement years I spend a good bit of time traveling to see my kids and grandkids and driving on the road shoulder to let the eighteen wheelers by so they won't have to lose their speed. I never thought I would need help on the road and I never anticipated an eighteen wheeler diesel stopping to help me and my little 48 horsepower diesel. I really renewed my faith in humanity and in truckers.

I would like to thank you and Gene and congratulate you on having a man on Gene's caliber in your organization. If you, or Gene, or anyone in your business family has need of help when you are near Cameron, please call me and I will be privileged to come to your assistance. Also, if I ever see an Easley truck stopped on the road, I will stop and render every service possible.
