



Comment

WASHINGTON, D.C. -There are more government programs that are unworkable, uneconomical, and unpopular with the people the programs were supposed to assist than I could possibly list in six of these columns.

Congress has taken a hard look at all government programs this year, with an eye toward trimming unnecessary and expensive programs. Members of the House Subcommittee on Tobacco and Peanuts, myself included, balked this week, however, at dismantling a program that does work, is economical, and has proven itself to the people it was designed to assist - the peanut producers. The Reagan Administra-

tion had targeted the peanut program for extinction, with the intention of gutting the program of its most vital supply-management provi-The current peanut program works. In fact, it works

far more economically than the Administration's proposal would work. The federal cost of the current peanut program has been reduced 60 percent in the last three years and peanut growers have proposed a program to continue this trend to a point of zero cost in 1985. To has worked should not be ignore the producer request this year is to ignore the per- that will cost more and not sonal sacrifice they have made work

over the last three years attempting to reduce federal costs and produce peanuts competitively priced for the

world market. The current program has also been beneficial to the consumer by encouraging production of a steady supply of peanuts over the last 25 years, even though this year's supply has been shortened by a rare national drought. With a normal production year, the price of peanuts and peanut products can be expected to return to pre-drought levels.

Peanuts, although grown in only a few counties in the 17th District, play an important social and economic role throughout the state of Texas. If the current government program is phased out, production in the Southwest area of the U.S. would be curtailed, resulting in much larger farms fewer people residing in rural areas, and fewer jobs for

everyone in those areas. I plan to continue to examine government programs with a critical and perhaps miserly eye, in light of our current economic problems in this country, but a program supported by farmers that works as well as the peanut program scrapped to accept a program



## 3 Men Arrested For Forgeries

EASTLAND (RNS) - Three men were being held at Eastland County Jail Friday night, following their arrest for forgery Thursday at Lake Leon by Gorman Police Chief Cecil Funderburg and Eastland County Sheriff Johnnie Morren. The three are Jimmy Lee Pelham of Lake Leon, Robert Wayne Russell of Tyler and Patrick W. Quinn of Michigan,

said Eastland District Attorney Emory Walton. They were charged with forgery in Stephens County, where bond for each has been set at \$10,000, said Deputy Tom Baker of the Stephens County Sheriff's Office. Similar charges have been filed against them in Brown County, where bond has been set at \$5,000 each, and in Comanche County, where bond has been set at \$10,000 each, according to Deputy Joe Forbess of the Brown County Sheriff's office

and Comanche County Sheriff W.G. "Shilo" Garmon. Pelham, Russell and Quinn each face a \$15,000 bond set by Pat Ingram of Gorman, Eastland County Justice of the

Peace, Walton said. They allegedly passed fictitious checks in the four counties in the past three days, he said, describing the forgery operation. After opening accounts at local banks using fictitious names, the three then used courtesy checks to write checks larger than the amount of their purchases of small items, Walton said.

The first order of business was to canvas the Election returns and the canvass showed that Mr. Higginbottom and Mr. Gressett were elected for a two year term. I administered the oath of office to them and they were declared as fully qualified membrs of the Commission.

We voted to give \$200 at this time to the Swimming Pool Committee so that they could pay some outstanding bills from last summer. Plans are being made to raise money to repair the pool for this summer. You will be hearing more about it at a later date.

Since my last report to you we have completed the cleaning of the portion of the sewer system that was scheduled for this year. We cleaned all trunk lines and much of the six and eight inch line. You just can't believe what we got out of the lines. Some had no more than two inces open on top of the line and one six inch was completely stopped. This stoppage was due mostly to sand in this line which we hope to eliminate in the future. We ask all of you to be careful as to what you put in your sewer lines so that we can keep them clean. With the cooperation of all the places that do washing of any kind where sand gets into the line, we can correct a major problem without having to take any official action to prevent sand from getting

into the lines. we have been hauling rock and putting it on many of our streets during the past two weeks and started hauling again on Monday. We are and taking those involved doing the road from Mrs. into custody. I am asking that Thompson's Grocery around all merchants be more carethe corner up to the gravel at the Cemetery. When the rock gets settled and packed down it will make a good road. While we are hauling we will

put rock on the parking lot at the Senior Citizens Building.

We are now busy with the budget for next year and as expected, it will be up over this year. We can't tell just yet what we will have to do about a tax increase. We hope that we can make one more year, but it may not be possible. Everything we are buying is up every time we place a new order. We will do the best we can to make every dollar go as far as possible without cutting ser-

At this time we do not

know when the Central Appraisal Board will have the Appraiser in our area, but it should not be too long. They will be in Carbon just as soon as they finish Rising Star. They will be giving this matter coverage in the paper from time to time. Just remember that this is not something that we have decided to do but it is something mandated by state law and all property will go on the tax roll beginning in 1982 at market value as determined by the appraiser and the County Equalization Board. We hope that you understand why this is being done. It will raise taxes some because there will be an added cost of operating the County Appraisal Office and local increaes to raise what ever is required to meet the budget needed. Remember as you value goes up, your rate will decrease. The appraised market value will not mean that you will be paying the same tax rate on that amount as you are now paying. As I have said before, your property will have the same value placed on it in all taxing units. You will not have three or four differnt values as you now have and you will have to meet with only on Equalization Board.

I would like to thank our Police Department for their work in helping to solve the hot check scheme that was pulled here last week. Our Chief was on the case as soon as it was reported and played a big part in solving the case ful in cashing checks on strangers without having some identification. 


