From The Superintendent's Desk

I would like to address some of the issues that the school board and administration is studying at the present time. During the special session of the legislation, new reforms and laws were passed that will have and is having to be done to meet state accreditation for the school district.

(1). Class loads to be limited to 22 in grades (K-4).

K-2 for 1985-86 school year. K-4 for 1988-89 school year.

We will have to add teachers and classrooms for grades 1 and 2 for 1985-86, 3-4 by 1988-89, have two sections of kindergarten if enrollment stays as it is now for 1985-86.

(2). Add elementary library. (3). Add new science lab for Jr. High and High School, old lab to be used by Jr. High and High School by 1988-89.

(4). Add computer courses, room to be added for this course.

(5). Add classroom for Special Education.

(6). Add classroom for Title I reading

The board has talked to a firm about the new 9 rooms that are needed, also the board is studying renovation to the existing building on campus. The Texas Education Agency did a study and said the existing buildings would be sound in structure to renovate. With these additions and updated construction on existing buildings, the Gorman School would be in good shape to handle additional growth, be in compliance with new standards with Texas Education Agency for accreditation.

The board would like to have open house meetings with the public to discuss with the community these things that have been mentioned. Further information will be published in the near future.

We have gotten school started, the teachers and students are busy and working hard. I know that we will have another outstanding year. Remember that a visit from you is always welcome.

The Panthers opened their 1984 season against the Hico Tigers at Hico on Friday night and came away with a very big margin in total yardage, however, the scoreboard read 6-6. The cause of the Panthers coming out with the tie was because, mainly, of three fumbles, one of which set the Tigers up in business

on the Big Red 37 yard line. The Tigers then took the fumble recovery on the Gorman 37 and scored in 8 plays with Steve Knudson getting the final 6 yards on a fine run with 52 seconds left in the initial quarter. The run for two points failed and the Tigers held a 6-0 advantage.

Following the Tiger scoring drive. the Big Red took the kickoff on their own 37 and went the distance in 11 plays with Jimmy Woodall getting the final 2 yards on a dive play with 7:50 left in the half. On the try for two points, the Panthers were called for lining up offsides and penalized 5 yards They tried for the two points on a pass try but the play failed, leaving the score tied at 6-6.

The half ended with the 6-6 deadlock and the teams played on fairly even terms the rest of the way, with the Panthers showing more ability to move the ball, but failing to take advantage of their yardage plays because of fumbles.

Then with just about a couple of minutes to play in the game the Panthers almost broke one on the punt return, but the ball carrier was stopped on the Tiger 30. The Panthers moved for a first down, then lost a yard on a running play. Then a pass try failed. Following this the Big Red ran for 5 yards. Then on fourth down, Ricky Hunter rolled out to his right and found Sam Brinegar

ground gainer for the Big Red with 86 yards on 14 carries, one being a beautiful 25 yard blast up the middle. Ricky Hunter got 51 yards on 11 keepers. Russ Gressett had 33 on 6 tries. Jimmy Woodall made 19 yards on 17 tries and Zack Wilcox had 5 yards on three tries. The Panthers just couldn't seem to

settle down and play their usual good brand of football. They made some good yards but just couldn't find the endzone.

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 20 proposes a constitutional amendment which abolishes the office of county treasurer in Bexar and Collin counties if a majority of the voters in each of those counties vote in favor of abolishing the office of county treasurer in a local election to be held on the issue. All the powers, duties, and functions of the office of county treasurer in each of these counties would be transferred to

the county clerk. The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to abolish the office of county treasurer in Bexar and Collin counties."

PROPOSITION NO. 5 ON THE BALLOT

Senate Joint Resolution 22 proposes a constitutional amendment which provides a new method of filling a vacancy in the office of Lieutenant Governor. The amendment requires the President pro tempore of the Senate to call together the committee of the whole Senate within 30 days after a vacancy occurs in the office of Lieutenant Governor. PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that permits the use of public funds and credit for payment of premiums on non-assessable life, health, or accident insurance policies and annuity contracts issued by a mutual insurance company authorized to do business in this state. The constitutional prohibition against a grant of public money to an individual, association, or corporation or against becoming a stockholder in a

proposed constitutional amendment will appear on the ballot as follows: The constitutional amendment to permit use of public funds and credit for payment of premiums on certain insurance contracts of mutual insurance companies authorized to do business in Texas."

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 4 proposes a constitutional amendment to change the membership of the State Commission on Judicial Conduct to include one Judge of a Municipal Court and one Judge of a County Court at Law, who shall be selected at large and appointed by the Supreme Court with the advice and consent of the Senate.

The amendment also provides additional grounds for removal from office of judges or justices of Texas courts, and provides additional disciplinary actions that could be taken in lieu of removal or censure. The amendment would extend the Commission's disciplinary authority to masters, magistrates, and retired or former judges who hear cases by designation. The amendment creates a tribunal to review recommendations of the State Commission on Judicial Conduct for removal or retirement of a judge or justice. The review tribunal would be composed of seven (7) Justices or Judges of the Courts of Appeals selected by lot by the Chief Justice of the Supreme Court. The amendment also provides for appeal of the review tribunal's decision to the Supreme Court of Texas and grants an accused judge the right to discovery of evidence.

The proposition will appear on the ballot as follows: The constitutional amendment relating to the membership of the State Commission on Judicial Conduct and the authority and procedure to discipline active judges, certain retired and former judges, and certain masters and magistrates of the courts."

PROPOSITION NO. 8 ON THE BALLOT

House Joint Resolution 22 proposes a constitutional amendment which increases the per diem of members of the Legislature. The amount of per diem allowed during a calendar year would be equal to the maximum amount set in federal income tax statutes as of January 1 of that same year as a deduction for ordinary and necessary business expenses incurred by a state legislator. Current per diem is \$30; the maximum deduction is now \$75.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide a per diem for members of the legislature equal to the maximum daily amount allowed by federal law as a deduction for ordinary and necessary business expenses incurred by a state legislator."




