





I don't remember a time when rain in Eastland County was of any greater benefit than it was this week. Of course, the June 5th rain was probably more valuable to the peanut growers, because it provided moisture for planting. The rain last week will help the peanuts and other crops get a good start.

The recent rain was more general and beneficial to the rangeland and hay crops in the northern part of the

The rains came at a time when water supplies in our lakes were getting very critical. While the rains did not fill the lakes by any means, they did lessen the demand for water from the lakes. During the week before the rains, water being used from Lake Cisco and Lake Leon were greater than the amount that could be pumped from the lakes. That was causing city water storage tanks to be dangerously low.

Are you being invaded by moths? They are a nuisance around the but otherwise harmless. oths, like butterflies, are the adult form of group of insects known as lepidoptera. Moths lay eggs that

hatch larvae or caterpillars. The larvae after maturing form a pupa and the moth or butterfly emerges from the pupa.

The moths feed only on the nectar of flowers primarily and to a lesser extent on the honeydew of other insects or on decaying fruit. They may be controlled around doors and out door living areas with Pyrethrin aerosol spray or with a malathion spray. There have been some reports of moths getting in window air conditioners and stopping the air movement around the units.

The moths we are seeing are the adults of several different insects, mostly unimportant insects. Some are cabbage worms and other leaffeeders that may damage vegetable crops. Be alert for any caterpillars on your vegetables or ornamentals.

One effective weapon in the war against caterpillars is B.T. (Bacillus thuringienses). B.T. is a biological type insecticide that only effects caterpillars.

Only susceptible caterpillars have the necessary combination of high PH, salts and enzymes in their digestive system needed to activate

New Education Bill To Help Gorman Schools

The Texas Senate adopted the compromise play by a 22-9 vote Saturday afternoon, and the House did the same by a 92-55 vote. Saturday night. The House later changed that final vote to 106-41, thus giving the bill the two-thirds vote necessary to go into effect immediately upon signing by the governor.

In the Senate, Grant Jones, D-Abilene; Ray Farabee, D-Wichita Falls; and Bob Glasgow, D-Stephenville, voted for the reform bill, while John Montford, D-Lubbock, voted against it.

In the House, Gary Thompson, D-Abilene; Stan Schlueter, D-Killeen; and Bruc Gibson, D-Cleburne, voted for it, while Stephen Carriker, D-Roby; Joe Hanna, D-Breckenridge; Dick Burnett, D-San Angelo; and Larry Don Shaw, D-Big Spring, voted against it the first time around. Carriker, Hanna and Shaw switched to yes vote on reconsideration of the bill. Burnett's vote remained unchanged.

Monday night the state legislature was still hashing and rehashing the "New Education Bill". While new teachers starting salaries got a boost, teachers already in the system will get a smaller slice of "Perot Piel" As one retired teacher stated the educators who have been in the profession several years always get the "short end of the stick".

The \$151,300 gain the Gorman School District will receive will not help as much as one would suspect. According to Superintendent, G.W. Maxfield, the district will in all probability have to add at least 4 new teachers or aides. After these salaries have been accounted for, then the new budget will have to accomodate the pay raises for all other teachers.

Now to something the \$151,300 gain will not ever touch and something our lawmaker did not bother to check on. The new bill will limit classes to 22 students in Kindergarten through seventh grade in the 85-86 year and in kindergarten through fourth grade beginning in 1988-89. This will necessitate the building additional classrooms. Some districts will have to have many more classrooms and teachers, even as many as 45 extra classrooms and teachers along with maintenance people and in all probability another principal.




