LICENSED AND BONDED





As promised in last week's column, I will begin brief explanations of the proposed Constitutional amendments which will appear on the November 5th General Election ballot. This week we will begin with the proposed amendments relating to water.

Proposition 1 would increase by \$980 million the bond authorization for the Water Development Fund, the state's conduit for funding water projects. From the additional money in water development bonds, \$400 million would be held for state participation in reservoirs, conveyance facilities, and water-and wastewater-treatment facilities. \$190 million would be used to fund sewage treatment projects of political subdivisions that could not otherwise sell their own water bonds and regional facilities. Another \$190 million would be for "hardship" water-supply projects and for areas converting from ground-water used for flood-control projects. Under Proposition 1 the state would also establish a program to insure local political subdivision's water-related bonds. Under this program, the state would pledge \$250 million of its credit to insure certain local waterrelated bonds against default.

Proponents of the water plan feel that since the usual sources of funding water projects--federal grants and local revenue and general-obligation bonds--are dwindling, Texas needs money for

water projects. The cutbacs have hurt both water-supply and waterquality projects. They believe the state should step in to help, so that needed projects can be developed sooner and more cheaply.

Opponents of this plan feel that the state needs more money for water projects, but not this much. They feel the conservation and environmental-protection

requirements are weak and that more research needs to be done.

Proposition 2 would authorize the Legislature to approve the issuance of up to \$200 million of general-obligation bonds for agricultural waterconservation projects. Both legislative approval and sale of the bonds would have to occur within 4 years of the effective date of this constitutional amendment.

Supporters feel this would allow the Legislature to set up a sound agricultural water-conservation program that will preserve land and water resources for future generations. The bond money could be used to expand a pilot program to help farmers maintain irrigated agriculture until research develops more water-efficient crop varieties and identifies new water supplies. The use of bonds means the program can be paid for without increasing anybody's taxes; and the state will not issue the bonds at all unless the Legislature is convinced by a 2/3 majority that state-backed financing

Opponents feel the amendment

does not go far enough in conserving water in agriculture and that much more money is needed. They feel that aid under the pilot program is in the form of loans, and that farmers are reluctant to add to their debt and that since aid would go to individual farmers, it could well be unconstitutional.

In November of 1983, an amendment was passed to allow the spending of public funds for replacement of sewer lines on private property, if the city is moving or replacing the sewer mains that serve the property. If the owner agrees in writing, the cost is charged to the property owner who then has five years to pay the city back. Until that time, the city holds a lien against the property. Proposition 3 simply allows the city to expand the use of public funds to include the moving or replacing of water lines, rather than just sewer lines, under the same conditions, i.e., the owners consent with the city holding a lien on the property until the loan is repaid within five years.

Supporters say many people, particularly those on a fixed income, cannot afford the \$1,000 - \$3,000 hook - up cost and the city should be allowed to charge the customer for the work and allow him to pay back the city in installments. This policy would be beneficial to the homeowner and would not cost the city any money.

Opponents do not voice opposition to the plan itself but feel the constitution has too many amendments already and adding another dealing with neighborhood water main financing makes it worse.

Proposition 4 would allow the School Land Board to buy land for the Permanent School Fund from the proceeds of the sale of other land from that fund.

Presently, the Board can sell land dedicated to the Permanent School Fund, but the proceeds must be used only to invest in certain bonds and securities. In order to acquire new land for the fund, the Board can only trade present land for land of equal or greater value.

Supporters say much of the state land is in parcels which are too small and scattered to make leases for grazing and mineral rights marketable. In order to acquire larger, single tracts of land which are marketable, the state has had to locate buyers for the small tracts of land, find a larger tract the state is interested in acquiring, then convince the buyers of the small tracts to purchase the larger tract to trade with the state. This procedure is cumbersome and requires unnecessary paperwork. Supporters feel Proposition 4 will allow the School Land Board to sell the small, scattered tracts outright and use the proceeds to purchase a single, larger tract. It will accomplish the same purpose in a much more simplified and time - efficient manner.

There is no apparent opposition to this proposition.

Proposition 5: The Indigent Health Care bills which passed in the Special Session last May set standards and eligibility requirements for county and public hospitals.

Hospital districts were excluded from those provisions because their creation is specifically authorized by the State Constitution.

Proposition 5 would allow the Legislature to set out by law the requirements a resident of that district must meet to qualify for those services and other provisions necessary to regulate the care provided to the hospital district's residents as is now done for county and public hospitals.

Those who support this provision say it would give hospital districts a uniform set of standards for both services and eligibility and clarify the districts' legal duties in order to protect them from law suits alleging they failed to "assume full responsibility for poor residents' medical and hospital care" as required by the Constitution.

Opponents feel that it will cut down on medical assistance received by many of those who cannot afford private insurance but do not qualify for Medicaid and other forms of public assistance, but who have been covered by hospital districts whose eligibility requirements are more lenient than Medicaid's.

I warned you that explanations of these proposals would be bland, to say the least, but I felt then, and still do, that it is important that you be able to cast an informed vote. I know, however, you are happy to hear that we are halfway through, with only 9 more proposals to go.


