# National Day of Prayer Slated For Thursday, May 3

The annual National Day of Prayer (NDP) will be observed in Gorman on Thursday, May 3<sup>rd</sup>, from noon to 1:00 PM. The event will be held in the Gorman City Park, downtown. All citizens, young and old, are encouraged to bring a lawn chair or blanket and join together in this time of prayer for our leaders, communities, businesses, families, and nation. Here are some common questions and answers regarding the NDP.

What is the National Day of Prayer and what is it purpose? The NDP is an annual event for Americans of all faiths to take time to pray for our nation and its leaders. The NDP was established by an act of Congress as a day to call the entire nation to pray.

When was the NDP started? National days of prayer have been called as early as 1775 with the First Continental Congress. Abraham Lincoln also called for such a day in 1863. The NDP as an annual event was established by a joint resolution of Congress in 1952, and signed into law by President Truman. The law was amended in 1988 and signed by President Reagan to be the first Thursday of May each year.

Is the NDP a political event? No. The NDP belongs to all Americans. It is not sponsored by or "owned" by any one group. Every American can observe the NDP and celebrate it as he or she wishes. Since 1988, every president has issued a proclamation encouraging Americans to participate in the NDP.

Is the NDP just a Christian event? People of all faiths are encouraged to participate in the NDP according to their own traditions. The NDP was created by an act of Congress and is therefore intended for all peoples of faith to pray to the God of their understanding. The local outdoors event, sponsored by the Gorman Ministerial Alliance, is to be conducted according to traditions of the historic Christian faith. If peoples of other faiths wish to celebrate in their own tradition, they are welcome to do so. The NDP, though created by the government, is not a function of the government. Therefore those who organize the NDP in the local context can define their particular expression of it.

The Gorman Ministerial Alliance warmly welcomes all citizens in the Gorman area to come together and unite in prayer for God's mercy and blessings upon our nation and communities.

### Registration for Credit by Exam

Gorman ISD students needing to register for Credit by Exam have until June 14, 2001 to sign up for these tests. To be eligible to earn credit by examination, a student can have received no prior instruction in the academic subject and must score 90 percent or above on a criterion-referenced examination for acceleration for the applicable course.

At the time of registration, the student will be required to make a \$20.00 deposit for each test they register to take. The student will need to check with the building principal before completing the registration. Registration for Credit by Examination will take place in the High School office.

Testing dates will be the week of July 23rd through 27th. The cost of exams will be \$28.00.

# Kalyn Porter - Sean Rountree and Brian Hunt Named In Top 20 in State Class A

The April 16th issue of *Texas Track and Field News* has ranked Kalyn Porter, Sean Rountree and Brian Hunt among the top 20 in the State in Class A in their respective events. Class A has approximately 325 schools participating in Track and Field. These rankings are normally only achieved by athletes during their Junior and Senior Year and are based on marks reported through April 7th.

Porter, a freshman, is 3rd in discus, with a throw of 123'9". Rountree, a sophomore, 3rd in the 100 Meter Dash with a time of 10.7, and 13th in the 200 Meter Dash with a time of 23.1. Hunt, a sophomore, is 12th in the Shotput with a toss of 46'8 3/4".

All three have had improved marks since the April 7th ranking as follows: Porter, 129'9", Hunt 46' 9 1/4" and Rountree

10.67 (100) and 22.45 (200).

Sean, Brian, Kalyn and Jose Cruz, also a sophomore, will be competing in the Regional Meet April 27th and 28th at ACU in Abilene.

For those who would like to come out and cheer them on, Jose will be the first to compete Friday morning at 9:30 a.m. in the 3200 Meter Run, followed by Sean at 11 a.m., in the 100 Meter Dash Prelim and 200 Meter Dash Prelim. Brian and Kalyn are scheduled in the Shotput and Discus at 3:00 p.m. Running finals for Sean will begin at 11:00 a.m. on Saturday.

### **Upper Leon Soil and Water Conservation District**

The Upper Leon Soil and Water Conservation District is now taking orders for its annual spring fish sale. Orders may be placed in Comanche, Eastland, and Stephenville at the Natural Resources conservation Service (NRCS) offices located in the USDA buildings.

Delivery will be May 12, 1:00 PM at the Upper Leon Soil and Water District office at the USDA Building in Comanche, 301 Highway 3381.

Species available for sale this year are: Bluegill, Hybrid Bream, Minnows, Red Ear, Largemouth Bass, Catfish, and Crappie. Also available will be Grass Carp that will require a permit, and Blue Cat in a limited supply.

According to the Texas parks and Wildlife Department, each person that orders Grass Carp must file an application for a permit to stock Triploid Grass Carp prior to stocking. You must have the permit before you can pick up the Grass Carp. The NRC offices will have application forms available.

To guarantee safe transport of fish from delivery site to landowner pond, please supply paper feed sacks. We will bag 50 small or 25 large catfish per bag unless landowner requests smaller amounts.

I would like to take this opportunity to introduce myself, for the ones that may not know me. My name is Tim Dennis and I'm a candidate for the Place 1 position on the City Council. I'm the son of the late E.L. and Virgie Dennis, who owned and operated Brown Jug Cafe in Gorman for many years. I graduated from Gorman High School in 1987 and a graduate of McLennan Community College in Waco with an degree in Paramedicine Education and Law Enforcement. I'm also a college educator and teach in the EMS Education Program at Navarro College. I have also served as a reserve police officer for the City of Gorman, several years ago. I'm also a member of the Rural EMS Task Force Committee, which is a part of the Governor's EMS and Trauma Advisory Council. I represent Eastland County as well as other counties as a member of the Rural EMS Task Force. Our Committee works with GETAC to develop rules pertaining to EMS certification, training and education issues where EMS personnel and providers are concerned. The suggested rule changes are then forwarded to the Board of Health for approval. I was appointed to this committee last year

during the EMS Conference in Austin. I have decided to seek this particular office because I feel that it is time that new ideas are brought to the council, as well as someone that will work for the citizens of Gorman, and that will insure that they are being served the way they should. Also, to insure that the city stays within its spending needs. As all of you have noticed, the City has spent about \$300-350 per car for the new lettering on the police cars. Granted, they do look sharp, but why was this not done when the cars were first purchased? The previous lettering costs about \$100-\$125 per car. This shows that the current council is spending freely on non-essentially items. What will be next?

The current Place 1 position is over the police department. However, this is subject to change when the new council is elected. If elected to this position, I would want to keep the current department, as I feel that having a law enforcement background and education would insure that the police department is properly run and is able to provide this much needed service to the citizens of Gorman. It is my understanding that the department is trying to get a grant for in-car video equipment. This is something that will be useful to the police department, especially where DWI stops are concerned. If elected, I would also try and get a grant that would allow the department to purchase bullet-proof vests for the officers. Last year, I had a current city commission tell me, "this is Gorman, they don't need them here." I beg to differ. Just because this is a small town, does not mean that we should not take officer safety into consideration. This person must have little concern for our


officers' safety. Being a paramedic and EMS Educator, the one thing that I would like to see the city purchase is an AED or Automated External Defibrillator that can be used either by the police department or fire department first responders. There is a current push to put AED's in all federal and state buildings as well as police and fire units. These machines cost about \$3000 each, but it would be money well spent because it saves lives. Again, this would be something that could be covered by grant money. These machines have saved many lives and are something that the city needs to look into, especially for the swimming pool since we are without a local ambulance service.






### Caution... **Camouflaged Critters on the Slither**

Texas is home to four categories of poisonous snakes, including coral snakes, copperheads, cottonmouths (water moccasins) and rattlesnakes. In Texas, you are four times more likely to be killed by lightning than a poisonous snakebite, but taking precautions is key to snakebite prevention.

Snakebite precautions:

- Walk heavily; snakes may sense ground vibrations and slither away before you approach them.
- Wear boots and long pants outdoors, especially when walking in tall grass.
- Do not handle snakes, even if they are dead. A reflex strike from a dead snake can be just as dangerous as a bite by a live one.
- Do not thrust hands or feet into dark areas or areas where snakes may be resting -under rocks, woodpiles, logs or brush.

We possess a natural instinct that causes us to feel that we must be in control all the time. When we lose or feel that we have lost control, it makes us very uncomfortable. However, when one trusts God completely they must surrender control to him. The only thing that we need to control is our flesh and its desire for carnality, because that combination will only produce sin in our lives.

In order for us to be truly effective in this matter, there must be a place in our lives where we begin to grow spiritually. However, we will only become spiritually stagnant if we campout at the starting line. We must continue to flow toward spiritual perfection.

Let us examine a passage of ture that we discussed in earlie-ditions. In Hebrews 6.1-2, Paul ex us to leave the principles of the doctrine of Christ and go on to perfection. Please note that Paul was not suggesting that we abandon or do away with the principles of the doctrine of Christ, but leave from there. I like to think of these as a launching pad. It has been said that space is mankind's last frontier. Therefore, a launching pad was erected years ago at Cape Canaveral and we have been launching rockets principles of the doctrine of Christ are our launching pad into and tow spiritual perfection.

Therefore, the things we must possess before we can grow and become mature spiritually, are the following six

1. The doctrine of repentance from dead works

- 2. The doctrine of faith toward God 3. The doctrine of baptisms (please note the plurality)
- 4. The doctrine of the laying on of hands
- 5. The doctrine of the resurrection of the dead
- 6. The doctrine of eternal judgement

We will begin next week with repentance from dead works and go through each of these one at a time. Once we have believed, received and incorporated these into our lives, we can then begin to grow toward the ultimate of what Christ has designed to produce in each of us.

Dorothy Tidwell is having serious health problems and will have surgery on Tuesday. Our prayers are with her during this time.



# Sibley Bill Speeds Advanced Telecom Access To Rural Areas, Cuts Texans Phone Bills

Legislation to spread high-speed Internet access and other advanced telecommunications services to rural areas, while at the same time lowering all Texans' telephone bills, was filed late Wednesday by State Sen. David Sibley, R-Waco.

"Rural areas have their cyberfuture in their own hands under Senate Bill 1783," Sibley said. "No longer will the expansion of advanced services, such as highspeed Internet access, into rural areas be the decision of a telecommunications provider, which may not consider it a cost effective business decision." Sibley unveiled SB 1783, his rural telecommunications initiative, at a Capitol press conference on Thursday. Thirteen senators have signed on to the bill as co-

Under the bill, a rural community could obtain advanced telecommunications services by providing the Public Utility Commission with bona fide requests from 50 individuals. Those requests are then posted on the PUC's website. Any telecommunications provider can bid to provide the service. The community can help attract a provider by using financing from the Telecommunications Infrastructure Fund, Community Development Block Grants or other economic development tools.

If a provider has not been secured 120 days after the PUC posting, the local exchange company must provide the advanced service or enter into a partnership to provide the service within nine months.

The bill also outlines alternatives for providing advanced services to a community of less than 20,000 population that is unable to accumulate 50 bona fide requests for advanced services (a "market failure"), or to a community with fewer than 2,000 residents.

In addition, SB 1783 will reduce consumers' telephone bills by slashing in half the 1.25 percent tax assessed on local, long distance and wireless calls mandated by the Legislature in 1995. That legislation, House Bill 2128, created the Telecommunications Infrastructure Fund (TIF), which was designed to generate \$1.5 billion over 10 years to bring advanced technology to public schools, hospitals and libraries through grants and loans.

To date, Texans have paid almost \$760 million into the TIF through the 1.25 percent assessment.

"The TIF assessment has resulted in technology grants to public schools of more than \$426 million, and disbursements to other qualified entities of more than \$195 million," said Sibley, sponsor of the bill that created the Fund in 1995. "This has helped prepare Texans, especially schoolchildren, to compete in today's high-tech economy.

"SB 1783 is not expected to harm the TIF or its valuable mission. While SB 1783 cuts the TIF assessment, it also extends the life of the Fund by five years, to 2010. In addition, because the Fund currently has an unspent balance of more than \$200 million, grants and loans to public schools, hospitals and libraries should not be reduced."





### **RURAL TEXAS' HEALTH CARE CRISIS**

Currently, there are 25 rural counties without primary care physicians, 29 with only one physician, and 62 with no hospital. Since 1990, 30 rural hospitals have closed, and since 1999, 57 rural health care clinics have shut down. If we do not stop this trend, the quality of life in these areas of Texas will continue to be threatened.

Health care is an essential economic development tool. Without local health care, the ability to attract and keep businesses declines. Then, as the downward spiral continues, we lose our jobs, schools, banks, local merchants, and our way of life.

Over the past interim, we learned that over 600,000 Medicaideligible Texas children are not enrolled in this program. Recent surveys of Texas families indicate that one of the most daunting obstacles to Medicaid enrollment is the complicated, bureaucratic application process. Rather than enrolling their children in Medicaid, many parents choose to take their uninsured children to the emergency room of the local hospital for treatment. This method of health care is putting a serious strain on local taxpayers who are footing the bill with increased property and hospital district taxes.

The 77th Texas Legislature is calling for a simplification of the application process for children's Medicaid. Simplification is a victory for rural Texas because we can use additional federal funds to slow the cost-shift to our local taxpayers. Also, every \$1.00 spent on health care in a rural community generates an additional \$1.50 of economic activity in that community.

Simplification is only the first step in the crusade for rural health care, but it is an essential step. The time is right for your legislature to take action.

### ASKING THE RIGHT QUESTIONS ON MILITARY READINESS

On March 19 the U.S. Army was forced to drastically curtail training for 65,000 soldiers in Germany for fear that their boots and equipment could spread the highly contagious hoof-and-mouth disease virus that is afflicting livestock in Europe. This will, without doubt, affect their combat readiness, and as a result, America and the world's bottom-line security.

In recent years, protesters have curtailed U.S. military training at ranges in Okinawa, Korea and Puerto Rico. With these and similar training restrictions being imposed on American troops stationed abroad, Congress may want to debate whether it makes better sense to concentrate on expanding and improving U.S.-based facilities to ensure training is conducted in our country under our total control.

As surely as Texas bluebonnets bloom in spring, the convening of a new Congress has brought calls for another round of study and debate over possible military base closures to "reduce costs" and "shape the military more efficiently." Once again, the assumption is that closing military bases on American soil is, inevitably, the only way to "reduce costs" and make the military more efficient. I'm not so sure, and these new training restrictions imposed in Europe have again cast into doubt the wisdom of prematurely closing more

domestic military bases. Before such a process even begins, Congress needs to take a closer look at several factors: 1) How should our armed forces be structured in order to reverse the decline in American military readiness we've witnessed over the past seven years and keep America the preeminent global military power? 2) How can we best avoid the missteps of the last round of base closures? The fate of Reese Air Force Base in Texas is an excellent example of a plan that looked good on paper but turned out badly. Reese was one of the Air Force's premier sites for entry-level pilot training, but an Air Force analyst decided there were adequate training facilities available elsewhere and Reese should be closed. Today the Air Force is experiencing a serious shortfall in training spaces for new pilots and is desperately trying to reestablish training sites on other bases. Everyone involved agrees that Reese never should have been closed. Or take a look at Fort Hood, downsized to just one division in 1990 at a cost of great disruption to the community. Just a little over a year later, the decision was made to bring a division back. Now Fort Hood has two active divisions and a Corps Headquarters - and is recognized as the Army's premier post. How was such a miscalculation made and how do we prevent one from being made again? Closing bases will save money only if we can be absolutely certain we will never need those bases in the future. 3) "Reducing costs" isn't a foregone conclusion. Recent rounds of the base closure and realignment process turn out to have grossly exaggerated the amount of money closures would save. To clean up abandoned bases — so they can be returned to civilian use — turns out to be vastly more expensive than anyone anticipated, and those bills come due immediately. 4) We have to be willing to learn from past mistakes. Having watched the base realignment process from my Senate position since 1993, I can bear witness that parochial political considerations came into play early and never left the field, despite assertions that decisions were being made in a politics-free arena. I am not convinced Congress should again delegate the responsibility for the fate of military bases to a commission that brings its own inherent political considerations to the

It is essential that we first determine whether the current mix of military facilities and infrastructure on American soil and overseas serves our needs as well as it could. The United State maintains more than 74 installations outside our borders, with nearly 213,000 personnel permanently stationed in 140 countries. These commitments have absorbed funding that in some cases may have been better used to maintain or improve our critical domestic base infrastructure and training capabilities. We need to take a closer look at the military construction projects we have undertaken abroad, which last year totaled nearly half a billion dollars, to determine if this is the most efficient use of our defense expenditures and if it is the best way to meet our national security objectives. As Chairman of the Senate Appropriations Military Construction Subcommittee, I intend to hold hearings to determine what our future force structure should look like and what their mission requirements might be. Our first priority must be to ensure our military forces continue to have the training and logistical support they need to carry out the tasks we assign them. It is essential that we make these determinations first, before other decisions are contemplated. I have not entirely ruled out the idea of another base closure and realignment commission in the future, but I will not support one until all the right questions have been answered.






