



This is a letter sent out to all representatives, congressmen, senators, the heads of the peanut program, the Governor of Texas and the President of the United States. I've enclosed some names, addresses and phone numbers of the people we need to contact. I asked our ASCS manager why the farmers in Eastland County were not called in and helped to figure the amount of acres or at least told about the new requirements like other surrounding ASCS offices. He told me it was probably because they were so short handed. Over 70 percent of the farmers in Eastland County did not qualify to transfer pounds and were not aware until they went to transfer that they did not qualify. It would seem to me that fault lies within our ASCS Office for not making their farmers aware. We are penalized for planting too many and now we are penalized for not planting enough. Please take the time to write or call these officials. We need to get off the stick and get something done.

I'm writing in regards to the transfer of excess quota pounds on peanut allotment from one farm to another. My husband (Bobby D. Carlton) and myself farm close to three hundred acres of peanuts in Eastland County, Texas.

Four tracts of land that we work are dry land. The quota pounds for these tracts were figured during a period of years that Eastland County was stricken with poor rain and low yields. Dry land peanuts took a hard hit. This year we have the chance to catch up with the bank due to good rains during the growing season. Now we are told too late to do anything about it that more laws have been added to restrict the movement of quota pounds fron one farm to another.

We have a tract of irrigated land that has some excess quota pounds. We transferred poundage last year and some the years prior. We planted approximately the same amount of acres this year as we have in the past. We planted 95.7 acres and had them certified on our irrigated acreage as usual. Last year we were allowed to transfer poundage without any problems amd without a word that things had changed for next year. We were not made aware that we would have to plant additional acreage to be alowed to transfer.

We were not told until Thursday, October 29, 1987, when I contacted the ASCS Office in our county to have them prepare the paper work for transfer. They told me that they would do some figuring amd would call me back. They called back in about thirty minutes and told me that we were short 1.7 tenths of an acre to be able to transfer. We are being penalized for being short 1 and 7/10 of an acre. Rudy Pack with the ASCS Office also stated that no information about the requirements was mailed out through their office. He also agreed that he felt it was not correct the way it was handled. But, that it was out of his hands.

We do not feel we are being treated justly for our hard work. Please, we need your help right now. We cannot afford to wait until next year. We are talking about five to eight thousand dollars being lost because we cannot touch our excess pounds on our irrigated tract.

GLASGOW DISCUSSES HB595 AND HB908

During the Regular Session of the 70th Legislature, SB 595 and HB 908 were enacted concerning private commercial carriers. SB 595 requires all private commercial carriers (motor vehicles) as defined by the Railroad Commission of Texas to be registered with the Railroad Commission. HB 908 requires all private commercial carriers to file proof of insurance with the Commission.

There has been a great deal of confusion as to the implementation of these bills, and I would like to take this opportunity to discuss them with the people of my Senatorial District 22.

In August, the Railroad Commission adopted a rule defining a commercial vehicle under SB 595 as a vehicle weighing over 10,000 pounds used in furtherance of a commercial enterprise. This definition considers the trailers or towed vehicle in calculating the weight of the vehicle. At the same time, the Commission adopted a rule pursuant to HB 908 which set minimum liability insurance levels for these vehicles at that same level required of for-hire motor carriers, I.E. \$500,ooo combined single limit coverage.

Subsequently, the Railroad Commission published a rule change in the Texas Register that would exempt from the definition of a commercial vehicle, vehicles operated by or on behalf of farmers and ranchers in the conduct of their farm or ranch operations. Additionally, the Commission also published a rule that would lower the minimum insurance levels to that required by the Safety-Responsibility Act for vehicles having three axles or less or weighing under 26,000 pounds. Only vehicles larger than that or having more than three axles would be subject to the \$500,000 insurance.

The Railroad Commission, however, has neither proposed nor adopted regulations regarding safety to be applied to group other than for-hire motor carriers.

The Texas Dept. of Public Safety has proposed regulations pursuant to HB 908 that are similar to those of the United States Dept. of Transportation to be applied to for-hire and private motor carriers alike. These regulations require that commercial vehicle operators observe hours of service, maintain drivers logs, and take physical examinations, among other requirements. These are the requirements that would apply to private carriers such as delivery trucks, beer trucks and other private vehicles not for-hire.

I hope this information will explain more fully the effect of these two bills, however, if you have additional questions, please do not hesitate to contact my office.

ice cream sundae has become a part of the American culinary landscape.

Originally dubbed the "Soda-less Soda," the concoction of ice cream smothered in flavored syrups or toppings was created by confectioners who came under fire for serving soda water on Sundays, because it was considered to be too "stimulating" a drink to be decent for Sabbath consumption.

Even the ice cream "Sunday" was not without controversy, for the original name was spelled with a "y." The "-ae" ending came about, claims Paul Dickson, author of the Great American Ice Cream Book, when, "those who orated from the pulpit on the sinful soda went to work on the sacrilegious use of the name of the Sabbath for its stand-in.'

Regardless of its somewhat precarious position under the scrutiny of turn of the century social reformers, the sundae was quick to catch the attention of the public, and today it is standard fare.

An opportunity for do-it-yourself sundae preparation makes a wonderful treat for a child's birthday party or a great way to end a summer barbecue.

Combining ingredients in the quantity and order dictated by one's tastes - questions such as whether fruit or hot fudge should be ladled over the ice cream first, can give rise to heated debates in some circles — is a thoroughly satisfying way of acting upon the latent food fantasies that are lurking in even the most controlled

Officials vote to buy land for Eastland jail expansion

EASTLAND - The Eastland County Commissioners voted during a special meeting Monday to buy \$75,000 worth of property next to the Eastland County Jail.

beds to the 7-year-old jail; it now has 25 beds. The addition is expected to cost \$1.25 million, which includes Monday's \$75,000 land purchase.

The county still owes about \$250,000 on financing for the current jail. The debt will be paid off by 1990, County Judge Scott Bailey

Have you heard it said that you should be careful what you wish for because you just might get it? Well, I wished for and supported an elected State Board of Education and now let me tell you what I got and you can tell me if it is good or bad.

In the general election in November of 1988, a representative will be elected to the State Board of Education from our area. That State Boatd of Education district will include 49 counties and will be about 1/2 the size of a state senatorial district. That's a lot of territroy.

The average state senator hasa probably in the neighborhood of \$100,000 - \$250,000 to spend campaigning and I just cannot believe a candidate for the State Board of Education is going to be able to raise anywhere near that amount of money. The important question occrs, how are we going to know who to vote for for that very important

position? Since the 15 member State Board of Education is going to be primarily responsible for the future direction of education in this state, the election of a competent board member is probably more important than the election of either a state representative or state senator. If either a representative or senator makes a serious mistake, there are at least 180 other people to catch that mistake, plus the oversight of the executive branch of government. If a State Board member makes a serious mistake, there will only be 14 other people to exercise that same degree of care.


