

Anyone who votes in the Republican primary on May 3 is eligible to participate in the Precinct Convention. The Republican Precinct Convention will be held at the new fire station immediately after the polls close at 7 p.m.





# COMMISSIONERS FENCE WITH PROBLEMS

EASTLAND - Eastland County commissioners Monday approved Commissioner-Precinct 2 W.C. Riddell's request to delegate additional responsibilities to one employee and increase his salary accordingly.

Bobby L. Boles will receive a pay increase for being responsible for locked doors and others tasks around the precinct barn in Ranger.

Riddell lives in the southern edge of the precinct, and some tasks around the precinct barn requires someone living closer to take care of them.

Problems with payments for fencing a farm-to-market road in Precinct 3 were hashed over. Checks to fencing contractor, George Fox, included the names of property owners, two of whom refused to endorse their checks to Fox.

Commissioners said James Morgan Mason had complained he was not satisfied with the fencing and had requested his old fence be rolled up by Fox and brush and timber on the county right-of-way be pushed onto his property to enbable him to saw it into pieces.

Commissioners voted to stop payment on the check for \$1760.10 and make a new one payable to Fox alone.

Larry Stewart refused to endorse his \$325 check. He told contractor Fox that a gate that was moved and reinstalled now 'drags the ground.'

When commissioners were advised Stewart would be willing to meet with anyone at the site and discuss the problem, Precinct 3 Commissioner L.T. Owen and District Attorney Emory Walton made an appointment.

Fees for civil process by the sheriff's department were set and adopted. Patterned after Parker County, they will be increased slightly.

They approved purchase of right of way for a farm-to-market road slated to be constructed from Gorman, in Eastland County, to the Oliver Springs Cemetery in Comanche County, a distance of 5½ miles.

Commissioners approved the request of three land owners along State Highway 6, north of Carbon, to have a strip of abandoned roadway returned to the oritinal

Second signup for Conservation
Reserve Program set for May 5-16.

WASHINGTON\* April 17--Farm ers who want to bid to enter their highly erodible cropland into USDA's conservation reserve program may do so during the program's second sighup period, May 5-16.

Secretary of Agriculture, Richard E. Lyng, said producers will be offered the option to bid for a conservation reserve program contract beginning with either the 1986 or 1987 crop year.f

For contracts which are effective immediately, annual payments will be made beginning Oct. 1, 1986. Producers can not harvest any 1986 crop planted on land to be placed in the program. Any producer who has had or will have a crop mechanically removed from the designated area is ineligible for a 1986 contract.

For contracts which become effective on Oct. 1, 1986, or later, producers will be allowed to harvest their 1986 crop, and no annual payments will be made before oct. 1, 1987.

USDA will establish maximum acceptable rental rates after the end of the signup and bid data have been evaluated.

Additional signup dates for the 1987 crop year will be announced

For the 1986 signup, designated cropland may be grazed until the Commodity Credit Corporation enters into a conservation reserve program contract with the producer and notifies him that livestock must be removed to comply with contract provisions.

Land that is designated for 1987 contracts may not be grazed after Oct. 1, 1986.

Agricultural stabilization and conservation state committees may reestablish pool boundaries for the second signup period.

The only acreage limitation that applies for the second signup is that a maximum of 25 percent of the cropland in a county may be entered into the program.

During the first signup period, which ran March 3-15, 838,356 acres of highly erodible cropland were entered into the conservation reserve program. Accepted bids ranged from \$5 to \$90 per acre, and the average bid was \$41.82 per acre.

#### EXTENSION AG ENGINEERS FOCUS ON IRRIGATION EFFICIENCY, SAFETY

Texas Agriculturalj Extension
Service programs related to irrigation efficiency, farm safety and other
areas benefit Texans in numerous
ways, including reduced irrigation
costs, increased water conservation,
and reduced farm-related deaths and
injuries.

"These educational progrms, however, will be affected by decreased resources should additional budget cuts at the state level and proposed reductions at the federal level take place," says Extension Service Director Zerle L. Carpenter. "While the Extension Service will continue to focus its efforts on high quality educational programs aimed at meeting the needs of clientele, budget restraints will definitely limit the scope of these programs," he adds.

This report of a successful educational effort clearly demonstrates that public funding for Extension is an investment which returns economic benefits in excess of funds committed to the Extension system, Carpenter notes.

The key tool in helping farmers with irrigation efficiency has been an intensified demonstration program, points out Wayne Keese, Extension Service agricultural engineer.

Over the past 10 years, on-farm demonstrations of irrigation pumping plant efficiency testing have shown a tremendous potential for cost reductions in farm irrigation pumping--\$1.23 per hour on the average natural gas-powered pump for a furrow system, 56 certs per hour for the average diesel-powered pump, and \$1.30 per hour for the average electric-powered pump.

"The typical irrigation pumping plant in the Texas High Plains, which boasts the largest irrigated crop acreage, operates about 2,000 to 2,400 hours a year," Keese points out. "Real savings are possible by keeping irrigation systems in good working order and by practicing other management techniques."

On-farm demonstrations with the Low Energy Precision Application (LEPA) irrigation system developed by a Texas Agricultural Experiment Station engineer also have shown the potential for reducing both costs and water usage. According to Keese, water application efficiency can be increased from 75 to 80 percent for a typical center-pivot sprinkler system to 97 percent with the LEPA system." This means about a 20 percent reduction in pump operating time and total water use," he notes.

Also, the LEPA unit can reduce required operating pressure 15 to 20 pounds per square inch or more, reducing pumping costs by \$1 to \$1.25 per hour for a quarter-mile system, or \$2,000 to \$3,000 per year for the typical High Plains center-pivot irrigation system.

A statewide educational program in farm and ranch safety conducted by an Extension Service safety engineer has contributed to a reduction in fatalities and disabling injuries from farm and ranch accidents. Over the past five years, farm and rural accidents have decreased 28 percent from the previous five years, representing a decrease of 255 fatalities and 25,000 disabling injuries. This corresponds to a savings in

medical costs alone of almost \$13 million, says Keese.

Further, increased family income due to prevented fatalities is estimated at almost \$32 million during this period. At a 15 percent tax rate, this means an increase of some \$4,800,000 in federal tax revenues.

Other educational programs by the Extension Service in agricultural engineering also have paid dividends. For example, Extension agricultural engineers helped farmers in Waller and Harris counties learn how to use municipal sludge from Harris County on their cropland. This has resulted in an annual savings of \$40 to \$50 per acre in fertilizer costs, which amounts to at least \$35,000 per year on certain farms in those counties, Keese reports.

In addition, result demonstrations at northern Texas dairies have shown how dairymen could harvest fertilizer nutrients worth \$2 million annually from dairy manure treatment lagoons by adopting recommended irrigation practices.

And an Extension agricultural engineer guided staff of the Texas Water Commission and leaders of livestock and poultry associations in the development of a state technical guideline for adequate, yet affordable, water pollution abatement from feeding facilities.

# MESSAGE TO WASHINGTON

#### ASSUMABLE PROPERTIES SOUGHT

MESSAGE—I am interested in assuming existing Federal Housing Authority Loans, particularly of seized and foreclosed properties available in counties around where I live. I need information on what kinds of loans are available, current interest rates, how to assume existing loans and closing costs. Is there a list that indicates available properties with dates and times of sales? Since I am new to Texas, I have not been able to locate this information. M.J.—Austin

SENATOR BENTSEN RESPONDS—Officials with the Department of Housing and Urban Development tell me that a member of their Property Disposition staff will contact you to explain procedures and properties they advertise for sale. A listing of properties for sale is sent each week to their mailing list of licensed real estate brokers. You will be instructed on how to submit offers for these properties and how to sign up for a real estate broker's mailing list.

#### TAX PENALTY PROTESTED

MESSAGE—Even though I receive insurance benefits, I work because I want to be self-supporting when I retire. I prepare my own taxes and submitted my return before April 15. The Internal Revenue Service deducted a penalty from my refund because I didn't pay estimated taxes periodically during the year. This "Estimated Tax by Individual" law is going to force me to get professional help preparing my tax returns and that's not fair. I can understand a business having to report more than once a year, or even people paying more than \$10,000 a year in taxes, but why should people in my circumstances? C.A.—Houston

SENATOR BENTSEN RESPONDS—IRS officials advise while taxes are withheld from your wages, they are not withheld from your insurance benefits. Every taxpayer in similar circumstances must pay an estimated tax on that extra income periodically during the year. This law simply makes taxes a "pay as you go" matter on both wages and other taxable incomes.


