- 3. All creditors and parties in interest.

The following is the agenda for the status conference:

- A report by the District on the status of this case including a report on the meeting of creditors. In connection with that report, the District shall submit to the Court five days in advance and have available for inspection by the public the following items.
 - (1) A balance shett of the District dated not more than thirty prior to the status conference.
 - (2) A detailed income and expense statement of the District for the months of January through May, 1988.
 - (3) A listing of the assets of the District with an estimate of the fair market value of each as established by the Board of Directors of the District. All major assets shall be listed separately.
 - (4) A listing of all obligations owed by the District including the name, address and amount owed to each creditor. These shall be summarized on a cover sheet with appropriate categories and the total liabilities shown.
 - (5) A delinguent tax roll giving the name and address of each delinquent taxpayer, the amounts owed by that taxpayer by years and the total amount now due. A cover sheet shall summarize the delinquent taxes by year and show the total amount of delinquent taxes.
 - (6) The tax roll for 1988 if it has been prepared. If the tax roll for 1988 has not been prepared, the oral presentation shall include a statement as to the estimated total valuation for 1988 taxes, the estimated tax rate and the estimated total taxes. If the tax roll has been prepared a cover sheet shall contain such information.
 - The Court will consider the appointment of a creditor's committee and any other appropriate committees.
- Such other matters as are appropriate at a status conference.

The attorney for the District shall within fifteen days after the entry of this order serve copies on all creditors and parties in interest and all other persons and entities mentioned in this order, and shall furnish an appropriate certificate of service to the Clerk of this Court. The District shall cause this order to be published once each week for three consecutive weeks prior to the date of the status conference in a newspaper of general circulation in Eastland County, Texas.


