-GP-CITY CHIT CHAT By Mayor Charlie L. Garrett

I have had some ask me what the requirements are to run for a place on the city ballot.

One must meet requirements as set forth in the Texas Election Laws, must have been a resident of the City of Gorman for six months and meet any other special requirements that might be set forth in the City Charter of a Home Rule City. (See Sec. 143.005, page 338 of Texas Election Laws.) Gorman is a Home Rule City and it states in the City Charter, Article IV, Section 4, Qualifications of Officers: The Mayor and each of the City Commissioners shall be resident citizens of the City of Gorman, having the qualifications of electors therein, shall not be indebted to the City, shall not hold any other public office of emolument, and shall not be interested in the profits or emolument of any contract, job, work or service for the City, or interested in the sale to the City of any supplies, equipment, material or articles purchased. Any member of the City Commission, who after being elected thereto, cease to possess any of the qualification herein required, shall forfeit forthwith his office and any such contract in which such officer is or may become interested shall be void.

Born in Cleburne, he lived in Comanche most of his life before moving to Stephenville. He was a driver for Ingram Concrete Company.





Series E Savings Bond **Stop Earning Interest** At Age 40 Years

Persons holding Series E U. S. Savings Bonds, issued in 1948, should redeem or exchange them for Series HH Bonds since they reach final maturity in 1988 and stop earning interest.

Anyone holding 40-year-old Series E Bonds have two options; cash them in and declare the interest on their 1988 tax return or exchange them for Series HH Bonds and defer Federal taxes for another 10 years. An example: A \$1,000.00 Series E Bond issued in January 1948 with a purchase price of \$750.00 will cease earning interest in January 1988 with bond has \$4,506.40 accrued interest which must be reported as income on the 1988 tax return unless it is exchanged for a Series HH Bond and this interest deferred.

Owners are encouraged to roll these 40-year-old Series E Bonds over into Series HH Bonds. This roll-over option must be accomplished within twelve months of final maturity of the Series E. Roll-over will tax-defer the \$4,506.40 interest for an additional 10 years while providing the owner with current income from the Series HH Bond at a rate of 6.0 percent.

The Department of the Treasury urges all holders of Series E Bonds which are 40 years old to redeem them or exchange them for Series HH Bonds.



Creole - Cookery:

Make Memories With a Current Hot Trend

Conversation about favorite memories from childhood often turn to those related to food.

The remembrance of a special onedish meal simmering, sending its fragrant aroma through the household is at the top of the list. While the mixtured simmered, the anticipation of enjoying its savory flavor slowly built.



The 1986 Tax Reform Act made the investment tax credit a thing of the past, but old credits that had already been earned and were waiting to be used can still be carried forward to 1987 and future tax returns under special rules, according to the Internal Revenue Service.



Report Payments of \$600 or More

Farmers who make total payments of \$600 or more during a calendar year to another person, other than a corporation, must file information returns with the Internal Revenue Service to nonemployees, are reported on Form report these payments, the IRS says.

Payments for merchandise, freight, and similar charges, and for rental payments to real estate agents, need not be reported. Payments for compensation to employees that are reported on Form W-2, Wage and Tax Statement, need not be reported on a Form 1099.

Pacemaker Quickens 'Pace' of Life

When Irene Mikulewicz of Prescott, Arizona, replaced her old fixed-rate heart pacemaker with a new rateresponsive unit, the pace of her life quickened dramatically. The new pacemaker, called an "Activitrax," varies her heart rate from 60 to 150 beats per minute (bpm) to match her physical activity.

Says Mikulewicz, "Now I don't get breathless when I climb a flight of stairs. And when I lie down, my heart rate slows down. I'm finding I sleep better, too!'

The Arizona woman received her first pacemaker in 1978 when tests showed her heart rate had slowed to 30 to 40 bpm, and she became exhausted just walking across a room.

Her conventional fixed-rate pacemaker was set at 72 bpm and it helped her somewhat. However, when the level of her activity required a higher heart rate, she quickly became tired. "When the unit needed to be re-

placed," she said, "it made sense to replace it with the latest technology.' The new rate-responsive pacemaker is just that - "state of the art" technology - the first of its kind.

The pacemaker was developed by researchers at Medtronic, Inc., in Minneapolis. The device contains a crystal that acts something like a phonograph needle. When it detects movement of the body, it sends out electrical signals that change the heart rate.

The unit is about the size of a matchbook and is implanted under the patient's collarbone, similar to the conventional pacemaker. A 'target-tip'' lead wire runs through a vein to the heart, and it is this wire faster or slower.

Cost of the Activitrax is about \$4,800, a few hundred dollars more than for premium fixed-rate models. Medicare and private insurance generally cover the cost at the same reimbursement rate as conventional pacemakers.

This cut-away photograph shows some of the inner workings that stimulates the heart to beat of the remarkable Medtronic Activitrax rate-responsive pacemaker - the first pacemaker ever developed to automatically adjust heart rate in response to the ordinary activity of the wearer. Whether sleeping, walking, jogging or even dancing, the unit is capable of adjusting the heart rate anywhere from 60 to 150 beats per minute. The center portion of the photo indicates some of the electronic circuitry, and the bottom portion of the pacemaker's unique "sensing" crystal.

Be sure you use the tax form that is right for you.

There are three tax forms for individuals-short Form 1040EZ for certain single taxpayers. Form 1040A, and Form 1040. All taxpayers may use Form 1040 if they want to, but you will probably save time if you are able to use one of the shorter forms instead. However, some taxpayers must use Form 1040, as explained on page 8. The following chart (pages 6 and 7) shows the kinds of filing statuses, exemptions, income, deductions, taxes, and credits that can be shown on each of these three forms. Use it to help determine which form to use.

Should you use Form 1040?

Many people choose to file Form 1040 so they can itemize deductions. Itemizing often benefits you when you have large deductions for items such as real estate taxes, state and local income taxes, mortgage interest, charitable contributions, or medical expenses.

Even if it does not benefit you to itemize deductions, you are still allowed to claim adjustments to income for such items as penalty on early withdrawal of savings or alimony paid, or to claim certain credits such as the credit for the elderly or for the permanently and totally disabled. However, you must use Form 1040 to take advantage of these items.



Doctors may soon be telling heart patients that watching TV is good for their health. That's because a new "prescription" exercise video has been created by heart specialists specifically for people with heart problems.

Studies have shown that exercise can speed up a heart's patient's recovery, improve the quality of life and decrease the chances of another heart attack. Yet an estimated 75 percent of all heart patients do not have access to formal exercise rehabilitation programs. In addition, most insurance policies cover only 12 weeks of rehabilitation.


Commodity Credit Corporation Loans Receive Special Tax Treatment

Farmers may choose to report the proceeds from Commodity Credit Corporation (CCC) loans as income in the year the loan proceeds are received, according to the Internal Revenue Service.

Normally, income from a crop is reported in the year the crop is sold. However, if part or all of a farmer's production is pledged to secure a CCC loan, the farmer can choose to report the loan proceeds as income in the year the loan proceeds are received rather than in the year the crop is sold. This may be to the farmer's advantage because it more closely matches crop income with the expenses to produce the crop and is an easier accounting method.

For example, suppose that you reported a \$10,000 CCC loan as income in 1986. In 1987, the market price for corn is higher than the loan value (support price) and so you redeem the loan for \$10,000 plus in-



terest and storage costs of \$950. If the corn is sold for \$12,000, you have a gain of \$2,000 (\$12,000 minus \$10,000). Also, you would have interest and storage costs of \$950 to deduct in the year paid.

If you do not choose to report CCC loan proceeds as income and you use a commodity certificate to repay the loan, you will recognize income in the year the loan is repaid. The amount of income you include that year is the amount by which the face of the loan exceeds the amount of the certificate. Later when the commodity is sold, you will recognize gain for the full amount received on the sale.

Heavy Vehicle Use Tax: Exemption for Some Farm Trucks

According to the Internal Revenue Service, liability for the federal heavy vehicle use tax may be suspended for an agricultural vehicle under certain circumstances. The tax may be suspended during a tax period if it is reasonable to expect that during the period an otherwise taxable highway motor vehicle used for agricultural purposes will be used on public highways 7,500 miles or less (5,000 miles or less for non-agricultural vehicles).

An agricultural vehicle is any highway motor vehicle that is:

· Used, or expected to be used, primarily for farming purposes, and


· Registered as a highway motor vehicle used for farming purposes under the laws of the state in which the vehicle is required to be registered. A highway motor vehicle is used primarily for farming purposes if more than half of the vehicle's use, based on mileage, during the tax period is for farming purposes.

To qualify for the suspension of tax, the owner of the vehicle must complete a statement in support of the suspension of tax on the first Form 2290, Heavy Vehicle Use Tax Return, filed for the period. If, while the tax is suspended, the vehicle is used on public highways for more than 7,500 miles during the period, the owner must pay the use tax for the entire tax period or part of the period for which the vehicle is in use, regardless of when it exceeded the 7,500 mile total. The tax is reported on a Form 2290 filed by the last day of the month immediately following the month in which the vehicle exceeds 7,500 miles for the period. If an agricultural vehicle on which use tax already has been paid for the tax period is used less than 7,500 miles on public highways, the owner may claim credit for the tax on the first Form 2290 filed for the next tax period, or may file a claim for refund of the tax at the end of the tax period. The tax period for this tax is from July 1 to June 30. Additional information is in free IRS Publication 349, Federal Highway Use Tax on Heavy Vehicles, available by sending in the order blank in the tax package or calling IRS toll-free at 1-800-424-3676.
