VOTERS APPROVE TO DISSOLVE HOSPITAL DISTRICT

Voters in the district approved the dissolvement of the South Eastland County Hospital District in the election held on Saturday. Of the 88 votes cast 84 were in favor of dissolving the district and 4 voter against the proposal.

The district's remaining assets and obligations will now be transferred to Eastland County and the county will assume indigent helath care and any delinquent district taxes will go to the county.

In 1967 the hospital district was created by the legislature and voters of the proposed district to keep Blackwell Hospital in operation.

The hospital closed in 1986 after serving the community's health care needs for 67 years.

When the hospital closed it was \$600.000 dollars in debt. The hospital board of directors declared bankruptcy in order to have time to pay creditors. An auction of the hospital

equipment, etc. was held to pay

some of the outstanding bills. Taxes were continued to be collected and when Dr. Clay Salyer purchased the hospital building in May of 1989 the district became debt free and Gov. Bill Clements signed into law a bill, HB1841, which provided for the election for dissolvement of the hospital district by the voters of the district. The bill became effective August 28, 1989.

The hospital is currently under the ownership of the Dublin Recovery Centers, Inc., who is anticipating the renovation of the building which is expected to house approximately 80 patient beds for acute care and chemical dependency patients.

The renovation project has not begun at this time and an opening date has not been set as yet.

Local folks are looking forward to the opening of the Dublin Recovery Center and it's economic impact on this area.

City To Perform **Smoke Tests On Sewer System**

You've heard the old saying, "Where there's smoke, there's fire" haven'T YOU? Well, it may not hold true during the coming weeks. The city crew and an engineering staff from Abilene will be injecting smoke into the manholes around town in an effort to locate and repair leaks in the wastewater collection system.

These tests are one of the steps being required by the Texas Water Commission to try to bring our waste water collection and treatment systems into compliance with State and Federal guidelines. It also makes it possible for us to locate sources of methane and hydrogen sulfide gas leaks in or under houses.

So, if you notice smoke coming from your rain gutter, vent stacks, or anywhere around your house while these tests are being done, don't panic! Call the City Office at 734-2317 and we will let you know if the smoke tests are being done in your area of town.

We will try to keep you informed as to the exact date that smoke testing will begin.

ROCK BLUFF COMMUNITY

by Jewell Dukes Huddleston An exchange of telephone calls and a gracious invitation from Bernice Farley set up another meeting to discuss early days at Rock Bluff.

There is always one ol' Timer who can remember names, dates and places better than others and this party was Vernon Skaggs, who started to school at Rock Bluff in 1917, and was one of the pupils that transferred to Duster when the schools consolidated in 1924.

Vernon was a mite late because he had been fence-fixing over Suez way. However, to be able to look after livestock and work on the fence at his age is the best part of our story. And there was nothing wrong school teachers from 70 years was named. agol

I might add that our gathering was made up of descendants of Frank and Lizzie Skaggs. This included Elsie Skaggs Robinett, Bernice Skaggs Farley, Marie Skaggs White, Vernon Skaggs and Jackie Robinett.

Bernice had a copy of the church records dating back

to 1878, written in longhand, giving names, dates and happenings relating to the church and its members. It was interesting to note that on more than one occasion a church member was spoken to for unchristian-like behavior.

brought up the customs of long ago. Vernon told of plowing the fields behind a walking cultivator and the principal crops were corn and cotton for the boll weevil had not destroyed the money crop back

Bernice, Elsie and Marie all turned to Vernon and said, "When our cotton was weighed and our sacks emptied you could easily pick out Vernon's. It didn't have a speck of trash in it"!

At the school Spelling Bee's Elsie and Vernon were the winners! Vernon said that there were times he misspelled on purpose so he could sit down. He named some teachers of that era: Myrtle Gregory, Faye Miller, Mittie Rackley, Lewis Roach, Gene Pettit, Gladys Toland, Sam Reed.

Teachers boarded with farm families in the community, during the seven month school term. Recess and dinner ended with Teacher ringing a handbell while standing in the school house door.

On the playground, Two-Eyed Cat was a popular game, and spinning tops were fun, especially if you could plug the other feller's top!

Candy-breakin's was a community social that young people enjoyed and the ol' swimmin' hole was another gathering place.

The Skaggs' family dog, Jack, went to school, too. When children were scolded by Teacher for being too noisy they pointed out the wisdom to Jack and said he was the culprit.

All members of the family recalled the chores and household duties. At hogkilling time Bernice was old enough to stir the black wash-pot filled with fat meat that would be cooked into lard. Other, older members, helped with sausage-making and Marie and Elsie remembered the home-made sacks that were used.

When Rock Bluff consolidated with Duster those Model T school buses provided transportation down the sandy lanes. Vernon recalled the time the bus got stuck in the sand beds and everyone hopped off and pushed ... and the journey continued.

One holiday memory that the Skaggs children recalled was the year their mother, Ms. Lizzie, walked down the railroad track, from Rock Bluff to Blair's Store at Duster to sell eggs for Christmas money. She carried 10 dozen, but no one remembered the price that eggs were that year.

Vernon recalled taking corn to Duster to be ground into meal. He also recalled Frank Rhodes' son, Morgan, that his classmates called, "Slats", because he was tall and slender.

Both Elsie and Marie identified with feed-sack prints that were recycled into clothes. And the old water jug that was carried to the field, with a tow-sack wrapper, wet down, to keep the water cool.

In the Rock Bluff school days, everyone carried a dinner bucket. School lunch usually consisted of a couple of biscuits and sausage patties and a fried pie for dessert. If no dried fruit was available, the fried pie would be filled with sugar and butter and cinnamon for flavoring.

Vernon was a classmate of mine at Duster. But he was not the boy who sat behind me and put my braided pig-tails in his ink-well, ribbons and all!

Furthermore - Vernon said W. C. Winkles would NEVER throw an eraser when the teacher's back was turned! School days, school days -

Dear old golden rule days -Readin' and writin' and 'rith-

Taught to the tune of a hickory stick!

What memories! And a special thank you to the Skaggs clan for their gracious outreach and cooperation. Their family history reaches back to Londonderry, Ireland, almost 300 years ago. But today, when we think of Rock Bluff, we think of the Skaggs name.

LIST OF UNCLAIMED FUNDS BY TEXANS RELEASED

State Treasurer Ann W. Richards said Friday that more than 120,000 Texans have \$99 million in lost or forgotten money coming to them this year-up 65 percent from last year's \$60 million.

The 120,000 are named in the 1990 version of the Texas Treasury Unclaimed Money Fund List which will be published on Sunday, March 4 in 27 newspapers.

"Each year we try to locate as many people as we can and return this money to them," Richards said. "Last year about \$26 million was given back to rightful owners."

All losted accounts are worth at least \$50 with the largest account worth close to \$103,000. All safe deposit boxes and stocks are listed regardless of the value.

Generally, accounts on the list are from checking and savings accounts, utility deposits, oil royalties, and xorporate stocks.

Most accounts must be dormant from three to five years before they are turned over to the state.

"There is no set time to make a claim on these accounts," Treasurer Richards said. "Money turned over to the State Treasury can be claimed at any time in the future by the original owner of his or her heirs."

Persons who find their names on the list can call the Texas State Treasury on its toll-free telephone line at 1-800-654-2463 or they can write the State Treasury at P. O. Box 17728, Austin, TX 78760. The tollfree line opens at noon on March 4.

During the first few weeks after the list is published, the toll-free line is often tied up by the volume of calls. The lines, however, are kept open for an extended period and there is no time limit for making a

The telephone hours are 8 a. m. to 8 p. m. Monday through Friday from March 5 through April 6. After April 7, the hours will be from 8 a. m. to 5

The Unclaimed Money Fund List was first published shortly after Richards took office in 1983 and she has made collecting and returning unclaimed money one of her top priorities.

Since she took office, the Treasury has collected more than \$273 million in unclaimed funds, which is almost 86 percent of all such funds ever collected in the State of Texas. About 96 percent of all funds returned in the 28-year history of the program have been returned during the seven years of the Richards Administra-

Money that is not claimed by owners is used by the state for education and general state services such as highways and law enforcement. Last year, for example \$40 million in non-tax revenue was turned over to the Foundation School Fund and the General Revenue

Special Free Tax Advice For Older Citizens

If you're an older American, be sure you're not missing out on some important tax benefits, says the American Association of Retired Persons (AARP). For example, there is the credit for the elderly or disabled. This credit could reduce the taxes you pay if you are age 65 or older, or if you are disabled. The credit is based on the taxpayer's income, filing status, age, and spouse's age (If the taxpayer is married). To figure this credit, use schedule R.

If you're 65 or older or blind and do not itemize deductions, the Internal Revenue Service says you may be entitled to take a standard deduction amount on your tax return for 1989 that is higher than the amount available to other taxpayers. The standard deduction table in the 1040 instruction booklet can help you determine your deduction.

As an older American you may have to file a return. If you are single and age 65 or older, you generally need not file a 1989 return if your gross total income was less than \$5,850. If you would ordinarily file a joint return, and both you and your spouse are 65 or older, usually no return is rewuired unless your joint income for 1989 was at least \$10,400.

Are you thinking of selling your home? If you are age 65 or older, you may be able to take advantage of a once-in-a-lifetime \$125,000 exclusion on the gain from the sale.

Free tax assistance is available to low and moderate income older people through AARP's tax-aide program. Tax-aide volunteers are trained in cooperation with the IRS, and provide assistance from February 1 to April 15 each year. They can help you complete the necessary federal, state and local tax forms. To locate the tax-free site nearest you, contact Gorman Senior Citizens Center, telephone 817-734-2966.
