Referendum And Election Of T.P.P.B. Board Approaching

Mary Webb, Exec. Director Texas Peanut Producers Board

The Texas Peanut Producers Board will hold its biennial election on May 1, 1990. The current terms of three of the nine board members will expire at that time. (Two from Dist. 1 and one from State at Large). Any person living within the following counties who is engaged in the business of producing, or causing to be produced, peanuts for commercial purposes, is eligible to vote in his district, including owners of farms and their tenants and share croppers, if such person is subject to paying the assessment that is collected on peanuts within the following

District No. 1 includes the following counties: Coryell, Hamilton, Comanche, Brown, Mills, San Saba, McCulloch, Llano, Lampasas, Mason Gillespie and Runnels.

State at Large includes all the peanut producing counties in the State of Texas.

NOMINATION TO THE BALLOT

Any person qualifying to vote in the election may place his name in nomination for membership on the Texas Peanut Producers Board for a six year term from the district in which he farms by application to the above organization, signed by himself and at least ten other persons eligible to vote in the election. Such application must be received at least 30 days prior to the election date -May 1, 1990, in order to have his name placed on the ballot.

PEANUT REFERENDUM TO SET ASSESSMENT

Texas peanut producers qualified to vote in the election may also vote on a proposition to set the refundable peanut assessment rate in an amount not to exceed \$2.00 per net ton of farmers stock peanuts. Such assess-

If a tornado is sighted in our area, there will be a one-minute blast on the siren, followed by several shorter blasts. When this signal is heard, take cover immediately!

You can rest assured that during inclement weather, your fire and police departments will be on duty, observing the clouds so that the citizens of Gorman may have adequate warning before a tornado hits. In the past, citizens with CB radios in their cars have assisted the police department during weather watches. If you have a CB radio and wish to assist during severe weather, please call the Police Department at 734-2317, and you will be assigned a unit number and weather-watch area. For those of you who have CB radios at home and wish to listen, we will be operating on CB Channel 9, but PLEASE, just LISTEN! If too many people start talking, an emergency transmission from one of the mobile units may not be heard, and the siren warning not given in time.

Judge Bailey's work experience includes farm and ranch work, oil field labor, oil field supply store position with "Oil Well Supply" division of U. S. Steel Corp., High School teacher and part-time Jr. College Instructor. 

Support Levels Announced For 1990 Crop

Washington, Feb. 15 — The U. S. Department of Agriculture announed today that the national average support level for 1990 crop quota peanuts will be \$631.47 per short ton, compared with \$615.87 for the 1989 crop.

The following provisions were also announced:

— The national average support level for additional peanuts will be \$149.75 per short ton, unchanged from the 1989 crop.

— 1990 crop additional peanuts owned or controlled by USDA's Commodity Credit Corporation will be sold for export edible use at no less than \$400 per ton, unchanged from the 1989 crop.

CCC outlays for 1990 crop year peanut loans to producer associations will be subject to a reduction of 1.4 percent under the deficit reduction sequester order.

The Agricultural Act of 1949, as amended, requires that the national average support level for the 1990 crop of quota peanuts reflect any increase in the national average cost of peanut production for the preceding year, excluding any change in the cost of land. This statute also

The price support level for additional peanuts must be set at a level which ensures no loss to CCC from sales or disposal of the peanuts. In determining this level, USDA must consider the demand for peanut oil and peanut meal, the expected prices for other vegetable oils and protein meals and the demand for peanuts in foreign markets. The price support levels are subject to quality and other adjustments.





Plan Now For Severe Weather Ahead

Altnough tornadoes, severe thunderstorms and floods can strike virtually any part of Texas at any time, spring seems to bring an increase in violent weather.

You can take precautions to assist yourself and your family in the event

Periodically hold a tornado drill so that family members know what to do and where to go if the National Weather Service issues a tornado warning. The safest part of a house during a tornado traditionally is the basement, but be aware of the potential for flooding if there is heavy rain in the area. Interior bathrooms, hallways and closets on the ground floor also offer protection from tornadic winds. Avoid windows and outside walls. Take along blankets or sleeping bags to protect yourself from falling debric and shattering glass, which are frequently the cause of death and injury during a tornado.

Remember, if a tornado strikes, electricity, gas, water and sewer service may be disrupted for several days.

Mobile homes and automobiles are dangerous places to be during a tornado. If you live in a mobile home, make sure all family members know where the nearest substantial shelter is. If you are in your mobile home or car and can't get to a better shelter; go outside, lie down in the nearest ravine, ditch or culvert and cover your head with your hands. Be aware of the possibility of flooding in low-lying areas. Do not hide under your mobile home or car because both can easily be picked up and carried away by a tornado.

Your local (city or county) emergency management office can provide you with additional information on severe weather precautions. The Governor's Division of Emergency Management, the National Weather Service Service. the Texas Insurance Advisory Association and the Federal Emergency Management are the sources of information and publications on various weather phenomena for local governments.

There is a test drill slated for Wednesday, March 14th. There will be more on this drill at a later date.
