

#### **Tax Deferral Available** for Over/65 Residential **Homestead Owners**

Section 33.06 of the Texas Property Tax Code requires the following information concerning the Deferral of Certain Property Taxes to be publicized.

Property taxes on the residence homestead property of those persons sixty-five (65) years of age or older may be deferred or abated if they satisfy the requirements of the Texas Property Tax Code.

The property owner must (in most cases) occupy the residence on which the tax is being levied or on which a suit has been filed for collection of delinquent taxes.

To obtain a deferral, the individual must file with the Chief Appraiser of the Appraisal District in which the property is located: an affidavit stating that he or she is sixty-five (65) years of age or older and that he or she does own and reside in the residence that the tax is being levied on.

## **'Peanut Express' Receives Funds**

The Texas Department of Economic Development is shelling out \$2 million to improve railroad tracks between Dublin and Gorman.

Eastland County commissioners signed contracts Monday accepting the grant from the state, said County Judge Brad Stephenson. The Rail Infrastructure Grant wilt be used to replace timbers, the gravel railroad bed and some of the rails, he said.

Known locally as "The Peanut Express," the roughly 20-mile railroad serves peanut processors in DeLeon and Gorman.

The grant through the Texas Capital Fund will help retain jobs at Birdsong Peanuts in Gorman, Golden peanuts in DeLeon and Gorman milling, Stephenson said.

The peanut industry is one of the largest employers in Eastland and Comanche counties, but it has fallen upon hard times. The government controls how many acres can be planted in peanuts and in recent years many local producers have sold their allotments to farmers in Haskell County and in the Texas Panhandle.

The lack of a local supply of peanuts puts the three peanut processing companies at a disadvantage. Improving the railroad will help shipping products in and out, Stephenson said.

In Dublin, the line connects with the South Orient Railroad, a route that runs from Dallas-Fort Worth to Mexico.

Aside from peanuts, Gorman Milling receives eight railcars of corn a day, the judge said. However, rail shipments must be unloaded at Ranger and trucked to Gorman because the railroad is in bad shape.

Cars frequently derail on the old tracks, he said, and the speed limit is only 20 to 25 mph.

The \$2 million grand does not require any matching funds. Stephenson said a grant administrator has been hired and he expects work to begin within a few months.

tax unit, the individual must file with the court in which the suit was filed the same type of affidavit.

By filing the affidavit with the proper authority, the payment of taxes or forced collections through suit is postponed until the person filing the affidavit no longer owns or occupies the property as a residential homestead.

It is emphasized that the tax is only deferred; it is not cancelled. A tax lien remains on the property and interest in the amount of eight (8) percent per year will continue to accrue during the period that the collection of taxes is deferred.

Wayland Shurley, State Executive Director for the Farm Service Agency (FSA), presented the Eastland County FSA team with a plaque. Service Center Personnel were recognized for their, "Outstanding service and tireless dedication in assisting local farmers and ranchers during the 1999 and 2000 program years," said Shurley.

According to Shurley, "FSA has sustained a 30% reduction in staffing over the past decade whil program payment distribution to producers has doubled since 1995. The farmers and ranchers of Eastland County are fortunate to have reliable, effective and efficient USDA program deliery provided by a dedicated staff."

USDA's Farm Service Agency is responsible for the administration of farm programs and farm loans including distribution of payments associated witht he Conservation Reserve Program, production flexibility contracts, commodity and livestock disaster programs, marketing assistance loan programs and operating/ownership loans.

Direct payments to Texas farmers and ranchers for 1999 and 2000 totaled \$4.1 billion. Statewide, \$385 million was distributed through commodity loans, \$143 million in direct farm loans and \$308 million in guaranteed farm loan commitments. in two years, approximately 700 FSA County Office employees processed an average of 1,000 payments per employee. "The Eastland County FSA personnel are comended for their steadfast perservance during a continued USDA trend of accomplishing 'more with less'," said Shurley. "During these times of increased workload and reduced resources, Texas FSA has done an outstanding job delivering programs to the State's producers while maintaining and improving program integrity." The Eastland County Office is one of twenty in the state to receive the distinguished service award. Staff members are David W. 
#### J. L. McDaniel Laid To Rest







### **TSTC Sweetwater to Host Spring Junior/Senior Technology Day**

High School Juniors and Seniors, parents, teachers and counselors are invited to TSTC Sweetwater's semi-annual Junior/Senior technology Day on March 2, 2001. Visitors will tour the campus and the various technology programs.

If you are the owner of land that is being currently used for some type of agricultural use or activity; you may qualify your land for a special use valuation for ad valorem tax purposes.

Land owners who have not already filed must file for special use valuation with the Eastland County Appraisal District by May 1, 2001. The Texas Constitution provides for two (2) types of agricultural productivity appraisal. Article 8 Section 1-d-1 allows what is known as Open Space Land Appraisal; while Article 8, Section 1-d allows agricultural use appraisal. The requirements for applying and qualifying both the land and the owner are different for each of the two types.

Most property owners apply for the 1-d-1 or Open Space appraisal. This special appraisal requires that the land's use in a qualifying agricultural endeavor meet the degree of intensity merally accepted in the area. The wner must show that the land's use is devoted principally to agricultural use and that it has been for at least five (5) of the preceding seven (7) years.

Landowners should be aware that the law does require a rollback to be incurred when the qualified land is taken out of agricultural use. The rollback tax includes the difference between the taxes paid under agricultural appraisal and the taxes that would have been paid if the land had been on the tax roll as market value. The law also requires that the rollback tax include interest charges of seven (7) percent per year.

The application must be submitted on a form prescribed by the Property Tax Division of the State Comptrollers ice. The application must contain the information necessary to determine the validity of the application.


