Sheriff Ronnie White Announces For Re-Election

I have strived to employ honest, capable and hardworking employees who enjoy their work. I have implemented training programs to keep up with the ever-changing laws, reduced the cost of the operations of the

jail and the Sheriff's department. I and my deputies have increased the follow-up investigation of offenses with a recovery rate of 42 percent for 1991. The recovery rate for the previous year was 17 percent. The department has been very active in drug investigation resulting in the closing of two drug labs and seizing three automobiles and one farm this past year. We have also implemented programs using the inmates in the jail to work for the county. My plans are to continue the drug investigations in earnest, implement a county truck farm operated by the inmates with the produce to be used to feed the inmates and to distribute to our senior citizens. I will continue to use inmate labor to help with the maintenance of the courthouse and the

My wife, Pam, and I have been married for 29 years and have two children, one son-in-law and one granddaughter we are very proud of. Our daughter, Robin, is married to Joe Don McCollum of Okra. Agriculture Viewpoint

By M. Davy Vestal

As my first week as Agriculture Agent in Eastland County winds down, I want to express my appreciation to Texas Electric for their hospitality in hosting a welcoming reception for my wife and I.

We are both excited about the future, and being in Eastland County. I've had the opportunity to meet many folks this week and look forward to getting to know the clientele both 4-H and Ag related as well as community involvement.

I've had numerous calls and office visits this week with home owners and yard managers in regards to fruit and nut tree pruning.

In regards to fruit tree pruning, we at the TAEX suggest you not prune until you observe bud swell on the trees. Commercially speaking this is not possible due to the fact the job would never get done unless you

What branches should I prune? Basically you have three types of branches - Primary (main branch or trunk) Secondary and Tritiary branches. A producer needs to consider what condition the tree is in, age, soil, root development, etc.

Fruit and nut trees should not be pruned in the first two years of growth according to Specialist with the TAEX. The extra branches increase root development and subtainability of the tree.

When you decide it's time to prune, remember the first season after pruning is normally a depressed production year. Your gain should be in the following two years.

Shape the tree to your desire remembering that 75 percent of the fruit and nut production stems from the tritiary branches which are shoots off the secondary branches. So secondary branches need to be spared, where possible, from pruning because tritiary branches form

Remember a good zinc fertility program can do wonders for a depressed pecan tree.

For more information on fruit and nut tree pruning, fertility or over all management, stop by the Basement of the Eastland County Courthouse in the office of the Texas Agricultural Extension Service.

Well it's beginning to be not near as hard to say "I'll be glad when it dries up". This weather is past the point of a drawback as far as agri-producer operations are concerned. Wheat has virtually "stopped" growing from the inclement weather and with the on-going situation peanut producers are feeling the pinch of set back as well.

Ground breaking that usually begins this time of year may be set back for sometime, depending on when this "thing" passes.

Nevertheless, we can't control the weather and I know that before long

For homeowners this may be just what the doctor ordered, however. Now, with this moisture situation, would be an excellent time to apply one of the pre-emerge herbicides for the control of unwanted broadleaf weeds such as hesbit and dandelion. Added fertilizer at this point should be held off until at the earliest the last of February. Now would be a good time for some soil testing both on the farm and at home. After all, if we're going to spent dollars adding fertilizer it would certainly help to know just what fertilizer you need and how much.

ASCS ANNOUNCES DISASTER

PAYMENT PROGRAM The Agricultural Stabilization and Conservation Service will administer a crop disaster assistance program to compensate eligible producers for crop losses caused by drought, flood, and other natural disasters in either 1990 or 1991.

"To be eligible, producers with crop insurance must have had losses greater than 35 percent," said ASCS official Jerry Harris, Chairman of the Texas State ASC Committee. "Prodcers without crop insurance must have had losses greater than 40 percent."

Program applications may be filed from February 3 through March 13.

The 1990-91 crop dosaster program provides cash payments for production losses on participating program crops of wheat, feed grains, upland cotton, extra long staple cotton, and rice; nonparticipating program crops; peanuts, soybeans, each year from the secondary bran-sunflowers, sugar beets, sugarcane and tobacco; and all commercial nonprogram crops.

Harris said producers who intend to file should begin to assemble their records now, so they will be ready when the program opens. He said that farmers will receive a special mailing with specific information on the program this month. "If a producer does not receive the disaster program information in the mail by February 3, he or she should call the county ASCS office."

Harris explained that a producer may not file on one crop on a farm for one year and a different crop on the same farm for the other. "However, the producer may request benefits for 1990 on one farm and for 1991 on another farm."

The ASCS official said disaster payments would be computed acccording to the 1990 Farm Bill, and expects to begin issuing payments to farmers by April 16. Further details of the disaster payment program may be obtained from the local ASCS

4-H OFFERS SUMMER **EXCHANGE WITH RUSSIA**

National 4-H Council is forging new ground with their summer travel program to Russia. Tentative dates are June 19 through July 26, 1992. U. S. participants, both 4-H'ers and non-4-H'ers, will experience the mystique and excitement of a country on a new politcial horizon.

U. S. outbounds will begin their journey on June 19, with an orientation in Washington, D.C. Before departing, participants will learn about new changes in the country and aspects of Russian culture.

Delegates will arrive in Moscow on June 24, and will be given an in-depth background on the culture and history of the country before beginning their homestays. While in Moscow, exchange participants will visit Red Square and tour the Kremlin's Armory Museum which contains items from czarist Russia. As a part of their historical training, the U. S. visitors will take a trip to Zayorsk, home of the Russian Orthodox Church. While in the Russian capital, participants will sail up the Moscow River, attend the Russian Circus and experience Russian cultural performances including folk dances and marionette recitals.

Participants will spend a one-week homestay with host families from the area to find out what daily life is like in Mother Russia. Host families will be encouraged to make the U. S. participants "one of their own".

Before returning to the states, participants will tour the Golden Ring Cities and Moscow for an evaluation and debriefing. Once back in Washington, D. C., participants will meet their Russian counterparts, who will have been involved in touring Washington, D.C., experiencing a U. S. homestay and attending the World Focus program at the National 4-H Center, before returning home to their families on July 26.

Prices for the program have not been confirmed at this point, but officials at National 4-H Council esti-□mate a cost between \$4,060 amd \$4,360 for U. S. participants.

Tax Deferral Available For Over 65 Homesteaders

Section 33.06 of the State Property Tax Code requires the following information concerning the Deferral of Certain Property Taxes to be publi-

Property taxes on the residence homestead property of those persons sixty-five (65) years of age or older may be deferred or abated if they satisfy the requirements of the State Property Tax Code.

The property owner must occupy the residence homestead on which the tax is being levied or on which a suit has been filed for collection of delinquent taxes.

To obtain a deferral, the individual must file with the Chief Appraiser for the Appraisal District in which the property is located, an affidavit stating that he or she is sixty-five (65) years of age or older and that he or she does own and reside in the residence that the tax is being levied

If a suit has already been filed by a tax unit, the individual must file with the court in which the suit was filed the same type of affidavit.

By filing the affidavit with the proper authority, the payment of taxes or forced collections through suit is postponed until the person filing the affidavit no longer owns and occupies the property as a residence

Although the tax is deferred; it is not cancelled. A tax lien remains on the property and penalties and/or interest may continue to accrue during the period that the collection of taxes is deferred.

For information concerning the tax deferral or abatement, contact the Eastland County Appraisal District. The office is located on the second floor of the Eastland County Courthouse and the phone number is 629-8597 in Eastland.
