

Lady Panther Softball Season Comes To An End

The Lady Panthers dropped a 2-7 decision to the Albany Lady Lions this past Friday in a district play-off game to decide the second place representative for the state play-offs in district 6-A. Gorman fell behind early in the first inning by giving up 2 runs and scoring none. Albany tacked on another before the Lady Panthers pulled within 2-3. But that would be as close as it would get as Albany scored 2 in the 4th and 2 in the 6th to take the victory 2-7. The Lady Panthers finish the year at 8 wins and 6 losses. The 8 wins are a high mark for at least the last 4 seasons, it is the first winning season in at least the last 4 seasons, and it is more wins than the last two seasons combined. Although the Lady Panthers did not make the play-offs for the first time in several years, they did accomplish many positives through-out the year including winning our softball tournament for the first time in at least 4 seasons. With only one senior graduating from this year's team there will be high expectations set for next year's team.

"We played mostly freshmen and juniors with a couple of sophomores sprinkled in here and there, so the future looks to be bright at this time. 
Jerry Lee "Peanut" Yates

Much debate has surrounded the proposed 4A tax increase for the City of Gorman. I, like many other individuals of this community, am opposed to the proposed tax increase.

There are two recent publications I would like to respond to. One being from Mayor Tom Isbell of Anson. His comments appeared in a letter to Ms. Lori Dodd published in the Gorman Progress April 7, 2005. The second publication is that of a recent mail flyer sent to the residents of Gorman entitled: "How the 4A TAX INCENTIVE will make our community STRONGER"

Mr. Isbell portrays the 4A sales tax incentive as a viable revenue source for small towns. He uses his town of Anson as an example. Gorman and Anson are similar in ways, but are very different in others. First and foremost, with the diminished presence of Birdsong we have lost a major contributor to our economic and employment base. Subsequently, people have been displaced, disposable income reduced and employment sought elsewhere. Unlike the town of Anson these are individuals that will be effected by any tax increase.

Anson is approximately twice the size the Gorman allowing for a larger taxable base to generate more income. Anson is also intersected by Highways 277 and 180. It has two major highways, while Gorman fails to compare with only Highway 6. It stands to reason, two highways will produce more travelers to purchase taxable items. Anson is twice as likely to benefit from such a tax increase and do so more at the expense of non-residents.

As in Mr. Isbell's comments the said flyer, which it's origin is unidentified, indicates that tourist will support a large percentage of the burden. Realistically, this is unlikely. Occasionally an unfamiliar face is seen purchasing items in Gorman, but glance at the local businesses to see just how many tourist are patronizing our community compared to our residents. Not many.

Both the flyer and Mr. Isbell refer to new businesses opportunities being established through the proposed tax increase, when fundamentally businesses are opposed to taxes. Taxes impose a negative effect on businesses, on the economy and stifles growth. The flyer also states," pennies turn to dollars.", insinuating the tax increase is inexpensive. Most taxes are small until they are compiled one on top of the other. Pennies will turn to dollars and it will be dollars unnecessarily paid by the people of Gorman. Unfortunately, our elderly population, unemployed and those living on limited incomes which will be penalized most unfairly.

I commend the City of Gorman, as it has done a satisfactory job with only limited economic resources. Nevertheless, if there exists no deficiencies with local governmental funds there is no justification to increase any local taxes. Any other implementation only serves to unfairly take revenues from one and disburse to another. As citizens we are already taxed far in excess with further increases imminent. The American people currently bear too much tax burden. Where does it stop? Here? In fact, this tax proposal should be voted down on principle alone.

In closing, I offer a rebuttal to the statement made in the flyer that the, "4A Sales Tax Incentive will make our community STRONGER". There is no tax increase that will strengthen our community. It will be made stronger only by the longterm innovation, commitment and dedication of the people in our wonderful rural community. Support local businesses. Support the community. Vote your conscious on May 7th



Like Glasson, I urge you to talk to those currently on the board but you also should talk to other candidates for a place on the board. Gene Smith has some documentation if you care to look at FACTS about the matter rather than hearing that people are just a bunch of "disgruntled taxpayers." I continually wonder why some people are so afraid of Gene Smith being elected. You know, ten minutes after Mr. Smith signed up to run for the board on the last day, Daryl Hirst arrived at the school to sign up in opposition to Mr. Smith (the only two candidates for a one year term).

Neugebauer, House Vote to Kill Death Tax

Congressman Randy Neugebauer and the House voted 272-162 to put a permanent end to a policy that made death a taxable event.

"The Death Tax is unfair, hurts the economy, and punishes a lifetime of hard work," Neugebauer said. "It is about time that we put an end to the Death Tax, which has left many farmers, small business owners, and their families in its wake."

The Death Tax Repeal Permanency Act of 2005, H.R. 8, will extend the Death Tax repeal beyond 2010. Congress passed a law in 2001 to begin phasing out the Death Tax so that by 2010 it would be completely eliminated. However, the repeal would only be temporary as current law "sunsets" the repeal and reinstates the Death Tax on January 1, 2011. Death Tax rates would then revert back to pre-2001 levels when the top rate was as high as 55%. H.R. 8 strikes this "sunset" provision.

With tax day just around the corner, taxpayers know all too well that the government taxes their income, their savings, and their property each year," Neugebauer said. "It is grossly unfair that after many years of taking away hard-earned money from our farmers and small business owners, the government wants to take almost half of what is left when they die."

A wide range of leading economists, including Nobel Laureate Milton Friedman, and a large group of national trade organizations representing the small business and agricultural communities support permanent repeal of the Death Tax. The American Farm Bureau Federation, National Cattlemen's Beef Association, the Newspaper Association of America, the U.S. Chamber of Commerce, the National Family Business Institute, the Independent Community Bankers of American, and the Independent Insurance Agents of America are but a sample of the more than fifty organizations that have joined together to voice support for the bill.

H.R. 8 has garnered such strong support because in addition to being unfair, the Death Tax also undermines economic productivity and suppresses job growth. As a result of the Death Tax, businesses are spending money to hire accountants and tax advisers instead of additional employees. According to a July 28, 1999 Wall Street Journal report, nearly 60% of business owners say they would add a total of more than 100,000 jobs a year if they were not forced to comply with the Death Tax.

The House approved legislation identical to H.R. 8 in the 108th Congress by a 263-163 margin. Companion legislation is being introduced in the Senate by Senators Kyl (R-Ariz.) and Nelson (D-Fla.).
