The Gorman Boys' Team and Girls Team both finished 3rd at the Clyde Powerlifting meet this past weekend. The Girls took 3rd with 27 points behind Clyde's 58 points and Hawley's 35 points. The Boys tied for 3rd with Dublin at 22 points just behind Clyde with 56 points and Winters with 54 points. The Panthers and Lady Panthers had some fine performances Saturday with every lifter increasing their totals from last week's meet in Gorman.

# **USDA Approves Emergency CRP Haying and Grazing For Texas**

Farm Service Agency today announced approval for emergency haying and grazing of Conservation Reserve Program (CRP) acreage in Texas.

Emergency haying of CRP is authorized until May 1, 2006 and emergency grazing is authorized until June 1, 2006. Producers must acreage and visit the Natural Reobtain a modified conservation

"CRP annual rental payments will be reduced 25 percent times the number of acres actually hayed or grazed times the per acre annual Other restrictions and limitations also apply.

CRP participants who do not own or lease livestock may rent or lease the haying and grazing privilege to an eligible livestock producer located in an approved county.

"In light of recent weather patterns, it is imperative that USDA offer the Emergency CRP having and grazing program to Texas producer. Availability of forage is literally a matter of survival in the unpredictable and often unforgiving agriculture industry," said Martin.

CRP offers annual rental payments and cost-share assistance to establish long-term, resource-conserving cover on eligible land. USDA will monitor producers to ensure the land is haved or grazed without damaging conservation





### **Fires in Texas**

After the fires have finally, hopefully, been put out in our area here, about a total of 35,000 acres and over 250 homes and businesses have been left in ashes. The tales of those who fought the fires and of those who were in the direct paths of the fires have been horrifying tales. Many told of walls of fire 50 feet high that would literally hit trees and knock them over by the force of the winds created by the fire itself. Not to mention the natural winds whipping at 60 mph which added to the force behind the flames. It was devastation everywhere you looked. Sadie and I got in the car a couple of days ago and drove the roads through the country around here and what we saw was enough to sicken you. We saw where the pastures of grass and of woods were burned to ashes. We saw where huge trees had just been blown over by the force of the flames hitting them. We saw dead cattle that couldn't escape. We saw the devastation of homes that were simply obliterated from exist-I've not learned who the preacher will be on Sunday, January 29, but there ence. We traveled in about a 150 mile circle and what we saw was like looking at a Sci-Fi movie of the after-effects of a nuclear war. No, it wasn't quite that bad, but that's what came to mind as we drove through places still burning and smoke so thick it was choking even inside the closed car. We saw as people were just standing in a fixed state of shock, sitting on the ground crying and some scratching through the ashes of their once lively home. Most were just there... no emotion, no reaction. Just there. As we stood alongside my nephew and his precious wife, Michael and Susie Hampton, it was unbelieveable what we were witnessing. They told the story of how the DPS officer had come and told them to get out of their home, and to go right then, not to wait. They had no sense of time in the state of panic that had hit the entire region. All they could do was grab a few small items and get in the car and leave everything they had worked so hard for behind them. As they drove away from their beautiful home in Kokomo, Texas, they didn't know if they'd ever see it again. All their hopes, their dreams, their treasures were in that home. And, like so many, many others throughout the state, they lost it all in a single flash of wind, fire and incineration. Many had insurance, many didn't. Fire is no respector of persons, places or things and is a raging destroyer of all that sits in it's path. So many lives have been forever changed because of one tiny spark somewhere that took on a life of

> Yet, in the aftermath of all this devastation, there is hope. Hope for a new beginning, a new life. Knowing the feelings of helplessness due to fire, I can understand not knowing which direction to turn, where to go or how to get there. And seeing the looks on the faces of those who lost everything they owned, it's hard to visualize in the natural mind how anything good could ever be born of such tragedy. Yet, as we somehow turn our affections and emotions, along with our anger and hurt, to Christ, hope is born out of the ashes. Standing in front of Michael and Susie's burned home, it was difficult to even form words that would be anything close to comforting. What can you say at a time such as this? What can you do that would change their hearts right at that moment? How can you comfort them? It's really hard to understand the purpose behind such sorrow, yet, the peace of God will sustain and bring them to a place of solitude in Him. There is no understanding why or how this could happen. But, there is hope for a new beginning. They are alive. Their children are alive and safe. There is hope.

> All those men and women who have been so diligent in battling the fires deserve so much more than just a handshake and a "thank you". But, all those I know who stayed on those trucks and in those pastures and around those homes, fighting night and day, at times so exausted they could barely move a muscle, yet somehow found the strength and courage to take another step, drive another mile, fight one more fire, THOSE are the ones who deserve a standing ovation. However, all those I know simply put their lives on hold and went without a word of pleading, without being asked, without once thinking of the dangers, just knowing that devastation was wreaking havoc on their neighbors and friends lives, and they went. Our volunteer fire department in Rising Star went literally night and day without end until the fires were put out. These are the hero's. And, knowing these men and women, I know each of them would simply nod their heads in humble and

WASHINGTON - The head of the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) announced today that federal disaster aid has been made available for Texas to supplement state and local recovery efforts in the area struck by an extreme wildfire threat beginning on December 1, 2005, and continuing.

## **Neugebauer Announces Lifting Of Haying and Grazing Restrictions**

Washington, DC- Congressman Randy Neugebauer announced Friday that federal having and grazing restrictions for Texas have been lifted in response to recent drought conditions throughout much of the state.

"I commend USDA for taking this action," Neugebauer said. "Easing having and grazing restrictions during this emergency is the smart move to make as it will help ranchers feed their cattle and will help prevent further wildfires in the region."

This news out of U.S. Department of Agriculture (USDA) extends the primary "nesting" period through May 1 for haying and June 1 for grazing on land enrolled in the Conservation Reserve Program (CRP). Neugebauer had been working with the USDA to have these restrictions lifted since the onset of the wildfires in December.

Ranchers will need to meet certain environmental and conservation requirements to take advantage of this extension and should contact their local Farm Service Agency office for further details.





## **Texas Tax Reform Commission To Hold Hearings In Laredo, Weslaco**

AUSTIN - The Texas Tax Reform Commission will meet Thursday, Jan. 26, in Laredo and Friday, Jan. 27, in Weslaco to gather recommendations on how to reform the state tax structure.

The hearings are part of a series of public hearings the commission will hold across the state to gather input from Texans on how to modernize the tax structure and reduce property taxes. The public is invited to participate.

The 24-member, bi-partisan commission was created by Gov. Rick Perry in September 2005. It is chaired by former Texas comptroller John Sharp. Since then, the Texas Supreme Court has ruled the state's current school property tax structure unconstitutional and has given lawmakers until June 1 to devise a different tax system and lower school property

The governor has outlined five key principles to guide the commission's deliberations on tax reforms. Perry said our new tax structure must be fair, broad-based, modern, understandable to taxpayers and competitive with other states "so that Texas can continue to attract jobs by maintaining the best business climate in America."

#### **Judge Alito Impresses at Senate Hearings**

Last week, the Senate began to consider whether or not Judge Samuel Alito, President Bush's nominee to replace Justice Sandra Day O'Connor on the U.S. Supreme Court, is worthy of sitting on the nation's highest court. I think JudgeAlito did a great job last week. He had to endure hours and hours of probing questions. In the end, what the American public saw was a smart man who understands the U.S. Constitution and the proper role of the federal courts. I was especially glad to hear that he thinks America's Founding Fathers would be shocked to hear that some judges and justices are basing their reasoning on foreign laws instead of relying on the text in our own Constitution.

News reports indicate that the Democrats on the Judiciary Committee have requested to delay the preliminary vote on Judge Alito's nomination until January 24. Once that vote takes place, the full Senate will consider the nomination. As long as the Democrats don't use any more delay tactics - such as the filibuster - the Senate vote should occur before the end of this month.

#### **Medicare Prescription Drug Benefit Goes Into Effect**

On January 23, I will hold my final Medicare Workshop in the district. This event will take place in Hereford at the Deaf Smith County Library from 10:00 a.m. to 4:00 p.m. Similar to previous workshops I have hosted, Medicare experts will be on hand to help answer questions regarding the new Medicare Prescription Drug Benefit that went into effect on January 1 of this year.

About 24 million seniors have already signed up for this new benefit and pharmacists have already filled 6 million prescriptions under the program, according to the Department of Health and Human Services (HHS). There have been a few stories in the media reporting that the program has experienced some problems in its early days. HHS has increased toll-free pharmacy support phone lines, increased coordination with state governments, and taken other steps to respond to these early glitches. If beneficiaries are in need of assistance, they should call 1-800-MEDICARE. Although some who are trying to sign up for the benefit may encounter frustrations, I encourage everyone to remain patient and learn as much about this benefit so that a well-informed decision can be made.
