New Districts for 2006-2008 Present Executive Director **A Challenge for Gorman Teams**

Every two years the UIL realigns all the districts in the state of Texas for athletics and UIL academics. The UIL first sets the cut-off numbers for each classification and aligns the football and basketball districts, which it did back in February. Then they work to form the districts for volleyball, baseball, softball, and spring sports/uil academics (this includes track, cross country, golf, tennis, uil academics, OAP). This realignment saw the cut-off for class 1A rise to 194 and under from 189 and under. To compare, in 1976 when Gorman won the state title in class B the cut-off ranged from 124 and under. In addition, as early as 2000-2002 the numpers were 169 and below, if that were now DeLeon and Tolar would not be in our football district. If we were under the 1976 numbers, only Perrin and Cross Plains would be in our district. It is interesting how times have changed and populations have caused the numbers to change over the years. Small schools have lost numbers, but one of the biggest changes that effects realignment every year is the addition of new schools (usually AAAA or AAAAA schools). 



He was preceded by one sister, Othell George.







Last week began with our regularly scheduled school board meeting. The meeting convened at 6:00pm and the board passed the regular consent agenda after making some minor corrections to the minutes of the last meeting. All in all, the elementary has been very busy. 



Nationwide ACT Test

The next nationwide ACT test date for college-bound high school students is Saturday, June 10, 2006. Students must register online or have their paper registrations postmarked by the end of the day May 5. Late registration postmark deadline is May 19 (an additional \$18 fee is required for late registration after May 5).

The June test date is a popular one for juniors. Around two-thirds of testtakers in June have just completed the eleventh grade. Many of them take the ACT, check their scores and then decide whether to re-test in the fall or winter of their senior year. By looking at their scores during the summer, students can study to boost academic weaknesses before taking the test again as seniors. ACT allows students to report only the scores that they want to colleges. Students can choose not to automatically report their scores when they register for the test.

The ACT includes an optional Writing Test. Most colleges do not p quire a writing score, so studen should check the admissions requirements of colleges they're considering before registering for the ACT. The cost is \$29 without and \$43 with the Writing Test.

Students can receive registration information from their high school guidance counselors or they can register online at www.actstudent.org. The website also features test tips, practice tests, an online test prep program, and a database for students to find out if a prospective college requires a writing score.

ACT scores are accepted by virtually all colleges and universities in the nation, including all Ivy League schools. The ACT is an academic achievement exam that includes four tests; English, reading, math, and science. Students who opt to take the Writing Test will add 30 minutes to the normal 3-hour testing time.



Small businesses in the following primary and neighboring counties may apply for working capital loans to offset economic losses that are attribute to the impact of the following weather conditions and incident dates in each county.

EIDL - 10376 - Primary Counties - Austin, Cass, Eastland and Palo Pinto; Contiguous Counties - Bowie, Brown, Callahan, Colorado, Comanche, Erath, Fayette, Fort Bend, Hood, Jack, Marion, Morris, Parker, Shackelford, Stephens, Waller, Washington, Wharton and Young -Drought from 4/1/05 to deadline 9/25/06. EIDL - 10415 - Primary Counties - Palo Pinto; Contiguous Counties - Eastland, Erath, Hood, Jack, Parker, Stephens and Young - High Winds and Wildfire - from 01/01/06 to deadline 10/13/06.

Small businesses may qualify for Economic Injury Disaster Loans (EIDLs) up to \$1.5 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred. "Eligibility for these loans is based on the financial impact of the disaster only and not on any actual property damage. These loans have an interest rate of 4%, a maximum term of 30 years, and are restricted to small businesses without the financial ability to offset the adverse impact without hardship," Judd said.

By law, SBA makes EIDLs available when the U.S. Secretary of Agriculture designates an agricultural disaster. Secretary Mike Johanns declared these disasters at the request of Governor Rick Perry.

AGRICULTURAL VIEWPOINT

The Texas Animal Health Commission (TAHC) will not address proposed regulations for premises registration at the upcoming May 4th TAHC commission meeting in Austin. Dr. Bob Hillman, Texas' state veterinarian and TAHC executive director, said the proposed premises registration regulations have been placed on "hold", and will not be considered by commissioners until the winter or spring of 2007.

Dr. Hillman said the TAHC will continue to promote voluntary, free registration of sites (premises) where livestock and fowl are held, handled, or managed. As of April 4th, more than 10,000 premises have been registered in Texas; more than 213,000 have been registered nationally. System registration is the foundation of the National Animal Identification System (NAIS), which, when fully implemented, would enable animal health officials to trace the movement of diseased or exposed livestock or poultry within 48 hours.

Information and agendas for Commission meetings will be posted on the TAHC website, filed in the Texas Register and announced through news releases. Comanche Co. Historical Commission To Hold Meeting



Tax Day Recap

With tax season coming to a close, I thought it would be a good opportunity to take a look back at recent tax relief measures and the effect they are having on the U.S. economy. What I found from studies done by the U.S. Department of the Treasury paints an interesting picture.

In May of 2003, President Bush signed the Jobs and Growth Act into law, which reduced the tax burden on American taxpayers. Lower taxes have meant real savings for millions of workers. This year alone, 5 million individuals and families will see their income tax liability completely eliminated; 44 million families with children will receive an average tax cut of \$2,495; 14 million elderly individuals will save an average of \$2,043. Small businesses will benefit as well: 25 million small business owners will see their tax burden decline by an average of \$3,641.

These tax savings are translating into positive news for the job market. In the three years since the tax relief went into effect, business investment has increased, the number of jobs have grown, and the unemployment rate has dropped. The U.S. economy is experiencing 31 consecutive months of job growth, which has resulted in the creation of more than 5.1 million new jobs (including 2.1 million in the past 12 months alone). Reports show that this growth is occurring in multiple sectors of the economy, including health, educational, business, and financial services. At the same time, the country's unemployment rate is historically-low at 4.7 percent.

Federal tax revenues have also gone up. Despite the misleading rhetoric that tax relief is adding to the deficit, quite the opposite is true. Since 2003, when the latest round of tax relief was passed, tax revenues have increased each year. This includes revenues increasing by 14% in 2005. More needs to be done to reduce the deficit - such as reining in spendi but raising taxes isn't the answer. To keep the economy humming along, we need to continue smart tax policies that allow small businesses and working families to keep more of their hard-earned money.

Apply For Assistance Even If You Have Insurance

AUSTIN, Texas - Individuals with insurance who were affected by the Texas Wildfires are urged by the Federal Emergency Management Agency (FEMA) and the Texas Governor's Division of Emergency Management to apply for assistance. Insured individuals may be eligible for several types of disaster assistance.

"We want everyone affected and eligible for assistance to receive help as quickly as possible," said Deputy Federal Coordinating Officer, Dick Harmon, FEMA's top official for Texas Wildfires recovery operations. "By law, we cannot duplicate what insurance already covers. However, in some cases, we may be able to help, up to our program limits."

Disaster assistance may include grants to help pay for temporary housing; uninsurable items and other serious disaster-related needs; and lowinterest disaster loans from the U.S. Small Business Administration (SBA) for homeowners and renters as well as business owners.

"Call to register with FEMA now," said State Coordinating Officer Duke Mazurek of the Texas Governor's Division of Emergency Management. "Then call after receiving your insurance settlement and update your information."

The Jan. 11 presidential declaration made individual assistance available to affected individuals and businesses in the counties of Anderson, Bastrop, Caldwell, Callahan, Cooke, Deaf Smith, Eastland, Erath, Gray, Guadalupe, Hood, Hutchinson, Montague, Palo Pinto, Parker, Roberts, Tarrant, Wheeler and Wise.

To register, call 1-800-621-FEMA (3362) or TTY at 1-800-462-7585 for the speech- or hearing-impaired. FEMA cannot duplicate what insurance already covers nor pay deductibles.

Examples of what FEMA may cover for insured victims include: expenses for renting a hotel room while a home is inaccessible or uninhabitable, if insurance does not cover that cost, and items that are uninsurable, such as wells or septic tanks, or the costs of obtaining access to one's home.

People who have insurance and have registered for assistance may receive a letter from FEMA telling them they are not eligible at this time because they are insured. People who get a letter denying assistance because of insurance should consider calling FEMA again at 1-800-621-FEMA (3362) after their insurance claim is settled. If you are not satisfied with FEMA's decision on your application, an appeal can be filed in writing to FEMA Appeals Officer, National Processing Service Center, P.O. Box 10055, Hyattsville, Md., 20782.
