Train Will Run From Dublin To De Leon To Gorman



Eastland County - New Laws On Sale Of Cold Remedies

On Monday, August 1, 2005, a law goes into effect in Texas that limits over-the-counter sales of pseudoephedrine. Pseudoephedrine is a common ingredient found in cold remedies that can be used to make methamphetamine, e.g. Sudafed.

The legislation limits access to over-the-counter sales of tablet forms of pseudoephedrine products, which must be kept behind a pharmacy counter or in a locked case within 30 feet and in direct line of sight of the sales clerk. Sales are limited to two packages or six grams. Purchasers must display a driver's license or other picture identification, and stores are required to keep a record of the customer's name, date of birth, date of purchase and the pseudoephedrine product purchased; these records must be kept for two years and may be viewed by state and local law enforcement agencies.

It also requires pharmaceutical wholesalers to record and report sales of pseudoephedrine and requires them to notify the Texas Department of Public Safety about transactions involving suspicious quantities of pseudoephedrine tablets.

Criminal District Attorney Russ Thomason stated "The primary goal of this new law is to place some reasonable limits on the accessibility of pseudoephedrine tablets being used to cook methamphetamine. These dangerous, delusional and paranoid meth cooks must be told that they cannot obtain enough pseudoephedrine to cook this drug. This law puts a very lage dent in this terrible problem that has swept through our county, Texas and the nation. Although some consumers, the pharmaceutical industry and retailers will experience some inconvenience, it is minor in comparison to the insidious damage that methamphetamine causes to our communities, families, and most especially our children."

Eastland County Sheriff Wayne Bradford also stressed the importance of the new law stating, "We, as a society, must get serious about eradicating methamphetamine and the toll it continues to take in our homes, in our schools, and in places of work. It continues to play a





A Word in Season

A TALE OF TWO BOYS, Part One

Last week I identified what I feel is the single greatest contributor to interpersonal conflict and emotional pain in our lives: judging the motives of others. I call this "attaching significance" to the observable actions of others. The more significance that you attach to an action or event, the more power you give it to frame your overall view about yourself, about God, about the world around you, and about life in general. And we all tend to do this. If you haven't realized this about yourself, you may be living in denial.

This principle explains how one event or series of events in one's past can end up defining the remainder of a person's life. Many of us live with unresolved resentment and anger in our hearts. We may have learned to cope with it, but it's still down in there and sometimes creeps (or leaps) out at unexpected times. Many times we think that the resentment we feel is largely attributable to the actions of someone in the past. While it is true that people hurt people, it is very important to realize that it is seldom the past events themselves that make us feel the way we do today. We tend to remember how an event made us feel rather than exactly what happened. And how we feel about a past event is largely a creation of our own making.

Let me illustrate. Let's say there are two boys, each from different backgrounds and home situations. Both of them grow up with absentee dads. Their dads never attended their school activities or ball games. They didn't go to church with them or take them fishing or camping. That's the observable events, the plain facts of the matter. But let's say the reason for each of these dads being absent is very different.

The first dad is absent because he's an angry, abusive, workaholic. The other dad is absent because he's an officer in U.S. Marines serving in Iraq. It is probable that the second boy will not incur the same emotional pain or baggage. Because he is less likely to attach "negative" significance to his dad's actions. He may see his dad as a brave man putting his life on the line for his own family and his country. But the first boy would be greatly tempted to turn his dad's poor lifestyle decisions into a statement of his own personal worth: "Dad was never there for me because he didn't think I was as important as his work or his drinking buddies." 

Congress Must Consider The Rule of Law As It Reviews Nominees For The Supreme Court

Whenever I have visited an emerging democracy, I have noticed consistency on two points: first, everybody easily understands the need for democratic voting and free speech; second, they have a much harder time understanding the rule of law, which is just as essential for a democracy to func-

I once met with members of the Russian Duma and emphasized how eager Americans were for Russia's fledgling democracy to succeed. One mem-

ber replied, "No you don't. Americans are not investing here." I replied that for American companies to invest, there has to be an independent judiciary and respect for the rule of law, so the state cannot easily confiscate private property. This was extremely difficult for the Russian par-

liamentarians to understand. We have grown up in the United States in a society of laws, not of men. We take that concept for granted. In most emerging democracies, the rule of law is an alien idea, almost incomprehensible. But if you want democracy to succeed, it must harness the two concepts of individual rights and majority rule - and it can do this only through respect for the rule of law.

The rule of law involves four basic requirements: Equality under the law; a respect for individual rights; an independent and honest judiciary; and transparent court proceedings.

This concept was built into our Constitution which established the judiciary as a co-equal branch with the legislative and the executive. Because of this, the Supreme Court can strike down laws through "judicial review" if it decides the law violates our supreme law, the Constitution.

Judicial review provides courts with a great deal of power which some people believe has been abused. Some believe the courts have taken judicial review so far that some judges are legislating from the bench rather than interpreting and implementing the laws passed by elected representatives. If the public begins to view the courts simply as a different avenue for partisan political contests, instead of a fair arbitrator of legal questions, their faith in the impartial rule of law will erode.

This would be an unhealthy development. Many times in our history, court rulings have been unpopular, but the general respect accorded to the

law allowed the public to accept its decisions. The importance of the courts explains why we must take the replacement of retiring Justice Sandra Day O'Connor very seriously. The Senate has a responsibility to examine the president's nominees closely to determine whether they are qualified by experience, knowledge and temperament to sit

on the high court. The Constitution says Congress should ascertain whether the nominee is qualified and fair, not fight to make sure he or she has a certain set of approved views on a laundry list of hot-button political issues. If this process is perceived by people as a partisan contest, it will only serve to diminish the respect the people have for the justice the court is expected to deliver. This could further erode the respect for the rule of law which buttresses our gov-

ernment and legal system. This concept is so important to the stable functioning of representative government that I joined with the Southern Methodist University Dedman School of Law to establish a Rule of Law program to bring jurists and officials from developing countries to the United States. The hope of all who participate in this program is that our foreign guests will build their understanding of the rule of law, and help this vital principle take root in their countries and foster the growth of strong and stable democracies around the world.


