



Disaster Declaration and Executive Order

On this the 30th day of December, 2005, I, Brad Stephenson, Eastland County Judge do hereby declare a local state of disaster for Eastland County, Texas as prescribed by Chapter 418.108 of the Local Government Code.

As such, it is hereby the executive order that the use of all outdoor combustibles, including all fireworks in East land County is banned immediately.

This order bans the use of ANY combustible materials in an outdoor environment, including but not limited to fireworks, materials used in activities such as welding or any other activity that could result in fire.

In accordance with section 352.081 of the Local Government Code, a person who knowingly or intentionally violates this order commits a Class C Misdemeanor, punishable by a fine of up to \$500.00.

Declared and Ordered this 30th Day of December, 2005.


The start of the New Year 2006 came out with a bang when the local area was struck with a large fire which destroyed thirty-five structures in Eastland County. The fire consumed the Kokomo Baptist Church, Kokomo Community Center and several more homes in Kokomo, New Hope and Carbon areas. The fire cosumed an estimated 35,000 acres.

Fourteen type I National Guard helicopters were attempting to control the fire that started near Rising Star and Carbon, along with ground units from many area fire departments.

Two firemen were taken to Eastland Memorial Hospital with non-life threatening injuries.

The Texas Forestry Service is reporting the *Rising Star-Carbon* Fire is now 95% contained as of 8:30 p.m. Monday night. There were two smaller fires near Carbon that have been reported and a separate from the original fire.

William Agatha Nance


William Agatha Nance, age 90 of Desdemona, passed away Monday, January 2, 2006 at Harris Methodist Hospital in Stephenville.





USDA Rural Development Conducts Comanche Co. Outreach Day

COMANCHE, TEXAS, January 3, 2006 – USDA Rural Development representatives will be in Comanche on Thursday, January 5, 2006 at the Comanche Electric Co-op Conference Room, 201 West Wright, from 9 a.m. to 11 a.m. to assist people interested in home ownership loans and home repair loans. Customers will be assisted on a first comefirst served basis.

There are several programs available to provide assistance to verylow and moderate-income applicants. Loans are available depending on repayment ability, acceptable credit and the location of the home or building site.

The direct home ownership loan is designed to provide very-low and low-income applicants with financing to build, purchase, or repair homes to provide adequate affordable housing. Funds may also be used to modernize or repair a home already owned by an applicant. For moderate-income applicants, mortgage loans are available through the Guaranteed Rural Housing Program. Moderate income limits vary by the number of persons in a household, but for a family of four the limit is \$66,150.

Two significant advantages of the direct loan program are that no down payment is required, and there is no requirement for mortgage insurance. Loans may be made for up to 100% of the appraised market value, which may allow the closing costs to be included. The loan term is typically 33 years. The interest rate is fixed and is currently 6.375%. Payment assistance is available, based on family size and income, which may reduce the monthly interest payment to as low as one percent (1%).

USDA Rural Development loans and grants are limited to rural towns or rural areas. In this part of west Texas, the only areas not eligible would be within the Abilene metropolitan statistical area, including Tye and around Lake Fort Phantom.

Home repair loans and grants are also available for very-low income homeowners. Grant funds are only available to homeowners 62 and over who cannot repay a loan. Grant funds are used to remove health and safety hazards such as repairing roofs, heating, electrical, plumbing, water and waste disposal, handicapped accessibility, etc. Loan funds may be used to repair or modernize a home.

The loan amount cannot exceed \$20,000 and grant assistance may not exceed \$7500. Loans under this program are made with a 1% interest rate and have a maximum term of 20 years.

All applicants must meet basic eligibility requirements such as being unable to obtain a loan from other conventional lending sources on terms they can afford; being without ownership of decent, safe and sanitary housing; have sufficient and dependable income for loan repayment, taxes, insurance, living expenses and other existing debts; possess the legal capacity to incur debt; and have an acceptable credit history. Other criteria must be met depending on the type of program.







Our hearts and prayers go out to all those who suffered loss in the fires on New Year's Day. And we owe a huge thanks to all those who fought (and are fighting) the fires and served our community during this great crisis.

Some folks are amazed that their homes were spared. Others are wondering how they will overcome the loss of all their personal possessions. Walking around the smoldering remains of one of the homes in our community, the owners and I observed several pieces of pottery in the midst of the ashes. It seemed they were untouched and untroubled by the flames. I was a bit amazed, but then thought, "These pieces faced previous fires and thus were prepared for this one."

Suddenly I caught a glimpse of how God can bring good out of disaster. Those who pass through the fire now become immune to its power later! In the same way that pottery is "fired" to bring it to its mature state, even so, the tests we now face can bring us to more mature faith and character. Fire brings out the best and worst in the things it burns. It reveals what we are made of. Will we use the tragedy as an excuse to curse God and become hard and resentful?
