"Seed Money" Planted By American State To Help Firefighers In Stricken Areas

American State Bank, which led a drive one year ago to aid disaster victims halfway around the world, is now moving to help stricken communities here at home.

Wildfires---generated by high winds, high temperatures, and drought conditions---have charred thousands of acres in Texas, with the loss of hundreds of structures and at least three lives. As the flames continue to burn, ASB is planting "seed money" to support the volunteer fire departments in six key communities.

Checks for \$1,000 each will go to those departments in Cisco, Early, Comanche, Gorman, Cross Plains, De Leon and Carbon.

ASB hopes the checks will be just a start toward meeting the region's needs. The bank encourages individuals and organizations to help in any way they

can. Contributions may be made at any branch of American State Bank.

Additional Emergency Assistance for Local Citizens

Churches of Christ Disaster Relief Effort, Inc., of Mashville, Tennessee Provides Much Needed Support for Eastland County Wildfire Victims



Disaster Relief for the victims of those affected by recent wildfires may be found at the Gorman Church of Christ Fellowship Hall, 419 N. Kent in Gorman. On Saturday January 7, a transport load of disaster supplies and materials were furnished and sent by the Churches of Christ Disaster Relief Effort, Inc. of Nashville, Tennessee.

All those affected in any way by the fire are urged to come to the hall to receive disaster supplies. All items are new, boxed and labeled. The basic item distributed is a family food and supply box that contains staple items which can sustain a family of four for five days. Those who need supplies are urged to take as many as they need. If they have no room to store them, you may return as often as necessary, or store them in a friends house if necessary. These supplies are sorted by function: i.e., food, bedroom, men's , women's and children's clothes, baby materials of all kinds, toys, cleaning supplies and daily needs.

It has been said in a national newspaper "when this organization's semi arrives into a church parking lot, those that don't know already will soon learn that competent, dependable help has arrived." The people in Gorman found this to be true last Saturday. During its 14 year history, the Nashville based, church supported relief agency has become a welcome and well received fixture at the site of fires, floods, tornadoes and other disasters nationwide. This agency distributed nearly \$11 million dollars of aid in calendar year 2005 and played a major role in the Gulf Coast and Katrina relief

Coordinating relief efforts here is Gene Foster, an elder of the local Church of Christ. When news of the fire went nationwide, Louise Scitern Tinkler of Abilene and native of Gorman, was contacted by friends Kirby and Nell Ball of Thomasville, North Carolina who are supporters of the organization. Immediate response was then given to Gene Foster when he called Nashville to make arrangements for relief for wildfire victims in this area. Since the Churches of Christ are nondenominational, local congregations in and around Tennessee furnish and obtain the supplies and distribution is made through local congregations where disasters occur. This Disaster Relief nonprofit corporation was started in 1989 with the advent of Hurricane Hugo. The ministry was started by two local elders in Nashville and has grown to a nationwide and international operation.



Many thanks to members of the congregation and community for the huge job of off loading the supplies last Saturday. Special thanks to Mr. Shawn Boles and the students of Gorman Schools, to De Leon Church of Christ representatives Jonathan Gilbert and Tresa Gilbert; to Reyes Hernandez, Adelia Martinez and Alfredo Escobar for their valuable help. All churches in Gorman are involved in relief efforts of many kinds and many thanks are extended to representatives of other churches and congregations in town for coming by so relief efforts can be coordinated.

Please help to spread the word that this help is available. Even if your home was not completely destroyed, if you are affected by the fires, please come and get the relief that is here for you. It will help to have this basic help so you can reallocate your resources to make a comeback from this disaster. Friends are urged to come by and pick up supplies for those who are in the process spending their days trying to get their lives back together. The hall will be open all day and numbers are posted on the door if you need to come after hours. Do not hesitate to call day or night!

Proclamation Issued To Protect County Citizens and Property

Eastland County has been ravaged by fire, fueled by high winds and low humidity. The Proclamation was put in place for the protection of the citizens and their property in Eastland County. It was not intended to take away a person's livelihood. Welding will be permitted if the proper precautions are taken.

- 1. The individual welding must have a spotter.
- 2. Two wet extinguishers must be available.
- 3. Must have sufficient supply of water on hand at all times.
- 4. Must have water sprayer available for use. Must wet down sufficient area (and rewet as often as necessary).
- 6. By February 1, 2006, a permit will be required in addition to the above. Details will be forthcoming when the permitting system is in place.

The safety precautions must be taken and also, please use common sense and good judgement if the conditions are windy. If the job is not an emergency, put it off until a later date.

We are in a disaster situation, violators may be charged with a Class C Misdemeanor, with a maximum fine of \$500. An individual, or individuals, could be liable for damages, if fire occurs. If there is a fatality, one could face possible felony charges.

Responding to Grass Fires

Instead of remembering Christmas 2005 as a time spent with family celebrating their faith, many residents in the 19th District will only remember this holiday season for the devastating grass fires that raged through the region, destroyed homes, and, in some cases, took the lives of their neighbors.

Last Wednesday, I traveled to Cross Plains to get a first-hand look at some of the damage caused by the fires. I also had the opportunity to speak with residents who were affected by the fires. From what I learned on my tourit is clear that the costs of these fires will prove to be immeasurable for many Texans. I am encouraged, howeverby the initial responses by the state government and the local communities who have rallied to help those in need.

Governor Perry has also visited the area. In addition to the emergency declared by the state government, he has also requested a federal emergency declaration for Texas. This would mean additional resources would be available to combat the fires, respond to this disaster, and help families and businesses affected by this emergency. To help this process move along as quickly as possible, I have sent a letter to President Bush supporting Governor Perry's request. In a show offexas unity, 14 other members of our state's congressional delegation signed on to the letter as well.

These post-Christmas fires are not isolated incidents. High winds and a severe drought have created conditions that caused 1,946 fires which consumed 112,319 acres in 2005. And it is a real possibility that more fires could be in store for our area as these conditions persist into 2006. With that in mind, I will continue to work with Governor Perry and my colleagues in Congress to get needed relief to the devastated regions. I also encourage everyone to do what you can to fire-proof your homes. Additionally, this is a good opportunity to take another look at your emergency response plans so that your families know exactly what to do in case of a fire.

When rough times have fallen upon our state in the past, Texans have always come to the aid of their neighbors. The compassionate response to the fires has proven that this community spirit is alive and well, and, once again, we will make it through together.

Among the bills that received final approval from Congress in the hours before it adjourned for the year was legislation to authorize continued funding for NASA. It was the first time in five years Congress has spoken so emphatically in support of the vision for the next generation of space exploration and research, including affirmation of the goal to put a permanent base on the moon.

The authorization bill provides a policy blueprint for NASA. I believe it is significant that an overwhelming number of my colleagues in the House of Representatives and the Senate recognized that the pathways of exploration and discovery outlined in the legislation merited their endorsement.

By supporting the bill, Congress has placed a stamp of approval on completion of the International Space Station and on moving forward with the transition to a new generation of crew exploration vehicles. In addition, NASA now has Congressional guidance on its activities related to research, science, education and aeronautics.

But perhaps most important, passage of the legislation -- and the implicit support for the science and engineering expertise contained within it -- may be seen as evidence of Congress' determination to address one of the most important challenges looming in front of our

America's preeminence since World War II has rested upon the bedrock of its economic dominance. Our economy, in turn, has depended upon a continued flow of technological and scientific advances for its strength. Increasingly, the edge that we have enjoyed in such a crucial area is being challenged by other nations. If we do not meet this challenge, not only will NASA's leadership be at risk, but so will America's.

Thankfully, leaders from our political, business, scientific and academic communities are beginning to tackle this problem. The National Academy of Sciences, the National Academy of Engineering, and the Institute of Medicine, have created the "Committee on Prospering in the Global Economy of the 21st Century." The committee is expected to soon release the final version of its study "Rising Above the Gathering Storm."

The committee cites a number of what it terms "worrisome indicators" that point to the decline in educational emphasis on science and mathematics. For example, in 2004, China graduated about 500,000 engineers and India 200,000. Here at home, we had only 70,000 such graduates.

U.S. 12th graders have performed below the international average of 21 countries on a test designed to measure general knowledge in mathematics and science. In 2007, for the first time, the most advanced high-energy particle accelerator will not be in the United States. In a prepublication summary, the committee notes that it is "...deep(ly) concerned that the scientific and technical building blocks of our economic leadership are eroding at a time when many other nations are gathering strength." The committee urges our nation to "... prepare with great urgency to preserve its strategic and economic security."

My colleagues and I are ready to act on a number of the recommendations made by the committee. This issue is not political; it is not partisan. There is already emerging in Congress a willingness to embark on a serious effort to ensure that America maintains creative leadership in the world.

We will make an effort to recruit annually 10,000 science and math teachers in middle and high school, offering four year college scholarships as an incentive. New training and education programs will be developed to strengthen the skills of current teachers and additional federal resources will be allocated for research activities in the hard sciences.

I will continue to write about this important initiative as the year progresses. Few policy debates will be more important to our country's security and our children's future. As Chairman of the Space and Science Subcommittee in the Senate, I intend to push for America's leadership and superiority to continue through this century.

I knew there were a lot of good people here but I had no idea to what extent. I am so proud to be part of a community that cares so much about each other and will go to ANY extreme to help out a neighbor. And to Gene and his crew, you have no idea how valuable you are to this community; not only as firemen, but as friends. For all of you who played a part in helping all of us deal with this crisis, I wanted to say thanks. I say this knowing that a mere thank you will never be enough!!

Fire Danger and Civil **Emergency Messges**

With the warm, dry, and occasionally windy pattern continuing over north Texas, we will see several episodes of increased/ critical fire danger over the next week. The first system to affect us will move across late Saturday and Sunday. As with the past several systems, it will pass to our north. Primary impacts, again, will be increased southwesterly winds (sustained around 20 mph with higher gusts), relative humidities from the low 20s over our eastern counties to the lower teens out west, and high temperatures in the upper 70s to lower 80s.

Looking further into the future, a system will move across on Tuesday, but the strongest winds should occur after the front passes. A more powerful system moves across the plains during the day on Thursday and Friday. Winds could be quite strong with this late-week system, but fortunately, humidity values may be a little higher than over this weekend.

With the continued possibility of fires threatening lives and property, today we have instituted a system to use our Civil Emergency Messages (CEM) to help notify people when evacuation orders are issued. The CEMs will be issued at the request and discretion of Emergency Managers, Mayors, County Judges, or their designees. The CEM is the same product we use to broadcast Amber Alert messages, or information concerning major hazardous materials events. Most importantly, the CEM will trigger the tone alarms on NOAA Weather/All Hazards Radio receivers, alerting people to the danger in their county.

The rapid movement of the fires last weekend emphasized the need for preparedness and fast action by those in harm's way (very similar to those in the path of a tornado). This also is a scenario in which the NOAA Weather/All Hazards Radio may play an important role. While we hope this capability is not needed, we will stand ready to assist if the threats and conditions materialize.

TEMPLE, Texas, January 10, 2006 — Bryan Daniel, USDA Rural Development State Director, announced today USDA Rural Development is accepting applications for the Value-Added Producer Grant Program. Funding in the amount of \$19.4 million is available to develop value-added agriculture business ventures which support President Bush's energy plan to develop alternative sources of renewable energy to support long term solutions to high energy costs in rural Texas.

The Value-Added Producer Grant Program provides competitive grant funds for one of the two following activities: (1) to support the planning activities needed to establish a viable value-added marketing opportunity for an agricultural product or (2) to acquire working capital to operate a value-added business venture that will allow producers to better compete in domestic and international markets.

"This grant will help agricultural producers become more profitable through value-added agricultural business opportunities," said Daniel. "In addition, priority consideration will be given to those grant applications that have at least 51% of project costs dedicated to activities for a bio-energy project."

Grants are available to independent producers, agricultural producer groups, farmer or rancher cooperatives, and majority-controlled producer-based business ventures. Eligible applicants applying under the renewable energy category must include biodiesel, ethanol or wind energy production, or the use of biomass to generate energy. The maximum award for the planning grant is \$100,000 and the maximum award for the working capital grant is \$300,000. Applications must be completed and submitted no later than March 31, 2006. BLESSED ARE THE PEACEMAKERS

"Blessed are the peacemakers, for they shall be called sons of God." (Matthew 5:9)

The authenticity of anyone's claim to be a child of God, someone who truly knows the Lord, is proven through a lifestyle of making peace with folks. Anyone can find fault and cause divisions. But few go out of their way to make peace and find solutions that unite offended parties.

The Bible is very clear about strife and contention: "Where there is jealousy and strife, there is confusion and every evil thing." (James 3:16) Jealousy and strife are the open door to "every evil thing." Fire Response and Recovery Efforts

The grass fires in Texas continue to be my primary focus. I mentioned last week that I had been to Cross Plains and sent a letter to President Bush urging him to declare an emergency in Texas. Since then, I have spoken with the head of the Federal Emergency Management Agency (FEMA) David Paulison to get his perspective on the response and recovery efforts. And I've traveled a second time to Cross Plains and to Carbon in Eastland County as well.

In my conversation with Director Paulison, I was reassured that FEMA understands the urgency of the situation in Texas. FEMA has already provided grants to Texas to pay for firefighting costs, and the agency is currently on the ground assessing the damage from the fires.

On my return trip to the region this week, I was encouraged by response of the local communities and how quickly they are moving forward. I was especially moved by the donations and contributions that have been made to help our fellow Texans in need. It never ceases to amaze me how Texans don't wait for things to happen, they go ahead and make things happen on their own. A perfect example of this generosity can be found in an Eastland County teenager who raised \$2,500 in a bake sale and donated it to local fire victims.

Although progress is undoubtedly being made, the recovery process is far from over. I will continue to work with local officials and the federal government to help the individuals and communities affected by the fires get back on their feet.

Good News for a Surging Economy

The economic numbers for 2005 are now in, and they tell a remarkable story. The addition of more than 400,000 jobs in November and December brought 2005's total job growth to more than 2 million jobs. Further good news out of the federal Bureau of Labor Statistics shows that shows that the current unemployment rate is 4.9 percent, lower than the average of the 1970s, 1980s, and 1990s. Another indication of a thriving economy is the strength of the stock market, which topped 11,000 for the first time since before the terrorist attacks of 9/11.

Since President Bush signed the Jobs and Growth Act into law in May of 2003, more than 4.6 million jobs have been created. Texas has reaped the benefits from our surging economy as well. Over that same time span, 317,000 jobs were added in our state, including 17,300 in November of 2005 alone.

The Department of the Treasury has compiled a graph that shows this 30 month-long surge in jobs. Since pictures can speak a thousand words, I encourage you to follow this link to Treasury's website to take a look at the job growth since May 2003.
