JULY 19, 2007

The Gorman City Commission met on the above date. Those present were Mayor Robert Ervin, and Commissioners Nathan Files, Don Underwood, and arriving late Joe Casey. Absent was Charlie Torrez. Others present were Emmett Lasater and Barbara Fenley.

Nathan led the opening prayer followed by the Pledge of Allegiance and the Texas Pledge.

Mayor Ervin called the meeting to order @ 5:34 p.m.

Don made the motion to approve the minutes as read. Nathan made the second. Motion carried.

Nathan made the motion to pay the bills. Don made a second. Motion carried.

Emmett Lasater, EDC director, gave a report to the Commission on behalf of the EDC. He also relayed to the Mayor and Commissioner that he was glad to be a part of the Gorman community.

Tacy reported that the Key Estate now officially belonged to the City. The quit claim deed had been filed.

Property cleanups were also discussed.

Don made the motion to retain Barbara Fenley as Police Chief and bump her salary to \$15.00/hr. Joe made the second. Motion carried 3-0.

There being no further business for discussion. Nathan made the motion to adjourn with a second from Joe. Time was 6:25 p.m.

Skaggs Reunion Set July 28



It is said that the late Bro. Frank Skaggs, when asked how many children he had, would reply, "I have five sons, and each of them has five sisters." And the descendants of Bro. Skaggs, his wife, Lizzie (Brown- ing), and those five sons and their many sisters will hold their 60th annual reunion from 10:00 a.m. to 3:00 p.m. Saturday, July 28, at the Reunion Center in De Leon, located at 640 E. Navarro Ave. (East Highway 6), next to the De Leon City Park.

The first of those Skaggs sons to come along was Virgil, and his sisters were Mae (Quinn), Cleo (Clements), Elsie (Robinett), Marie (White), and Bernice (Farley). After Virgil and the first two sisters were born, along came second son Vernon, and his five sisters were... well, the same five sisters. So, you guessed it, the remaining three sons—Archie, Lloyd, and Frankie Lee—shared those same five sisters, bringing the total number of children born to the union of Frank and Lizzie Skaggs between 1903 and 1925 to ten.

By the time the last child was born, the next generation was already under way, and it continued until the summer of 1952, when from late April to early September, the Skaggs family added six new members—all boys—three grandsons and three great-grandsons. But more generations kept coming, and the number of descendants growing, as the Skaggs family expanded from its native Rock Bluff community (where Bro. Frank pastored Rock Bluff Baptist Church for more than four decades) throughout Comanche and Eastland counties, up into the Texas Panhandle, and eastward to South Carolina.

Jerry Barton of Granbury still remembers the first Skaggs reunion he attended, held then at Lake Eanes near Comanche on the Fourth of July, less than a week after marrying into the family via wife Peggy White. "As we came into the park area, I said to Peggy, 'It looks like a lot of people are in the park for the holiday.' She said, 'No, this is just the family.' I told her I didn't realize the Skaggs family was that large. She said that, actually, it looked like maybe only half the family was there. Seems like there were somewhere around 90-plus names on the register that year."

One of the traditions which has remained the same throughout the lifetime of the reunion is the noontime meal of covered dishes, fresh produce, and desserts galore. Over the years, certain family members have garnered some fame within the family for their particular dishes.

"I remember," Jerry continues, "the first time I heard someone say, as they were going through the dinner line, 'We'd better get some of this chocolate pie; Marie [White] made it. If we don't get a piece now, it will be gone by the time we get back.' And they were right!"

The reunion's location and date have changed a bit over the years, as dictated by necessity or preference. The first, in 1947, was held at Lake Cisco.

De Leon's Frances Howard, chief Skaggs family genealogist and historian, whose younger sister, Ona Mae Odom, at two months of age, was the youngest attendee at that first reunion, recalls, "Aunt Marie said she thought the first reunion was at Cisco because Virgil's family [which lived in the Panhandle at the time] requested it to be there, so it wouldn't be so far for them to travel...I guess after that, they started having the reunion at Bass Lake [now Frank Gray Memorial Park, near Gorman]. 

Fresh Taste Of Summer Year Round

When you grow your own vegetables there will be times when you have too much to eat right away, so you basically have three choices; give it away, put it on compost heap, or find a means of storing it in good condition. Freezing sounds like the perfect solution, but it is not just a matter of sticking it in the freezer. So if you want your vegetables to taste and look as good halfway through the winter as they did when you picked them, you need to blanch. And it is worth learning how to do it properly, because sloppy blanching results in sloppy vegetables.

Blanching (scalding vegetables in boiling water or steam for a short time) is a must for almost all vegetables to be frozen. It stops enzyme actions which can cause loss of flavor, color and texture. Blanching cleanses the surface of dirt and organisms, brightens the color and helps retard loss of vitamins. It also wilts or softens vegetables and makes them easier to pack. Blanching time is crucial and varies with the vegetable and size. For home freezing, the most satisfactory way to heat all vegetables is in boiling water. Use a blancher which has a blanching basket and cover, of fit a wire basket into a large pot with a lid. Use one gallon water per pound of prepared vegetables. Put the vegetable in a blanching basket and lower into vigorously boiling water. Place a lid on the blancher. The water should return to boiling within 1 minute, or you are using too much vegetable for the amount of boiling water. Start counting blanching time as soon as the water returns to a boil. Keep heat high for the time given in the directions for the vegetable you are freezing. As soon as blanching is complete, vegetables should be cooled quickly and thoroughly to stop the cooking process. To cool, plunge the basket of vegetables immediately into a large quantity of cold water, 50 degrees F or below. Change water frequently or use cold running water or ice water. If ice is used, about one pound of ice for each pound of vegetable is needed. Cooling vegetables should take the same amount of time as Blanching. Drain vegetables thoroughly after cooling. Extra moisture can cause a loss of quality when vegetables are frozen.

AGRICULTURAL VIEWPOINT

DAMAGE TO PLANTS BY DISEASES AND INSECTS

Diseases and insects can cause a significant amount of damage to plants. In many cases it becomes necessary to use pesticides. Sometimes the cure can cause as much damage as the problem if label recommendations are not followed.

Pesticide damage to plants appears in a number of ways, but occurs most often as:

Burn - Appears on the tip or margins of the leaf as necrotic areas or the entire leaf surface may appear burned, or the roots can be burned.

Chlorosis - appears as curling, crinkling, or cupping of the leaf.

Stunting - reduction in size of entire plant or certain parts (fruit, flowers, roots) while rest of plant appears normal.

Abnormal growth - a stimulation of excessive growth on either certain parts (aerial roots, suckering) or the entire plant.

Usually the new growth is most likely to show damage when sprays are applied. The following are general rules or guidelines to help reduce plant damage from pesticides.

(1) Do not apply a pesticide to plants that are stressed. Avoid spraying under extremely hot, sunny conditions. When air or plant temperature is approximately 90 degrees or higher, damage will likely occur. On bright days, leaf temperature may be 5-15 degrees higher than the surrounding air, thus increasing the possibility of injury. Avoid temperature extremes, either high or low.

(2) Do not apply pesticides under conditions which will not promote drying. Plants sprayed when cool, humid conditions exist for extended periods will remain wet for long periods of time and increase the possibility of injury. Never spray plants when they are in need of water. Wilted or dry plants are extremely sensitive to spray injury.

(3) Wettable powders are usually safer to plants than liquid pesticides because they do not contain solvents. The disadvantage of wettable powders is the objectionable residue on the foliage.

(4) Almost all aerosol formulations of pesticides will cause plant damage if applied at less than the recommended distance between aerosol nozzle and plant. The distance usually recommended is 18-20 inches. In some experiments it was found that almost all of the aerosols tested were damaging to plants when applied at eight inches.

(5) Study the label and any brochures that are available concerning the particular pesticide to be used for rates, application instructions, and plant damage information. Do not overdose. Clean out sprayer, hose, and nozzles after each use.

"Things seem different now," Peggy notes, "and we compete with a glitter-laden world of entertainment. None of the glitter compares with my memories of Bass Lake."

"I just wish we could have those relaxed, casual days back," Frances adds.

"I guess the most rewarding part," Jerry concludes, "is the fellowship and warm sense of family that I remember the most. Everyone should have family reunions. If they did, the world would be a better place."

And the Skaggs reunion is open to everyone—Skaggs or not.


