### **USDA Announces Second 2006 Crop Counter-Cyclical Payments**

The U.S. Department of Agriculture today announced it will begin issuing \$555 million in second partical counter-cyclical payments (CCPs) to producers with 2006-crop upland cotton or peanut base acreage enrolled in the Direct and Counterpcyclical Payment Program (DCP).

Producers with barley, corn, grain sorghums, oats, rice, soybeans, other oilseeds or wheat base acreage enrolled in DCP will not receive these payments because market prices are well above levels triggering them.

Producers are eligible for CCPs when effective prices fall below target prices as specified in the 2002 Farm Bill. The effective price equals the direct payment rate plus the higher of either: (1) the national average market price recieved by producers during the marketing year; or (2) the national average loan rate for the commodity. USA calculates CCPs based on historical base acreage and payment yields, not current production.

#### Second Advance 2006-Crop Countor-cyclical Paymont Rates

The 2002 Farm Bill allows producers to receive CCPs in three installments:

The first in October (up to 35 percent of the total projected rate);

The second in February (up to 70 percent of the tala projected rate,



USDA issued 2006-crop first partial payments based on projected CCP rates in October 2006 for producers with upland cotton or peanut base. USDA bases the second partial payment rates for 2006 on supply, demand and price forecasts from USDA's World Agriculture Supply and Demand Estimates, released on Feb. 9, 1007.

#### **2006 Final Counter-Cyclical Payments**

USDA determines final CCPs after the nd of the marketing year for each commodity. The end of the 2006/07 marketing year for each commodity is:

- Wheat, barley and oats May 31, 2007
- Rice, upland cotton and peanuts July 31, 2007
- Corn, grain sorghum and soybeans August 31, 2007

#### Overpayments

The 2002 Farm Bill requires that any overpayments to producers must be repaid. If not repaid, USDA will deduct overpayments from any DCP payments received after the final payments are determined.

Richard Watson Kinser, age 89 of Gorman, died Friday, February 9, 2007 in a local nursing home.


Graveside services were held 3:30 p.m. Saturday at Oakland Cemetery, south of Gorman with Rev. Barry Schahn officiating.



## Eastland County Safe Kids, NHTSA, Others Unite to **Remind Parents of Importance of Child Passenger** Safety Valentines Week to Focus on Booster Seats

According to the National Highway Traffic Safety Administration (NHTSA), approximately 7,500 lives have been saved by the proper use of child restraints during the past 20 years. Yet, motor vehicle crashes still remain the number one killer of children ages 4 to 14 in America. The reason? Too often it is the improper use or non-use of child safety seats and booster seats.

That's why Eastland County Safe Kids is joining with NHTSA and other state and local leaders around Valentine's Day this year to commemorate Child Passenger Safety Week (Feb. 11-17).

"In 2005, an average of five children ages 14 and younger was killed and 640 were injured in motor vehicle crashes every single day," said Wayne Dennis, Education Director for Eastland County Safe Kids. "That's why we'll be working so hard during Child Passenger Safety Week and throughout the year talking to parents and caregivers about the importance of restraining their children properly in their vehicles."

While 98 percent of America's infants and 93 percent of children ages 1 to 3 are regularly restrained, not enough children ages 4 through 7 are restrained properly for their size and age. Only 10 to 20 percent of children ages 4 through 7 who should be using booster seats to protect them are actually in them. But children ages 4 to 8 who are placed in booster seats are 59 percent less likely to be injured in a car crash than children who are restrained only by a seat belt, according to a study by Childre Hospital of Philadelphia (CHOP).

"As children grow, how they need to be secured in a car, truck, van or SUV changes," Wayne Dennis said. "Moreover, when you're an expectant mother, it's important to always wear your seat belt to protect you and your unborn child. Wear the lap belt across your hips and below your belly with the shoulder belt across your chest (between your breasts). Once your child is born, be a role model and continue to buckle up every trip, every time."

For maximum child passenger safety, parents and caregivers simply need to remember and follow the 4 Steps for Kids:

1) For the best possible protection keep infants in the back seat, in rear-facing child safety seats, as long as possible up to the height or weight limit of the particular seat. At a minimum, keep infants rear-facing until a minimum of age 1 and at least 20 pounds;

2) When children outgrow their rear-facing seats (at a minimum age 1 and at least 20 pounds) they should ride in forward-facing child safety seats, in the back seat, until they reach the upper weight or height limit of the particular seat (usually around age 4 and 40 pounds);

3) Once children outgrow their forward-facing seat (usually around age 4 and 40 pounds), they should ride in booster seats, in the back seat, until the vehicle seat belts fit properly. Seat belts fit properly when the lap belt lays across the upper thighs and the shoulder belt fits across the chest (usually at age 8 or when they are 4'9" tall);

4) When children outgrow their booster seats, (usually at age 8 or when they are 4'9" tall) they can use the adult seat belt in the back seat, if it fits properly (lap belt lays across the upper thighs and the shoulder belt



#### POOR REPRODUCTIVE PERFORMANCE

Many times poor reproductive performance is caused by nutritional deficiencies and not the infertility of the cow or bull. By meeting nutritional requirements, those long calving intervals can be shortened. Increased supplemental feeding is often necessary for those cows on native range that are currently calving to rebreed within 90 days since an adequate supply of green grass is months away. A cow's protein and energy requirement can increase 20%-40% after calving depending upon the amount of milk the cow is producing. Cows with low energy levels may not cycle for 4 to 5 months after calving and may also fail to conceive at a satisfactory rate. An adequate energy in take of the cow is best reflected by an increase in body weight. Any cows that are gaining weight will rebreed much faster than cows that continue to lose weight after calving. Special attention should be paid to extremely thin cows and first calf heifers. Producers that are still feeding 38% cube after calving should probably switch to a 20% or 29% cube to boost energy levels in cows. Instead of feeding 2 pounds of 38% cube, producers should feed 4-6 pounds of 20% cube per day after calving for quicker rebreeding. This rate of 20% cube will allow the producer to hold the cow while doubling the energy intake over that of the 38% cube being fed at 2 pounds per day.

#### **TEXAS BEEF OUALITY PRODUCER PROGRAM**

Many beef producers have already heard about this but if you have not, mark it down. Beef producers can get free training to help them become more competitive by attending the Texas Beef Quality Producer Program in Comanche, Texas on Thursday, February 22, 2007.

The Texas Beef Quality Producer Program teaches the principles of Beef Quality Assurance, a proven system of sensible management practices that help improve the quality and safety of beef plus the program updates ranchers on changes occurring in the industry and what we must do to increase demand for our cattle. This program will demonstrate how a producer's actions on the ranch can have an impact on the final beef product something we all need to know more about.

There are two sessions for a total of eight (8) hours of training, divided into two levels. Level I covers BQA principles, industry update, record keeping, environmental stewardship and proper management practices associated with genetic selection, cattle handling, culling, vaccine and drug use. Level II provides a detailed explanation of the requirements needed to receive and maintain full certification as a Texas Beef Quality Producer. Ideally this certification should put you at a higher level as a beef producer and signify you as a cattleman who can and does produce a higher quality product.

It is not a mystery that consumers who buy our product are saying loud and clear that they want their food, not only great tasting but safe, wholesome and raised responsibly. We must respond if we want a place for our beef to go.

The speakers for this training are the best in the state. Dr. Ron Gill is Professor and Extension Livestock Specialist, Stephenville, and is well known in this area for his great livestock programs. Next is Dr. Ted McCollum, Professor and Extension Beef Cattle Specialist, Amarillo. Ted works a lot with the feedlot and stocker cattle industry and has first hand knowledge of how important quality is. Also on the program is Dr. Rick Machen, Associate Professor and Extension Livestock Specialist. Uvalde. Rich has been on programs in this area before and with his experience he is a real asset.

# **Application Process Begins For Certification Class In Basic Manufacturing**

The West Central Texas Workforce Development Board, in partnership with the Development Corporation of Abilene, the Workforce Center, and Texas State Technical College, are pleased to announce a the creation of a newly-developed training program in basic manufacturing. The six-week curriculum will culminate in a certification as a "Manufacturing Production Technician." The nationally-recognized certification is awarded by the Manufacturing Skills Standards Council (MSSC), and having this credential demonstrates competency in basic skills required to enter any type of manufacturing environment in any geographical location. Each trainee must complete a 140-hour course, which will consist of five weeks of manufacturing skills training at TSTC and one week of basic employment skills training at the Workforce Center.

Twelve local manufacturers, including Bandag, Abtex Beverages, Coca-Cola, Tige Boats, Martin Sprocket & Gear, Hirschfeld Steel, Fehr Foods, Peerless Manufacturing, Rentech Boiler Services, Micrometals, Inc., PWP Industries, and Zoltek, participated in a series of meetings and a survey process during the months of October and November to determine their interest in hiring workers with the MSSC certification. A significant shortage of entry-level workers and an immediate hiring need of 90-105 additional workers was identified. Targeted manufacturers have voiced their overwhelming support for the MSSC training, and have agreed to participate in a job fair and provide interviews to any student who completes the training and subsequently becomes certified as a "Manufacturing Production Technician". During the training period, site visits will be conducted at local manufacturing facilities to acquaint trainees with various types of work environments.

Funding for the training and the certification assessment fee for each participant will be covered by the Development Corporation of Abilene and the Workforce Development Board. The application and screening process is currently in progress for the first MSSC class, which is scheduled to begin on March 12, 2007. Interested individuals may pick up an application packet at the Workforce Center, 400 Oak Street, in Abilene, or download an application at www.workforcesystem.org. A Weekly Newsletter from Congressman Randy Neugebauer House to Debate Iraq Resolution

President Bush's new strategy for attaining victory in Iraq takes center stage this week in the House as we will devote three days to debating this important issue. At the end of the debate, the members of the House will vote on a non-binding resolution which states that "Congress disapproves of the decision of President George W. Bush...to deploy more than 20,000 additional United States combat troops to Iraq." Unfortunately, this hollow resolution does not match the seriousness of the issue we are debating. But it does send a demoralizing message to our troops.

Fighting and winning a war is serious business. It requires our President, our military leaders, and elected officials to make difficult decisions. However, making tough decisions is what the American people expect their representatives to do. The resolution we will vote on this week has no impact on policy and does not lay out a strategy for victory. Because it is non-binding, this resolution only serves to score political points and embarrass our Commander-in-Chief during a time of war. The realities of our current global conflict demand a more responsible approach.

We know that Iraq is not the beginning of this conflict, nor will it be the end. Our enemy is patient, calculating, and intent on attacking America. Therefore, the consequences of losing this important battle of the Global War on Terror could be catastrophic and far-reaching. If we leave Iraq without victory, terrorist groups will only be encouraged to expand their efforts. We must now stand 100 percent behind our troops and give them the tools and support necessary to get the job done.

#### USDA Secretary to Appear Before House Ag Committee

USDA Secretary Mike Johanns will appear before the House Agriculture Committee this week to discuss USDA's 2007 Farm Bill recommendations. Secretary Johanns also recently presented USDA's 2008 cholo budget proposal. Both of these issues are of significant interest to our region. I have some real concerns about several of his proposals, and I look forward to discussing with him the impact they could have on the 19th District.

#### The Home of the Intrepid

Fort Sam Houston in San Antonio is the most important military medical training and treatment facility in the world.

The Fort was built in 1875, but its roots date back to arrival of the first U.S. soldier in Texas in 1845. From 1910 until World War II, Fort Sam was the largest Army post in the continental U.S., and played a key role in the beginnings of military aviation.

Since the mid-1940s, Fort Sam has been the nucleus of U.S. Army medicine. The base spans 3,000 acres and employs more than 27,000 military and civilian personnel.

Now the Fort has a new distinction: It's the location for the world's most technologically advanced rehabilitation facility for American warriors wounded on duty, particularly in Iraq or Afghanistan.

Our generation is engaged in a deadly war on terrorism. Thousands of our finest young men and women have been injured in operations abroad, including hundreds of amputees and burn victims.

These wounded men and women deserve the very best facilities, and the "Center for the Intrepid" certainly delivers. Last month, inspiring dedication ceremonies were held in San Antonio, officially opening a four-story, 65,000-square-foot rehabilitation facility adjacent to Brooke Army Medical Center.

It offers state-of-the-art physical and occupational therapy and psychological counseling resources to amputee and burn victims. Facilities include an indoor running track, a firing range, an Olympic-sized pool, a two-story climbing wall and other notable rehabilitation benefits.

Modern technology is evident throughout. The Center's "computer assisted rehabilitation environment," known as CAREN, is as advanced as any facility in the world. CAREN provides virtual landscapes that simulate everything from a city sidewalk to a peaceful lake. Rehabilitation patients use the unit to improve their gait and balancing skills.

The Center reflects our nation's gratitude for the bravery, patriotism and service offered by our troops.

Another positive aspect of this cutting-edge project is that it was made possible through the generosity of individual citizens, rather than relying solely on the government.

Resources for the \$50 million facility came from the hearts and pockets of an estimated 600,000 Americans who donated anything from pennies to millions of dollars. The Center is the largest single private contribution to our nation's wounded military. The fundraising campaign was led by philanthropist Arnold Fisher of New York and the Intrepid Fallen Heroes Fund. In addition, the Center opened along with two new 21-bedroom Fisher Houses, which provide temporary accommodations for visiting family members. Earlier this month, I had the honor of visiting a number of our superb soldiers and marines, including some from Texas, who were wounded in Iraq or Afghanistan and are undergoing treatment at Walter Reed Army Medical Center in Washington, D.C. I was able to discuss career options and future plans with several patients and their families on the wards, and with men and women undergoing rehabilitation in the Physical and Occupational therapy clinics. I was impressed with the optimism and spirit of these great Americans. I hope that at least some of them will be able to utilize the great advantages of the new Intrepid Center at Brooke Army Medical Center for their future rehabilitative care. The Intrepid Center will be a great asset for our service members for years to come as we care for those on the front lines of the global war on terror. It's heartening that so many individual Americans are eager to show their appreciation to those defending our freedom. Our nation has a solemn duty to provide for our troops, and the government can never do enough to demonstrate our gratitude for their sacrifice. But voluntary points of light made the Intrepid Center possible, and that spirit of shared mission makes our country even greater and stronger. Sen.
