# **Panthers Shutout Lions** 55-0; Host Owls Friday

The Fighting Panthers took it on the road this past Friday night in Roby. They came home with a 55-0 victory. The offense accumulated just under 500 yards total offense with senior Tony Perez leading the ay with 224 yards rushing on 24 carries. Perez also had four touchdowns. To of the four touchdowns were of multiple yardage, 33 and 55. Swanner in his first outing at quarterback had a good night going 3 of 5 passing for 57 yards. He had no interceptions. Swanner also dialed his own number with a 30 yard keeper after a great play fake with Matt Underwood. Underwood finished the night just under the century mark with 91 yards rushing on just 12 carries. Fox had 10 carries for 66 yards. Senior Orlando Valenzula had four carries for 42 yards and one touchdown. Fox had a 35 yard scamper and went untouched after outrunning the Lions defense unit in the fourth quarter.

The Panther defense had a good first game giving up just four first downs. Sophomore transfer Drw McCreless had a first quarter interception to kill one drive and made several key tackles on the night. Senior linebacker Chad Klein had a good game at inside linebacker after being missing part of the week ill. The defense overall showed promise after just one scrimmage and one game.

Late in the fourth quarter the shutout looked a bit vulnerable. On a 2nd and goal from the Lions five yard line the ball was stripped and senior defensive Aaron Keith scooped the fumble up and lumbered 95 yards for the final score on the night. Swanner handled the kicking and punting on the evening and made all his PAT attempts. He also did a great job in the punting.

This Friday night the Panthers will be playing at home against Covington Owls at 7:30 p.m. Hopefully everyone will show for the first home game of the year. 

The cleanup of flood-related debris at Lake Leon is almost complete according to Eagle Construction. I was in the Staff area Tuesday morning and the difference is remarkable. Eagle has done a good job of debris removal and site ranking. Commissioner Christian of Precinct Two and his crew have made many rounds at the lake and have done a good job of removing the metal goods and hazardous household waste. By the end of Friday, the cleanup should be finished.

PLEASE NOTE: Eagle Construction made one more sweep of the Lake Leon area on Saturday, September 1st. This was the last chance for flood related debris to be removed by the contractor. Now, the residents will need to plan to use their normal, individual waste removal system.

In a prior press release, I reported that FEMA will not reimburse Eastland County for expenses related to the removal of demolition or any new construction debris. As a homeowner, you need to make sure that your private contractor is going to responsible for completely removing debris from the demolition and construction work. My advice to homeowners is to obtain a written and signed contract with your contractor that specifically addresses debris removal. As Eastland County will not be responsible for demolition and new construction debris removal.

Finally, a hug thank you to all the first responders, volunteers, faith-based work groups, local churches, state and federal agencies, and individuals who labored so hard ot get the flood problems resolved. I would thank each of you individually, but I know that I would leave someone out of the list. Be assured that your efforts were noticed and appreciated by everyone affected. In conclusion, the self-motivation, spirit of cooperation, and overall strength of Eastland County residents were evident in the manner exhibited by the people affected by the disaster and the people that responded. I thank you greatly.







### ORDINANCE NO. 2007-04

AN ORDINANCE OF THE CITY OF GORMAN, TEXAS, LEVYING TAXES FOR FISCAL YEAR BEGINNING OCTOBER 1, 2007 AND ENDING SEP-TEMBER 30, 2008: PROVIDING DISCOUNTS FOR ADVANCE PAYMENT OF AD VALOREM TAXES; PROVIDING FOR THE COLLECTION OF DE-LINQUENT TAXES; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, notice of a regular meeting with the adoption of a tax rate was duly posted on the agenda,

WHEREAS, a regular meeting was duly held at the time and place as provided for in the notice of such meeting and all interested persons were given opportunities to be heard on said tax rate; and,

WHEREAS, it is necessary, at this time, that said ordinance be passed levying taxes on all property, both real and personal, within the City of Gorman, Texas, in accordance with such budget and all requirements of Article 7244c RCS of the State of Texas have been complied with:

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GORMAN, TEXAS, AS FOLLOWS:

Section 1: That there is hereby levied, and there shall be collected for the use and support of the municipal government of the City of Gorman, Texas, for the year 2007 upon all property within the corporate limits of the city of Gorman, Texas, subject to taxation for the year 2007, a tax at the rate of \_\_.84\_\_\_/100 dollars on each One Hundred and no/100 (100.00) valuation of property to be assessed and collected for the purposes hereinafter stipulated, to-wit,

Section 2: All taxpayers shall be allowed discounts for the payment of 2007 ad valorem taxes due to the City of Gorman, Texas, said discounts to be allowed under the following conditions:

Three percent (3%) discount on ad valorem taxes due to the City of Gor-(a) man, if same are paid within the month of October,

Two percent (2%) discount if such taxes are paid in the month of Novem-(b) ber,

One percent (1%) discount if such taxes are paid in the month of December,

Section 3: The general laws of the Texas, and all provisions of Article 7336, and of Titla 122 of the Revised Civil Statutes of Texas, penalties, interest, cost, and the collection of delinquent taxes, insofar as such provisions may be applicable in connection with the collection of all taxes assessed and levied by the City of Gorman, Texas, for the year 2007 are hereby referred to and adopted.

Section 4: This Ordinance shall take effect and shall be in full force and effect from and after its passage.
