This is in response to the City Council's Amendment of City Ordinance #299 posted in the November 8th issue, Prohibiting Commercial Trucks to park overnight in any residential areas in Gorman.

My husband and I moved to Gorman recently and we love living here and being a part of this community. What makes it possible for us to live here, pay our city water, garbage, taxes and be patrons of all the business here that support our community is that my husband drives a Commerical Truck for a company dispatched out of Stephenville. Occasionally, there is need for that truck to be parked at our residence on our own private property. We have plenty of room for this. At no time is traffic blocked or vision impaired. At no time will this particular truck contain a hazardous load. There are no high wires in threat. The postman is not blocked.

Gorman does not have a truck-stop that is attended 24hrs a day. When my husband has the need to bring his truck home, his company requires the truck to be close by and dropping the trailer is not allowed. Most trucking companies have the same policy.

From observation I see a high percentage of Gorman residents that are commercial truck drivers with the need of being allowed to park at their homes. With the rapidly rising and instable gasoline prices, it saves these residents a considerable amount of their budget from having to be spent on gasoline. This is a seeming family oriented city. Allowing the trucks to be able to be parked at homes encourages and supports


> The commercial drivers in this city are a great workforce that help keep this city a city.
