




SCAMPERING OUT OF THE BACKFIELD - Matt Underwood is shown trying to go out wide in game action Friday



I have had several questions asked about the bond election and what it would mean regarding taxes should the citizens of Gorman pass the bond. First, let me say that for senior citizens whose taxes are frozen it would have no effect. It will also have no effect on homestead exemptions. Last year, your school tax rate was \$1.45 per \$100.00 dollars evaluation. So, on a \$50,000.00 home, the school tax was approximately \$725.00. This year the tax rate was lowered to \$1.3257 and the approximate tax on the same home will be approximately \$662.85. This is a savings of approximately \$62.15, if your home did not increase in value. If the bond passes, we will not do anything until we see if the Legislature (begins in January) rolls forward the existing debt allotment for schools (EDA). We have to have EDA money to actually do the project. Assuming the state rolls forward the EDA program and the district issues the bonds, the state will be picking up approximately 65% of our debt service payable on the bonds. Our part of the debt service would be approximately .32 cents per hundred dollars evaluation. The state has said they are lowering the maintenance and operations tax rate to \$1.00 next year. Based on this \$1.00 maintenance and operations tax rate, coupled with our .04 cents enrichment and the .32 cents for payment of the bonds, the district's total tax rate will be approximately \$1.36 for the 2007-2008 school year if the bond passes. This would make the school tax on a \$50,000.00 home approximately \$680.00, approximately \$45.00 lower than the 2005-2006 taxes. If you have any questions, please call me.

The School Board met Monday night at 7:00pm for their regularly scheduled September meeting in the auditorium at the high school. All board members were present and the following action was taken:

- 3. TASB Policy Update 78 was approved 7-0
- 4. Campus and District Improvement Plans were approved 7-0 5. Adjunct personnel agreement with Eastland County was approved 7-0
- 6. Superintendent goals and appraisal instrument were reviewed and ap-
- proved to remain as they were 7-0 7. Interlocal Agreement with Eastland County was approved 7-0

8. Board adjourned at 8:15pm

During reports that were given, Coach Talbert was very pleased with the effort of his team Friday night and was looking forward to this Friday's game in New Braunfels. Mrs. Reeves pointed out how well the schools in Region 14 did as a whole compared to the state. We are in the best performing region in the state. Mr. Panter said everything was positive on the secondary campus and that the good attitude of the students and teachers was incredible. Mr. Perry shared plans to put sprinkler systems in at the softball, baseball, and football fields this year as a means of conserving water and reducing labor involved in field maintenance. It was also discussed that the food in the cafeteria was great so far this year and that there had been no complaints. Gena Roan, the new manager is preparing a lot more from scratch this year and the menu in much healthier for the students that way. We appreciate what the cafeteria crew is doing!



WINTER WEED CONTROL FOR LAWNS

Early September is the time to be applying fall preemergents for the control of annual winter weeds in home lawns, sports fields and on golf courses. One of the big reasons for poor weed control with the fall preemergent applications, is that individuals wait too late to make their treatments. Once the weed seed has germinated and the plant is growing, the majority Charlie made the motion to approve the bills for payment. Joe made of these preemergents will not control the weeds. Also, many of these herbicides are broken down by sunlight and if left on top of the turfgrass, they will loose some of their activity.

Preemergent herbicides are the most effective means for control of annual grassy weeds in turfgrasses. If the turfgrass is completely dormant, then you can use herbicides such as Glyphosate (Roundup) or Glufosinate - ammonium (Finale) for winter grassy weed control. However, for most of our winters, many of the turfgrasses being grown in home lawns and on sports fields and golf courses do not go completely dormant. Using one of these products when the turf is not completely dormant could cause severe injury to the turfgrasses.





USDA Issues Final '05 Counter-**Cyclical Payments**

Agriculture Secretary Mike national average loan rate. beginning today. This is the earliest that producers will have received final counter-cyclical payments for these commodities.

"Drought and low market prices are just two factors adversely affecting many producers this year," said Johanns. "These payments will help many farmers during this difficult period to remain a viable part of America's agriculture sector in the future."

Upland Cotton

The final 2005-crop upland cotton counter-cyclical payment rate is 13.73 cents per pound. The upland cotton payment rate is at the maximum level due to market prices averaging well below the 52-cent-perpound loan rate during the marketing year. Because of these low market prices, USDA is able to calculate the final counter-cyclical payment rate for upland cotton at this time. If market prices were higher, USDA would calculate the payment rate after USDA's National Agricultural Statistics Service (NASS) announces the national average market price in October.

Required by the 2002 Farm Bill, final Counter-Cyclical Program (CCP) payments for upland cotton are made following the marketing year. The 2002 Farm Bill provided for the availability of partial 2005crop CCP payments in October 2005 and in February 2006. Producers who accepted the two partial payments received 9.61-centsper-pound. They are due an additional 4.12-cents-per-pound.

Grain Sorghum

The final 2005-crop grain sorghum counter-cyclical payment rate is \$0.27 per bushel. The grain sorghum payment rate is at the maximum level due to market prices averaging well below the \$1.95 per bushel loan rate during the marketing year. Because of these low market prices, USDA is able to calculate the final counter-cyclical payment rate for grain sorghum at this time, prior to NASS's release of the final season average price at the end of September.

Final CCP payments for grain sorghum are normally made following the marketing year. The 2002 Farm Bill provided for the availability of partial 2005-crop CCP payments in October 2005 and in February 2006. Grain sorghum producers who accepted the two partial payments received \$0.1890 per bushel. They are due an additional \$0.081 per bushel.

Peanuts

CCC announced that peanut farmers will receive 2005-crop counter-cyclical payments of \$104 per short ton. The final weighted average marketing year price for 2005-crop peanuts, which was announced on Aug. 31, 2006, is \$346 per short ton, \$9 lower than the \$355

The 2002 Farm Bill reupland cotton, grain sorghum and gram (CCP) payments for peanuts peanut counter-cyclical payments to be made after the end of the marketing year. The 2002 Farm Bill provides for partial 2005-crop CCP payments in October 2005 and February 2006. > The counter-cyclical payment rate is the amount by which a commodity's target price exceeds its effective price. The effective price equals the direct payment rate plus the higher of: (1) the national average market price received by producers during the marketing year, or (2) the national average loan rate for the commodity. The counter-cyclical payment amount equals the CCP payment rate, times 85 percent of the farm's base acreage, times the farm's CCP yield per crop. USDA's Farm Service Agency distributes CCP payments on behalf of CCC.
