

### **Neugebauer Appointed Deputy Ranking**

### **Republican on Financial Services Committee**

"I look forward to our work in the Ag Committee as we craft the next Farm Bill and put in place agriculture policies that help producers in Texas and across America succeed in the global marketplace."





Neugebauer, who served on the Science Committee during his first term and the latter portion of his second term, will retake his seat on the panel under its new name, the Science and Technology Committee.




## **Upcoming Brown Bag Seminar**



## **Tax Deferral Available For Over 65 Residential Homestead Owners**

Section 33.06 of the Texas Property Tax Code requires the followinbg information concerning the Deferral of Certain Property Taxes to be publicized.

Property taxes on the residence homestead property of those persons sixty-five (65) years of age or older may be deferred or abated if they satisfy the requirements of the Texas Property Tax Code.

The property owner must (in most cases) occupy the residence on which the tax is being levied or on which a suit has been filed for collection of

To obtain a deferral, the individual must file with the Chief Appraiser of the Appraisal District in which the property is located: an affadavit stating that he or she is sixty-five(65) years of age or older and that he or she does own and reside in the residence that the tax is being levied on. If a suit has already been filed with the proper authority, the individual mus file with the court in which the suit was filed the same type of affidavit.

By filing the affidavit with the proper authority, the payment of the taxes or forced collections through suit is postponed until the person filing the affidavit no longer owns or occupies the property as a residence homestead.

It is emphasized that the tax is only deferred: it is not cancelled. A tax lien remains on the property and interest in the amount of eight (8) percent per year will continue to accrue during the period that the collection of taxes is deferred.

For information concerning the tax deferral or abatement, contact the Eastland County Appraisal District. The office is located on the second floor of the Eastland County Courthouse Annex Building at 102 N. Lamar, Eastland, Texas. The telephone number to call for assistance is 254-629-8597.

## **Post-Traumatic Stress Disorder Among Military Veterans**

"During the Civil War, Dr. Decosta, a U.S. Army surgeon, reported high levels of tension, fast heart rate, inability to sleep, and fear about returning to combat. This response to combat was called "soldiers heart."

During World War I this same phenomena was called by a more familiar term, "Shell Shock." The think of the medical professionals at that time was that tremendous shelling caused small blood vessels in the brain to burst. The symptoms included running amok, jumpiness, irritability, trouble sleeping and physical tremors.

World War II brought us "Battle Fatigue" a term which started with the U.S. forces in Tunisia, North Africa. The battlefield medical personnel found that rest, food, and returning soldiers to their units helped them to deal with their emotional and physical problems related to combat. In the Korean War, the term "Gross Stress Reaction" was used to describe the emotional turmoil that was a result of combat and being a prisoner of war.





### State of the Union Address: What to Look For

President Bush will deliver his seventh State of the Union Address on Tuesday, January 23. 
