The annual meeting of the Texas Shorthorn Association is scheduled for 8:00 p.m., according to Dale Taylor, Wolfforth, association president. Business will include yearly reports, election of directors and officers, announcement of the Progressive and Pioneer Breeders and an auction of prime advertising space in the 2006 membership directory. Association members, Rodney McAnear and Cliff Wammack, will serve as auctioneers. During the business meeting the youth will swim and participate in volleyball, horseshoes and other outdoor games.

Judging contest classes will be reviewed at 4:30 p.m., followed by a tour of floyd Shorthorn cattle. #### **Locate Lost Graves**

Have you ever tried to locate a lost or unmarked grave? One of the easiest and least expensive ways to locate these graves is by dowsing.

There will be a demonstration on dowsing for lost graves at the Victor Cemetery on Thursday and Friday, May 25 & 26, anytime from dawn to noon, and on Saturday, May 27 from dawn till 10:00 a.m.. Anyone interested in watching, learning or helping is welcome.

To reach Victor Cemetery from De Leon, go north on Hwy 16 about 6 miles, urn right (toward the east) on FM 2156 for about 3 miles. From Desdemona, go south on Hwy 16 about 4 miles, turn left (toward the east) on FM 2156 for about 3 miles. From Dublin, from the traffic light at Dairy Queen, take FM 19 North (toward Lingleville) for about 1 1/2 miles, then left on FM 2156 for about 11 miles.

Anyone who is interested in learning about dowsing is welcome to come. If possible, bring 2 all-metal clothes hangers with you to practice with.

#### **Juice - Too Much Of A Good Thing**

Preschoolers who drink too much juice are more likely to be too short, and too heavy, for their age according to research. As a result, nutrition experts are advising parents and child care givers to limit juice to 3/4 cup per day. "Unfortunately, when it comes to juice, there's such a thing as too much" says Dr. Sharon Robinson, Nutrition Specialist with Texas Cooperative Extension.

While fruit and juice are part of a healthful eating plan, they should not be substituted for milk and other healthful foods. As always, a healthy eating plan is based on variety, balance and moderation.

When shopping for fruit juice, look for '100% juice' on the packaging. Powdered fruit-ades and fruit flavored sodas are no substitute for the nutrition that is in 100% fruit juice. "In fact," says Dr. Robinson, "sweet drinks not only add calories to the diet buy they can spoil children's appetite for the foods they need to grow, develop, and stay healthy." Children who consume more calories than needed are more apt to be heavy for their age.

How much fruit and juice should you offer your preschooler? Most young children need about 1 to 2 cups from the MyPyramid Fruit Group each day. To determine how much food you should serve your child based on your child's age, gender and physical activity level visit http://www.mypyramid.gov .

The next time you take your child to the doctor, ask if your child's height and weight is right for this or her age. Remember, never place a child on a weight loss diet unless instructed by a doctor. Instead, serve foods based on MyPyramid during family mealtimes and enjoy regular family activity.

Only time will tell. There is rarely a piece of legislation passed of this magnitude that doesn't have to be tweaked several times before it actually accomplishes what it was created to do. Our thanks go out to Representative Keffer and his staff for all the hard work they endured and for representing us well.

Monday night we held our regularly scheduled board meeting at 7:00pm in the high school auditorium. After our usual opening with a prayer and the Pledge of Allegiance, Hollyann Wright read the prose to the board that she performed in Regional U.I.L. academic competition where she placed fifth. She did an excellent job. I think she should have won the competition! Hollyann then spoke to the board representing girl's athletics in support of the job Coach Tooley has done. Coach Tooley himself addressed the board next. He will not be with us next year and we wish him well in his career pursuits. Next, the board approved the consent agenda after making one correction to the minutes of the previous meeting. Coach Tyson announced that the Athletic Banquet would be hosted by ZJ's on Tuesday, May 16, 2006 at 7:00pm and that awards would be presented for all sports at the event. Mrs. Hampton then gave the counselor's report reviewing her counseling activities for the previous month. She also mentioned the Academic Awards Assembly on May 16, 2006 at 10:00am in the auditorium; Senior Community Service Project on the 15th, 17th, and 18th; and the Talent Show for grades 7-12 May 18th. Mrs. Reeves then gave the Elementary Principal Report where she commented on the many trips our children have made over the past week. Their enrollment is at 217 and our attendance rate is at 96.79% which is excellent. She also gave the results of our 4th, 5th, and 6th grade Science Fair. Those that placed are as follows:

Mr. Panter then gave the High School Principal Report and commented on how great prom was and thanked Mrs. Majors, Mrs. Gore, and the junior class for their work on it. He then stated that students will have their schedules for next year before they leave for the summer. He then mentioned up coming events including the Spring Band Concert Monday, May 15, 2006 at 6:30pm. The superintendent then gave his report which included several information items, but centered on compiling a list with the board of specifications for the proposed gym and fine arts building so that he could meet with the architect and relay the information. He also informed them that there would be an online driver's education course available to our students for the textbook portion of the course. The cost will be \$125.00.

The board then approved the Student Handbook for the 2006-2007 school year; Trustee Certification of Textbooks, and the adoption of a local wellness policy with votes of 6-0. They then tabled the approval of the school's contract for library services until the June meeting in order to give Mrs. Reeves time to assess the needs at the elementary library. The board then approved Stanley Walker as the Student Insurance carrier for 2006-2007 and a transfer of funds from investment to operations (FYI - we keep our money in investment accounts to earn maximum interest as long as we can). The board then went into executive session by order of the president to discuss personnel. When the board came out of executive session, motions were made, seconded, and passed to offer probationary contracts to Billy Fox and Dena Scitern for the 2006-2007 school year. The board then adjourned. Then next regularly scheduled board meeting will be at 7:00pm in the high school auditorium on June





**Making Choices** 

Being a United States Congressman often boils down to the simple act of making choices. Each day, there are choices that need to be made regarding national priorities and whether or not to support particular pieces of legislation. It is a responsibility each member accepts, and one that I take seriously. Last week, members of the House had several opportunities to make some important choices regarding national security and the federal government's use of taxpayer dollars.

On Wednesday, I chose to support tax relief legislation and prevent a tax increase from being levied on middle-class Americans. 
#### **Texas House Votes 136 to 8 for HB1**








#### **Legislature Passes Ban On Protest At Military Funerals**

The Texas Legislature passed House Bill 97 today, which would ban protests or other disruptive behavior at funeral and burial services for Texas military men and women.

"There is a time and place for protests and dissention, but it's not at funeral and burials for U.S. solders. Their families have through enough pain and trauma without these demonstrations," says State Rep. Jim Keffer (R-Eastland).

House Bill 97 criminalizes protesting within 500 feet of a cemetery or facility being used for a funeral service beginning one hour before a service and ending one hour after the service is complete. Such acts will be classified as Class B misdemeanor in the Penal Code. The legislation will not prohibit patriotic displays.



## **Watching for Birds**

'As prices for oil and gas remain unacceptably high, Texas is turning to alternative energy sources. Texas already leads the nation in generating electricity through wind power - much of it in the Panhandle. Now there are proposals to build big wind turbine farms along the Gulf near Galveston and Corpus Christi.

But there are complications. Environmentalists point to the Texas coast as a prime travel route for hundreds of bird species migrating to and from Mexico and Central America. Researchers are making certain the wind farm propellers will pose no danger to the migrating birds. It's all a reminder that virtually every "easy" solution to our energy supply problems has a potential downside.

It also points out the growing importance of birds to Texas. Birdwatching has become one of the state's more popular pastimes and tourism attractions. The American Birding Association has named Texas the best place to bird-watch for five consecutive years. 'Birding,' as it's known, is our state's fastest-growing form of nature tourism. That has two beneficial consequences: it promotes the conservation of natural habitats, and it strengthens our local economies.

Texas is home to a greater variety of birds—more than 600 than any other state. Three-quarters of all American birds either migrate through Texas or reside here. One reason is our diverse surface geography. Another is our key location in traditional migration patterns. And maybe even birds know what we know: Texas is just a great place to be.

In the early days of the Texas Republic, famed naturalist James J. Audubon landed at Galveston and traveled parts of Texas sketching wildlife for his classic book, "Birds of America." It's safe to say he was impressed. Visiting South Texas in 1837, Audubon observed, among other birds, the ivory-billed woodpecker. Until it was reportedly spotted again last year in Arkansas, the ivory-bill had been considered extinct for 60 years.

Great birding venues exist all across our state. A watcher with good eyesight can see 10 types of hummingbirds in the Davis Mountains in West Texas. Bird watching can be combined with general enjoyment of the wilderness – near Alamo, Texas, you might see various birds, butterflies and even a rare ocelot at the Santa Ana National Wildlife Refuge. In the often tropical weather of the Rio Grande Valley, birders may spot spectacular visitors such as a Mexican northern jacana, with its bright yellow-green wings.

But the Texas Gulf Coast is properly described as the crown jewel of bird-watching venues. The Great Texas Coastal Birding Trail spans the entire 624 miles of our Gulf Coast, from Beaumont to Brownsville – the first of its kind in the nation.

Included in this vast spread – big even by Texas standards – is the Aransas National Wildlife Refuge, just north of Rockport, winter home to the endangered whooping crane. Further south on the trail, native birds such as the oriole, the flycatcher and the kingfisher congregate in a much-visited state park on the Rio Grande.

Bentsen-Rio Grande Valley State Park, near Mission, houses the headquarters of our World Birding Center. It's a collaboration of the Texas Parks and Wildlife Department, the U.S. Fish and Wildlife Services and nine Valley communities. The 10,000-acre center's mission is protecting native habitat and increasing awareness and appreciation of birds and wildlife. It opened officially only in 2003, but it's already world famous.

The Center is actually nine different sites. It includes a wide array of habitats along a 120-mile stretch from South Padre Island west to Roma, Texas. The Center promises visitors a "birders' eye view" of the seasons in the Lower Rio Grande Valley. In winter, there are warblers, sparrows and purple martins. The spring brings swallows and migrating raptors. Summer offers the long-billed curlews and orchard orioles. With autumn arrive buntings, cuckoos and ruby-throated hummingbirds.

This is all great for Texas tourism. In 2001, wildlife-associated recreation — fishing, hunting, and wildlife-viewing, including birding – contributed \$4.7 billion to the Texas economy. Nature tourism alone contributed \$301 million in additional local tax revenues.
