County Judge Rex Fields Responds to Flu Inquiries

I have been asked to respond to inquiries about the current flu issue and how it is affecting Eastland County. As of this writing on April 30th, there are no known, confirmed cases in our county of H1N1 flu or what has been called "Swine Flu" by some. I have checked with the County's health officer and some of the schools in our county. No unusual flu beyond the seasonal type that always affects us has been reported. No schools in Eastland County have been closed. The only school event that has been canceled of which I am aware is Cisco Junior College which has canceled its graduation ceremony, held Friday, May

I have also talked with the division of homeland security at the West Central Texas Council of Governments (WESTCOG) in Abilene. As of this morning, April 30th, non of the 19 counties that comprise the WESTCOG region have any confirmed cases. This includes Taylor County, so I infer that neither of the regional hospitals in Abilene have any confirmed cases. There are 26 confirmed cases in Texas, with the nearest cases being in Tarrant County. All of the cases seem to be in more densely populated areas such as the Metroplex and San Antonio area.

Eastland Memorial Hospital reported to me this afternoon that there have been no confirmed cases. The Director stated that they monitor anyone being admitted with flu-like symptoms and report these to the state.

So to restate, the N1N1 "swine flu" is not here, but you do need to take precautions to prevent infection from this or any communicable disease. I will paraphrase some of the information that I have received from the state and other resources. Practice healthy habits to stop the spread of germs by washing you hands and using alcohol-based hand sanitizers. Cover your mouth when you sneeze or cough. Seek medical care if you feel sick. If you have been to Mexico, pay close attention to your health for seven days and if you start feeling sick, see a doctor. Those people most susceptible to this flu are the very young, the very old, and anyone that is pregnant. The bottom line is to prevent infection and protect yourself and your family from any disease.

Finally, here is the state source of information on the flu issue: http://www.dshs.state.tx.us/ Texas Department of Health Services (DHSH). This website is loaded with very useful instruction on what to do about this and many other diseases. I encourage you to do some research so that you can be better prepared now and in the future.

tre facilities on the west side of the square. Richard Rossander, who has personally undertaken the task of putting this fund raiser together, feels it is time for the people of Eastland to help.

"There currently is very little, if any money out there for projects like this," he said, "so WE the people of Eastland need to pull together and help get this project off the ground."

The Eastland Centre for the Arts was formed in late 2006 and were given permission by the Eastland Community Foundation to use the facilities the foundation owned on the west side of the square for their project. The organization was chartered as a Texas nonprofit corporation in July 2007and in September of that same year a 501(c)(3) exemption was received from the IRS.

Since then this group has diligently attempted to raise funds for work to the buildings and in June of 2008 the Eastland Community Foundation presented the deed transferring ownership of the properties to the Eastland Centre for the Arts, Inc.

Work began on the facades of the facilities earlier this month with demolition and framing started this week. Current estimate of the project is \$70,000 and the ECA board started the work with funds from their building account. In recent actions by the City of Eastland, a \$35,000 "Challenge Grant" was awarded to the project in hopes others will step up and

Ranger Man Gets Six Year Prison Sentence

Abel Delatorre, 29, formerly of Ranger, is now an inmate awaiting transport to the Texas Department of Criminal Justice to serve a six year prison sentence for the delivery of approximately 6 grams of Cocaine.

Delatorre was part of a group of individuals arrested in October, 2008, when approximately 20 law enforcement officers began serving felony warrants on multiple defendants in various locations of the county. An agent of the West Central Texas Interlocal Crime Task Force, while working in an undercover capacity, made the purchase of cocaine from Delatorre that led to his arrest.

Criminal District Attorney Russ Thomason stated, "Drug Dealers should be aware, law enforcement officers are watching and actively working to stop the flow of poisonous drugs in Eastland

Army National Guard Staff Sgt. Tim Allen **Receives Army Achievement Medal**

Army National Guard Staff Sgt. Timothy M. Allen has been awarded the Army Achievement Medal for participating in Operation Iraqi Freedom.

The medal is awarded to soldiers who have served in any capacity in an area authorized by the Secretary of the Army. The recipients must have distinguished themselves by meritorious service or achievement while acting on behalf of the Army.

Operation Iraqi Freedom is the official name given to military operations involving members of the U.S. armed forc-



es and coalition forces participating in efforts to free and secure Iraq. Mission objectives focus on force protection, peacekeeping, stabilization, security and counter-insurgency operations as the Iraqi transitional governing bodies assume full sovereign powers to govern the peoples of

Members from all branches of the U.S. military and multinational forces are also assisting in rebuilding Iraq's economic and governmental infrastructure, and training and preparing Iraqi military and security forces to assume full authority and responsibility in defending and preserving Iraq's sovereignty and independence as a democracy.

Allen received the medal for aiding an Iraqi civilian after his car caught fire on Dec. 7, 2008. He is deployed as a combat engineer squad leader at Camp Liberty, Iraq, assigned to the 836th Engineer Company, 926th Engineer Brigade, Multi-National Division in Baghdad. The guardsman is regularly a member of the 836th Engineer Company based in Kingsville, Texas.

The staff sergeant has served in the military for 17 years. He is the son of Ann Higdon of Cataula Drive, Cataula, Ga. His wife, Brenda, is the daughter of Milie Richardson of N. Bowie St., De Leon, Texas.

The sergeant is a 1989 graduate of Montgomery County High School, Mount Sterling, Ky.

Man Sentenced To Seven Years For Cattle Theft

Bryan D. Rainey, 34, formerly of Haskell, is now an inmate awaiting transfer to prison to serve a seven (7) year prison sentence for theft of cattle - stolen in a single transaction with aggregate value of less than \$100,000. Rainey was facing a maximum sentence of ten years confinement in the Institutional Division of the Texas Department of Criminal Justice. The Honorable Judge Steven R. Herod of the 91st District Court sentenced


The theft case stemmed from a purchase made by Rainey of 53 head of cattle at a local livestock auction in March of 2008. Rainey presented a check that was returned for insufficient funds.

On April 9, 2009, Rainey received probation in Midland County for similar charges related to the theft of 64 head of cattle. Rainey would have been on probation for seven years.

Also in April, 2009, Rainey was tried to a Haskell County jury that was unable to reach a verdict resulting in a mistrial That case also involved theft allegations. District Attorney Mike Fouts of Haskell, has stated that he intends to retry the case immediately. Rainey faces a maximum of ten years confinement in that case.

Rainey also faces probation revocation charges in Wise County. Rainey was placed on ten years probation in 1998 in Wise County for Theft of Property. He will face a maximum of three years confinement in that case.

The investigation of the case was handled by Ken Miniard, an investigator and field inspector with the Texas and Southwestern Cattle Raisers Association. Criminal District Attorney Russ Thomason prosecuted the case with Attorneys Lance and Mike Hall of the Hall Law Firm in Sweetwater.



Senate Passes Eminent Domain Bill

Austin, Texas - The bill to provide a more property owner friendly eminent domain process was unanimously approved by the Texas State Senate today. Senate Bill 18, introduced by Senator Craig Estes (R-Wichita Falls), reforms the process of eminent domain and condemnation for property owners in the state of Texas. SB 18 now moves

"Property owners know that Texas is growing and that our land and water will be needed to accommodate future growth, but that accommodation shouldn't be at the expense of property owners," Texas and Southwestern Cattle Raisers Association (TSCRA) President Dave Scott said.

"Members of the Texas and Southwestern Cattle Raisers strongly believe that Texas property owners do not have enough protections under the current eminent domain law. Senate Bill 18 levels the playing field for property owners," he continued.

SB 18 prohibits condemnation of land for private use. It improves procedures to initiate eminent domain. proceedings by requiring any actions by governmental entities to be done in public and by a record vote.

Additionally, the bill requires a bona fide offer by the condemning entity. If no bona fide offer is made, SB

18 requires the condemnor to pay all fees incurred by the property owner. The bill also allows for a property owner to be compensated for a material impairment of direct access on or off the remaining property if it affects the market value of the remaining property. It goes further to define "direct access" as ingress or egress on or off a public road, street or highway at a location or locations where the remaining

property adjoins that road, street or highway. The bill allows for a property owner or their heirs to repurchase the property at the price paid to the owner when the property was acquired if the land is not used for public use in a timely manner.

II. Enjoy the Seasons you are in. (Eccl. 3:11-13)





Nominations for candidates to run for the Farm Service Agency county committee election representing producers in Local Administrative Area 1 will be accepted now through August 3, 2009.


LAAs are elective areas. Single counties are divided into three LAAs. Elections are held each year to replace a member whose three-year term will expire.

Eastland County will be holding an election for a person to represent LAA 1, which is in the east part of the county. That position is currently held by Danny Snider. Mr. Snider is eligible to run again.

Ballots will be mailed to eligible voters by Nov. 6, and must be returned to the FSA county office or postmarked by Dec. 7, 2009.

All farmers, ranchers, and other producers are encouraged to participate. The county committee provides local input on commodity price support loans and payments, yields, conservation programs, disaster assistance payments and other programs. They make many decisions that affect you as a producer, so these elections are important.


