



NEWS FROM DISTRICT ATTO MARIHUANA POSSESSION NETS PRISON SENTENCE

Vincent Antonio Griffieth, 44, formerly of Carson, California, is now an inmate awaiting transfer to state prison to serve a (5) five year sentence for possessing 16 small baggies of Marihuana, 50 pounds or less but more than 5 pounds. Griffieth was apprehended on August 5, 2005 by a Department of Public Safety State Trooper on Interstate 20 near Eastland.

Griffieth had previously posted bond but did not appear for trial. An arrest warrant was issued and Griffieth was rearrested in November 2008. On April 9, 2009, Griffieth entered a plea of guilty and was sentenced by the Honorable Steven R. Herod of the 91st District Court.

MAN SENTENCED TO PRISON FOR POSSESSION OF CHEMICALS

David Glenn Vaughn, 46, formerly of Abilene, was sentenced to (15) fifteen years confinement in a Texas Department of Criminal Justice State Jail facility by 91st District Court Judge Steven Herod after entering a plea of guilty to the offense of Possession or Transport of Certain Chemicals with intent to Manufacture Controlled Substance.

Vaughn and two other men were arrested on April 11, 2008 by the Cisco Police Department during a traffic stop for speeding on N. Hwy 6 near Cisco Jr. College. A search of the vehicle in which Vaughn was a passenger, revealed chemicals and other items necessary in the manufacture of Methamphetamine inside Walmart plastic bags. Investigators from the Cisco Police Department were able to obtain video surveillance tapes from Walmart in Eastland depicting the men purchasing some of the items. The men were headed to a cabin at Lake Cisco to "cook" the Methamphetamine. District Attorney Russ Thomason stated, "Thanks to the Cisco Police Department and their thorough investigation, these men were not able to complete their "cook" or spread this poison in our county.'

MAN SENTENCED TO 25 YEARS FOR POSSESSION OF METH

Timothy Todd Gosnell, 44, formerly of San Angelo, was sentenced to (25) twenty-five years confinement in a Texas Department of Criminal Justice State Jail facility by 91st District Court Judge Steven Herod after entering a plea of guilty to the offense of Possession of a Controlled Substance - Methamphetamine, 4 grams or more but less than 200 grams. This offense is normally punishable as a Second Degree Felony with a maximum punishment of twenty years, but the Criminal District Attorney's Office enhanced the punishment range to that of a first degree felony utilizing a prior conviction of Gosnell. Fred Franklin of Brownwood represented Gosnell with Criminal District Attorney Russ Thomason prosecuting.

MAN SENTENCED TO PRISON FOR POSSESSION OF METH

Jerry Don Williams, 59, formerly of Abilene, was sentenced to (10) ten years confinement in a Texas Department of Criminal Justice State Jail facility by 91st District Court Judge Steven Herod after entering a plea of guilty to the offense of Possession of Methamphetamine, Less Than One Gram. This offense is normally punishable as a State Jail Felony with a maximum punishment of two years, but the Criminal District Attorney's Office enhanced the punishment range to that of a second degree felony utilizing two of William's prior convictions

PROBATION REVOCATION NETS MAN 15 MONTHS IN PRISON

Henrique Roberto Deleon, 51, formerly of Eastland, is now an inmate awaiting transfer to state prison to serve a (15) fifteen month sentence for the revocation of his probation stemming from a conviction in August 2008 for possession of two pounds of Marihuana. Deleon entered a plea of true to allegations by the Criminal District Attorney's Office that he had violated terms and conditions of his Community Supervision

We are told that Mike Snider spotted the fire. He called 911 and Durwood and Aletha Burgess, who ran over and started moving our horses and cattle. Scott and Nan Stacey showed up and moved equipment and loaded our things into vehicles in case the wind shifted toward the house.

We are told that at least 8 fire trucks with volunteer firefighters from Gorman, DeLeon, Sipe Springs and Ranger bravely fought the fire into the night. We are also told that Eastland County showed up with maintainers and plowed a firebreak around that 100 year-old house that has become so precious to us. We are overwhelmed by this support - especially because we weren't there and were helpless to do anything.

The fire took a lot of pasture, a few trees and a few calves but nothing more and we are so grateful. Without a bunch of brave and willing firefighters, I'm not sure we would have been so lucky.

I got an email recently listing the many reasons America is great. One of them was: "If your place catches fire a bunch of brave strangers will show up and risk their lives putting it out for you." I would add to that, in Gorman, Texas your friends will show up too.

Thank you to all of you brave firefighters, county employees and friends who came to the aid of a couple of new Texans. And to all of you we haven't heard about yet, thank you too. We are deeply grateful for all of you.



Eastland Co. Judge Reports On Wildfire

Cedar Mountain Fire - What has been named the Cedar Mountain Fire has been stopped. Once again, our Emergency Responders have stepped up and prevented what could have been a tragedy for 65+ homes.

The fire burned from north of Cisco to north of Morton Valley, a distance of about 14 miles west to east and about 4 miles wide. According to the Texas Forest Service. about 18,500 acres burned. With the high winds Thursday afternoon, no air support was available until Friday morning. This fire had to be fought the old way, on the ground with brush trucks, tankers, transport water trucks, graders and dozers. Each piece of apparatus had to be staffed and most of these people are volunteers, giving of their time and own resources to prevent tragedy.

Every fire department in Eastland County was at the scene. Many fire departments from outside our county responded as their own fires allowed them to do so. Food and water were provided for two days by volunteers and the Red Cross. Law enforcement got the word out to residents to evacuate. TX dot kep the highways closed for safety. The Texas Forest Service finally got spotter aircraft and helicopters on the scene early on Friday morning in addition to operating TFS dozers in countless areas for many hours. Hearing that rotor sound and seeing the water drops from the air will always be in my

Other state agencies, local businesses, and just people walking up to the Command Center were working to get us what we needed. The Mobile Command Center was sent to CR 331 and TX Hwy 112 where it became the emergency operations center (EOC) and home of the Responders and volunteers for the next two days. Fueling, water resupply, and food needs were met at the EOC. The EOC was also the forward communication point for radio traffic and fire assignments. Late Friday, the fire was contained and under control enough to demobilize the EOC and send the exhausted Responders home.


Saturday, a DPS aircraft took Eastland Fire Chief Arther into the sky to see if any hotspots were active. A fire was spotted near the canyons noth of CR 155 and fire fighters were able to get extinguished. With the good rain on Easter morning, no active fires were reported.

I talked to Heath Begeman, Texas AgriLife Extension Agent about the agriculture losses. He is working with state agencies on fencing repairs and hay resources to assist the 404 farms and ranches affected by this fire. Mr. Begeman can be contacted at 254-629-2222 if you have a need or want to help.

It is an enduring testimony to the emergency response groups that a fire of this size was not allowed to destroy even one home or take anyone's life. On firefighter from Rising Star was injured. He is still in the hospital with a hip injury and he will be there for a few more days; please keep him in your prayers.

I have life-long friends that live on CR 331, north of Hwy, 112. When I got to the EOC Thursday, I know that their home had been in the direct path of the fire after it jumped TX Hwy. 183. When the smoke cleared enough to drive, I went to the home expecting to see burning rubble. Instead, I saw where firefighters created a miracle at the perimeter of the yard and diverted the fire away from the house and barn. This scene was repeated many times as the fire traveled with incredible speed. Finally, if you want to show your appreciation for a job well done, just contact your local fire department, tell them thank you, and ask how you can help. Thankyou, Respectfully submitted.
