## Callahan/Eastland County **Arsonists Arrested**

Three Eastland County residents have been arrested and charged with arson in connection with recent wildfires that burned more than 260 acres and destroyed five structures in Eastland and Callahan Counties

Suspects Brian Freeman, 23. Christina Utley, 20. and Michael Thomas 24, have each been charged with five counts of arson and one count of organized criminal activity related to wildfires intentionally set in Eastland County on Sunday, March 23, 2009.

Freeman, Utley and Thomas were initially arrested for fighting and public intoxication. Suspicious items found in their vehicle by the Cisco Police Department led to an investigation and questioning by the Eastland County Sheriff's department, Cisco Police Department and Texas Forest Service (TFS) regarding deliberately-set wildfires in the area.

The three suspects remain in the Eastland County jail with bonds totaling \$87,500 while TFS and local fire departments still fight to suppress the 270-acre Callahan-Eastland Complex Fire that has been burning since Sunday afternoon.





# **Jury Convicts DWI Suspect**

Mace Gregory Gifford, 47, of Coppell, Texas was convicted of Driving While Intoxicated by a jury of six citizens in the Eastland County Court on Tuesday, March 17, 2009. The arrest was made in September 2008 by DPS Trooper Michael Orsini, after stopping Gifford for a speeding violation on Interstate 20. After approaching the driver, the Trooper smelled an odor of alcohol and began a DWI investigation that culminated in Gifford's an "expert witness" from Georgia, who testified that it was his opinion that Gifford was not intoxicated. The expert touted 29 years of experience as a peace officer and extensive field sobriety expertise.

Assistant Criminal District Attorney Bill Dowell was lead prosecutor assisted by co-counsel Sarah Adams. This was Dowell's first jury trial since returning to the Criminal District Attorney's Office this past November. Previously, Dowell had served nineteen years as an assistant before retiring in July

"It feels good to be back and get my feet wet again," he said, "There was a bit of pressure for me in this case because our office has a very successful conviction record for DWI offenses and I had not participated in a DWI trial in over five years." "I am proud of Trooper Orsini 's presentation of a professional case to the jury and that they gave him due respect in light of the "expert" who presented a "contrary" opinion. It is a pleasure to return to a community where citizens diligently serve as conscientious jurors."

The Honorable Rex Fields, Eastland County Judge, presided at the trial and set the punishment for Mr. Gifford.

Producers who have not already taken the necessary steps to become eligible for the Supplemental Revenue Assistance Program (SURE), Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish (ELAP), and the Tree Assistance Program (TAP) are required to complete the following steps by May 18, 2009:

- Pay a \$100 "buy-in" fee per crop. The maximum fee is \$300 per county, per producer, not. to exceed \$900 for multi-county producers.
- · In the case of each insurable crop, excluding grazing land, agree to obtain a policy or plan of insurance for the next insurance year for which crop insurance is available; coverage level should equal 70 percent or more of the yield at 100 percent of the price.
- · In the case of each noninsurable crop, agree to file the required paperwork and pay the applicable administrative NAP coverage fee by the applicable state application closing date for the next available year.

Producers who choose to "buy in" under this provision will be considered, for insured crops, to have obtained a policy or plan of insurance for the 2008 crop year at a level of coverage not to exceed 70 percent of the yield at 100 percent of the price. For noninsurable crops, producers will be considered to have a level of coverage equal to 70 percent of the yield. These levels of coverage will be used to calculate the 2008 SURE guarantee.

Producers who meet the definition of "Socially Disadvantaged, Limited Resource," or "Beginning Farmer or Rancher." are not required to pay the buy-in fee.

### Representative Keffer Files Bill


On March 5th, Representative Jim Keffer (R-Eastland) filed HB 2471 to emphasize rigor and relevance in our state's education system in a way that provides a quality education curriculum while meeting the diverese interests and aspirations of our student population.

Joined by Rep. Patrick Rose, Rep. Joe Deshotel, Rep. Alan Ritter and Rep. Lois Kolkhorst, and many interested Texas employers. Keffer announced that the bill provides capacity for career and technical education (CTE) course curriculum as part of the recommended degree plan along with recommended requirements for math, science, English, and social studies. This flexibility will ensure career and college readiness, help to reduce drop out rates, provide alignment with Texas employer needs now and in the future.

The bill also allows local school districts to develop CTE course curriculum that encompasses the state's requirements for math and science, awarding math and science credit to students demonstrating proficiency for those requirements while providing them real world skills development.

"School districts should have every incentive to work with institutions of higher education and employers to develop course curriculum that can be offered for dual credit articulation, utilization of public/private technology training centers, and other applied learning techniques," said Rep. Keffer. "We need to give students opportunities to engage in relevant, rigorous coursework that prepares them for additional learning opportunities, as well as, success in tomorrow's workforce"


# **Producer Meeting**


