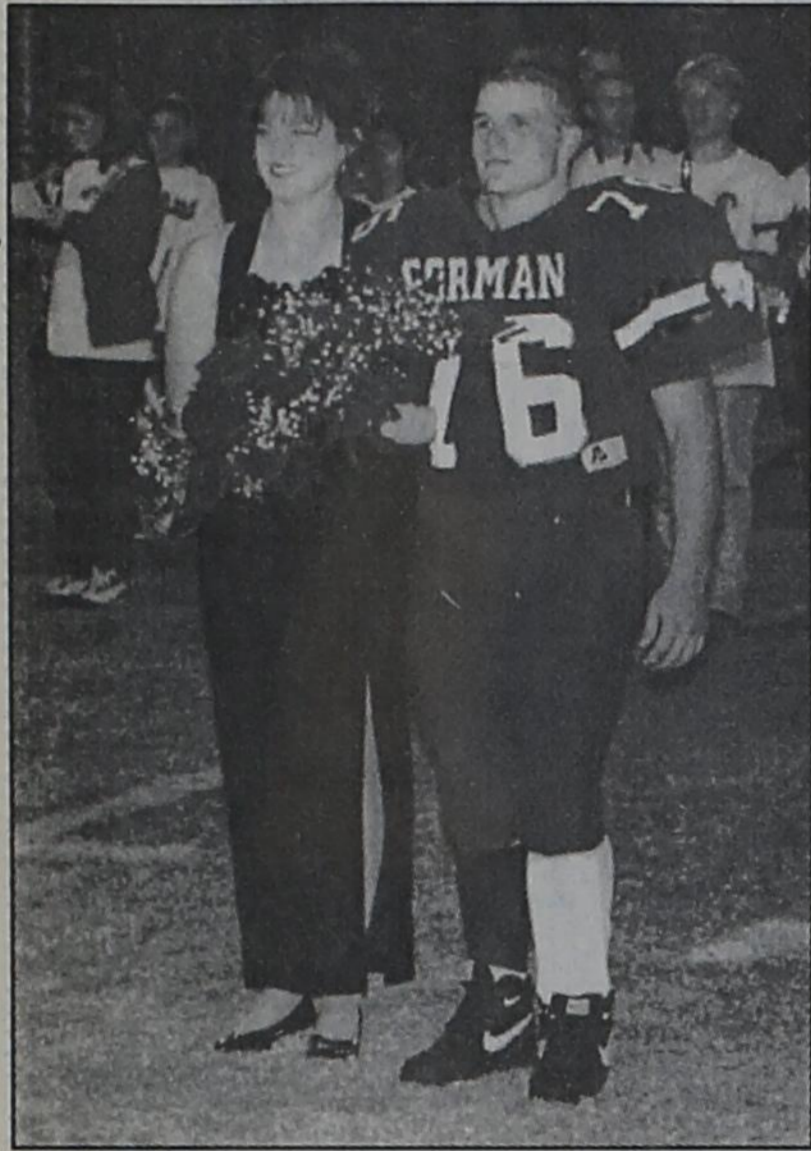

PANTHERS EDGE SANTA ANNA 35-34 IN OVERTIME GAME; TRAVEL TO BAIRD FRIDAY

The Panthers edged the Santa Anna Mountaineers in a thrilling game for the Homecoming crowd Friday night at Brogdon Field when they defeated the Mountaineers 35-34 in an overtime battle in the District 8A race. A point after kick by Shannon Mauney gave the Panthers the win.

Gorman took the opening kickoff on their own 38 and moved the distance in 9 plays with Margarito Sanchez getting the final 3 yards with 8:40 left in the first. The drive featured first down runs of 10 by Sanchez, 10 by Cody Foster, and an 11 yarder by Blake Guthery, and a beautiful pass play from Foster to Robert Seaton to set Gorman up at the Santa Anna 3 yard line. Sanchez ran it in. Shannon Mauney booted the point after and the score was 7-0.

Then with 2:48 left in the first the Mountaineers scored on a 13 yard run by Chris Boyet following a 3 yard loss on the first play. This score was set up when the Mountaineers recovered a fumble on the Gorman 10. Adam Garza kicked the point after to tie the score at 7-7.

Chris Boyet added another score for Santa Anna with 8:57 left in the half when he raced in from 45 yards out on a quarterback play up the middle. The drive also featured a 21 yarder to set Santa Anna up at the 45. Garza booted the point after and Santa Anna led 14-7.

With just 21 seconds left in the half the Panthers scored on a Cody Foster to Robert Seaton pass covering 8 yards, following the recovery of a Santa Anna fumble at the Santa Anna 34. The drive featured a great pass from Foster to Seaton for 26 yards. Then came the pass of 8 to Seaton for the score. The kick failed and the score was 14 to 13.

Both bands performed their routines that were to be performed at the UIL Band Contests. They did a great job. Also during the halftime intermission Samantha Stephens was named Homecoming Queen. Her escort was Shannon Mauney. Sonya Reagan was named Band Sweetheart. She was escorted by Clay Sandlin. Ruth Reeves was named Football Sweetheart. She was escorted by Reece Clark.

Following the halftime activities the two teams played on even terms until 5:28 of the fourth quarter. Gorman took the ball on their own 22 and went the distance in 9 plays with Robert Seaton again scoring for the Panthers on a 28 yard pass from Foster. The drive featured a 27 yard pass to Seaton, an 11 yard first down run by Sanchez and another 5 yard first by Sanchez to set Gorman up at the Santa Anna 31. Then after a 3 yard run, Seaton got the scoring pass. Cody Foster ran for the 2 pointer and Gorman was up 21-14.

On the ensuing kickoff Santa Anna got the ball on their own 40 yard line and score in just 3 plays with Shane Watson getting the score from 30 yards out with 4:01 left in the game. The kick failed and Gorman led 21-20. Santa Anna came back after holding the Panthers and moved 55 yards in 5 plays with Chris Guerrero catching a 29 yard pass from Watson with 1:13 left. Boyet ran for the 2 pointer and Santa Anna led 28-21.

But the Panthers were not to be denied this night as they took the ball on their own 38 and scored in 10 plays with Seaton again getting the honors on a 5 yard pass from Foster with no time left on the clock in regulation play. The drive featured passes of 13, 9 and 15 to Seaton, and an 18 yard hook and ladder pass to Seaton and Sanchez to

set Gorman up at the 8. Sanchez caught a 3 yard pass before Seaton got the score. Mauney kicked the point after to tie the game and send it into overtime.

In the overtime each team gets an opportunity to score starting on the 25 yard line. Santa Anna get the ball on the first series and scored in 3 plays with Josh Robertson getting the final 19 on a run. The kick for point failed when it hit the right upright and the score was 28-34.

Then the Panthers got their opportunity to win the game. The Big Red threw an incomplete pass on the first play, then Sanchez took the ball on a reverse type play that fooled the defense and raced into the end zone on a 25 yard run. Then came the winning point as Shannon Mauney kicked the point after through he uprights and won the game for Gorman.

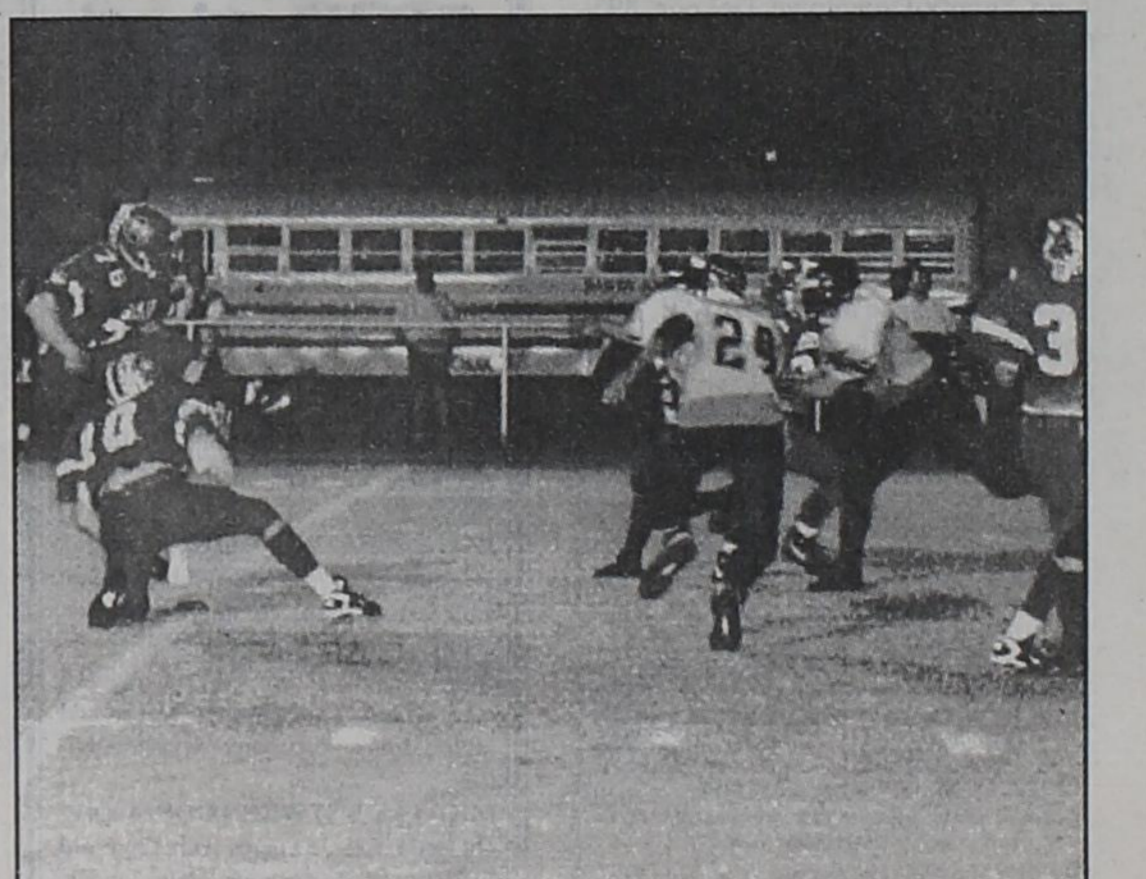
Sanchez led the Panthers on the ground with 134 yards on 27 carries. Blake Guthery had 56 on 14 trips. Clay Sandlin had 4 yards on 3 tries. Seaton and Foster highlighted the game with 7 completions for 3 touchdowns. The pair were elisted in the Honorable Mention bracket in the Reporter News on offense. Great job guys!!! Foster is 32 of 75 for 558 yards and 9 touchdowns. Seaton has 420 yards on 21 catches for 7 TD's.

Gorman will travel to Baird this Friday to meet the Bears in a crucial game in district. The Bears have a very good team and are always ready to play Gorman. The Panthers will really need a great game to put them in a good position to make the playoffs. They have Baird and Rising Star remaining on the schedule.

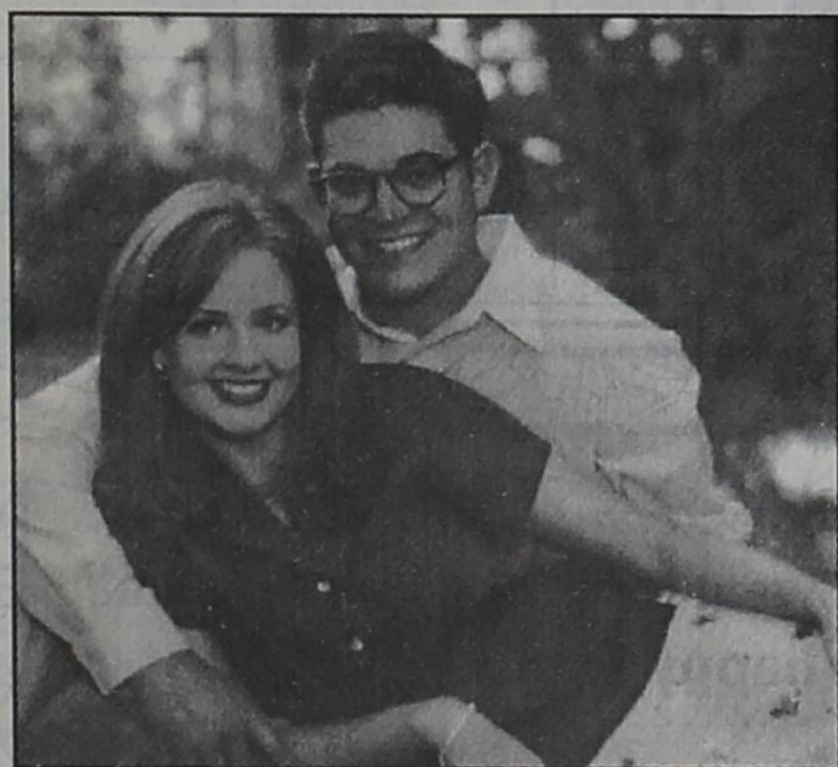

The City of Gorman held its regular Commissioners meeting October 16, 1997. Those present were Mayor Jack Simpson, who entered a few minutes late, Commissioners Johnny Smith, Kenneth Good, Robert Ervin and John Rice. Others present were Estelle Craddock, Joe Bennett, George Simmons, Paula Lewis and Linda

Norris. The meeting was called to order at 5:10 p.m.

Robert made a motion to approve the minutes with the correction of the fact that Kenneth was not present at the called meeting of Oct 3, 1997. They will make corrections. Kenneth made a second. Motion carried 3-0.

Robert made a motion to approve the bills for payment with a second from John. Motion carried 4-0.

John made a motion to turn the Old Fire Hall over to the Cub Scouts with

the understanding that if someone submitted an acceptable bid to tear out the walls to make it appropriate for storing equipment the City Commission will notify the Scouts with a 30 day notice. Kenneth made a second. Motion carried 4-0.

The street light issue was put into abeyance so further investigation could be done. Personnel will be discussed last.

No action was necessary on the backhoe. Verl just wanted to report that it needed to be serviced. Comanche Ford New Holland will pick up and deliver. Bobby Watts, Chief of Police, was present and expressed an interest for

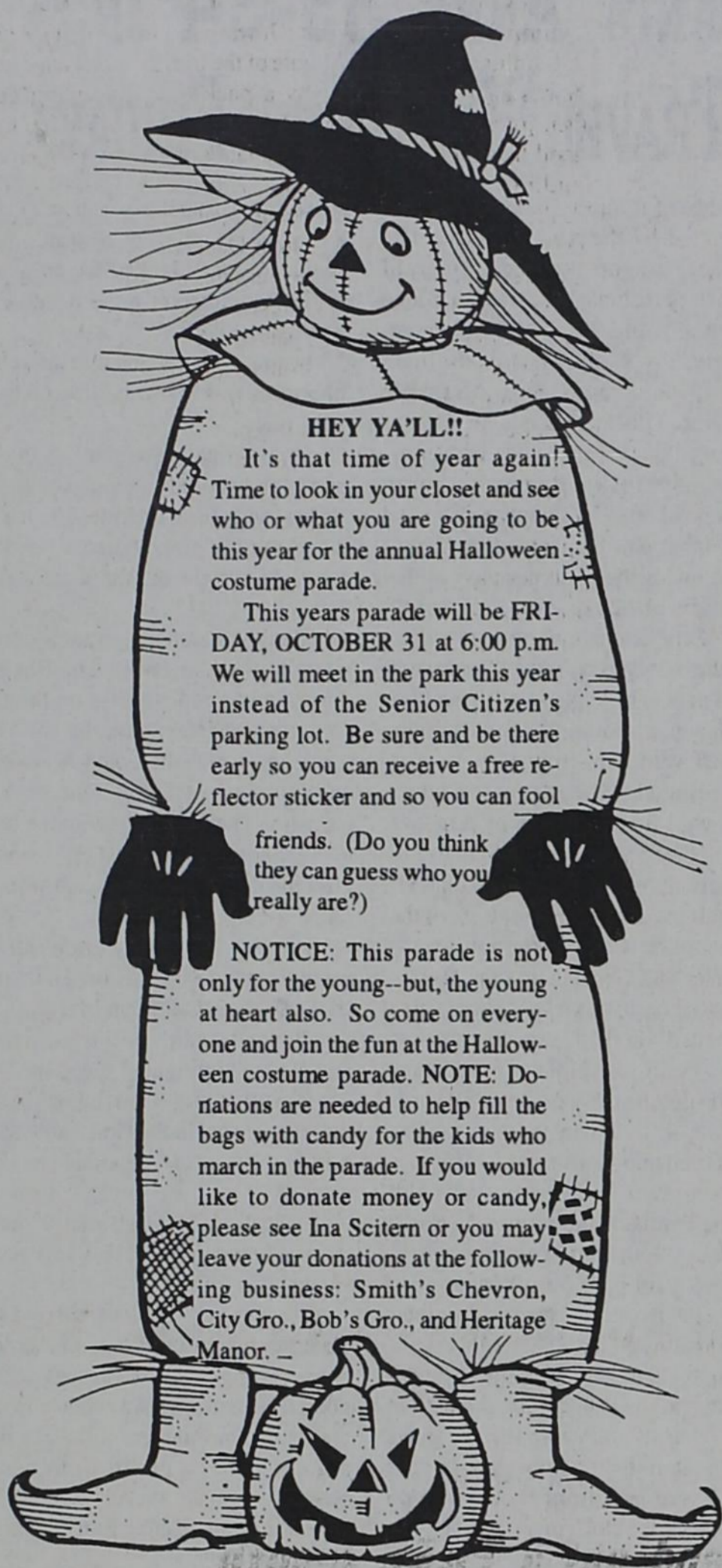

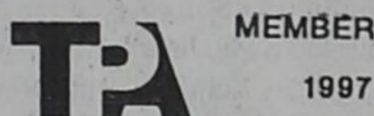

Have You Repented?

"Unless you repent, you will all likewise perish." (Luke 13:3)

Jesus places great importance on repentance--without it we are doomed to eternal destruction. Repentance is not simply feeling sorry for our sins nor merely admitting we have sinned or even confessing our sins to God. One can even quit a certain sin and be unrepentant. It goes beyond all this. A thief may feel sorry because he got caught. A drunkard may confess her sin to God and keep partying. An adulterer may stop cheating but still be enslaved to his lustful thoughts.

You have not repented if: you fail to return the stolen goods; You keep falling back into the same sin; You have forsaken some sins but justify others; You have failed to make public restitution. For instance, if you have stolen someone's husband or property, you have not repented until you acknowledge this as widely as there was public knowledge of your sin.

Repentance means to have a radical change of mind and actions and can only occur as the Holy Spirit is allowed to illumine the heart and liberate the will. Why? Because the human heart is deceitful and the will in bondage. Only God knows its true condition. Let me illustrate. As a student I once caught a substitute math teacher in an error. I called it to his attention. Refusing to recognize it he insisted the error was mine! There was no doubt that I was right. We argued for several minutes. Suddenly light flashed into my intellect and I saw that I was wrong! I was forced to humble myself, admit my error and silence my arguments. Yes, I was sincere--but proudly deceived.

And so it is with many people in our day. They proudly go on in their sin and unbelief. They deny God. His rightful place in their lives. They have convinced themselves that they are okay. Fortunately, others are coming out of darkness and heeding Christ's call to repentance. What about you?

CVC Program's use of technology and outreach second to none

The National Association for Victim Assistance (NOVA) presented its Tadini Bacigalupi Award for outstanding service to the Crime Victims' Compensation (CVC) Division at its 23rd annual conference held in Houston last August. At the NOVA national conference, victim advocates examine issues and exchange ideas in the rapidly growing victim justice movement. As part of the conference, the NOVA Board of Directors each year singles out individuals and programs which have made outstanding contributions in the field of victim assistance.

This year, the CVC division was recognized for its use of technology, outreach services, the swift processing of applications, and the drafting and support of critical legislation that has expanded benefits to crime victims and their relatives in Texas. NOVA leaders point out that our compensation division has the rare distinction of being the only state compensation program to be issued the award in the organization's 23-year history.

To say the least, I am very proud of the 67 people in my office who, day in and day out, dedicate

themselves to assisting victims of crime. The division today provides more assistance to more victims and their families than in any time in its history. In 1996 alone, an estimated \$30 million in benefits was provided to qualified applicants.

My congratulations also go out to the vast state network of victim service professionals who are dedicated to the movement and state leaders who are committed to continuously improving state laws that extend financial support to victims and their families. These individuals recognize that the rights of criminals should never take precedence over the rights of innocent people who are victims of violent crimes. CVC program continues to improve

Despite the accolades, the State's commitment toward improving services continues. Legislation recently approved by lawmakers now doubles the total amount a crime victim may receive from the program. The maximum that can be disbursed on a claim has increased

from \$25,000 to \$50,000. Compensation for catastrophic injuries has also doubled.

Other legislative provisions include reimbursement for lost wages and compensation for time missed from work. In addition, peace officers and firefighters injured while on duty during the commission of a crime are, for the first time, eligible to receive victim compensation under new crime victim legislation that became effective September 1, 1997.

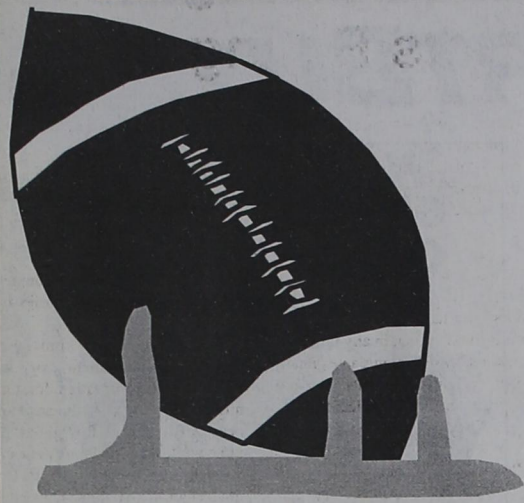
