



D.L. Cox, United States Naval Veteran of WWII, was the speaker for the annual Christmas Ball held at Highway 6 Cafe in DeLeon recently. Mr. Cox survived the torpedoed ship, Indianapolis four days before the way ended. He was in the salt water, covered with spilled oil, for 4 days and 5 nights before being rescued. He lost many of his buddies to shark attacks as he floated there with only a life preserver.

Mr. Cox is a member of the Sons of Confederate Veterans and received a Military Service Award from Thomas Harrison, commander of the 2nd Frontier District Sons of Confederate Veterans. Others receiving awards included Betty Leatherwood, Ladies Achievement Medal, the highest award to a lady that the SCV bestows; Stone Mountain Award was presented to SCV members, Ronnie Jennings and to Frank Bussey for their outstanding dedication and service to the SCV, OCR, and UDC activities.

In other activities Confederate bills were presented to Joyce Whitis, President of the Major George B. Erath UDC as best dressed lady; Cliff Weible, best dressed male; and Sharon and Cliff Weible, best dressed couple.

### **Gorman City Minutes** Unapproved

DECEMBER 2, 2010

The Gorman City Commission met on the above date. Those present were Mayor Robert Ervin, Commissioners Durward Webb, Nathan Files, Joe Casey, and David Stanley. Others present that included carpentry around the were Chief Fenley, Glenn Scitern, Cliffa Vaughn, and Jill Rainey.

Joe led the opening prayer, followed by the Pledge of Allegiance and the Texas Pledge. .

Mayor Ervin called the meeting to order @ 5:30 p.m.

David made the motion to approve the minutes, with one correction adding motion carried 4-0 on the motion to adjourn from Executive Session. Durward made a second, motion carried 4-0.

After looking over the bills, Joe made the motion to approve for payment with a second from Nathan. Motion carried 4-0.

Cliffa was present under Citizens In Put. She would like to have a meeting with the Building and Standards Commission as soon as possible.

Reports were submitted from department heads. Barbara clarified that her police report and the judges report would not reflect the same information. Joe brought up some questions about one of the daily log records. It was decided that the police daily logs would reflect dates with shift times on them, and a description of the events during that shift. (EX; ran traffic, patrolled. Checked doors, businesses, farmers and ranchers, and for our nation's economic recovery. Members of both parties answered call, etc.)

The commission wants the city crew to grease caps on all of the fire hydrants. Locations country no longer have to worry about a massive tax hike next year. As President Obama signs this were noted for the next fire hydrant replacements.


