

INTERNATIONAL TRADE AND GROUNDWATER RIGHTS HEADLINE 2010 TSCRA SUMMER MEETING

Meeting is a must for anyone with a vested interest

in the cattle business or rural Texas

Cattle producers from across Texas and Oklahoma will gather June 16-18 in Grapevine, Texas, for the 2010 Texas and Southwestern Cattle Raisers Association (TSCRA) Summer Meeting. The meeting will feature educational sessions and speakers on a variety of topics that affect cattle producers and rural Texans.

Phil Seng, president and chief executive officer of the U.S. Meat Export Federation (USMEF), will speak at the general session Friday, June 18. Seng will review the international beef market and the status of efforts to open new markets and re-open or expand existing markets, especially Europe, Japan and Korea. Seng will also report on the efforts by the USMEF to promote beef in those markets.

Jason Skaggs, TSCRA executive director of government and public affairs, will discuss the current battle over groundwater rights in Texas and what landowners can do to join the efforts to reaffirm groundwater as a vested, private property right.

Educational sessions, hosted by TSCRA's committees, begin Thursday, June 17, and will cover a variety of topics ranging from new feral hog research and state animal ID regulations to next year's redistricting process and how that will affect rural Texans.

ORDINANCE NO. 2010-02

AN ORDINANCE OF THE CITY OF GORMAN, TEX AS ADOPTING THE BUDGET FOR THE CITY OF GORMAN TEXAS, FOR THE FISCAL YEAR BEGINNING JUNE 1, 2010 AND ENDING MAY 31, 2011, PROVIDING FOR THE INTRA AND INTER DEPARTMENT AND FUND TRANSFERS; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, notice of a public hearing on the budget for the City of Gorman, Texas for the year June 1, 2010- May 31, 2011 has heretofore been published in accordance with the law; and,

WHEREAS, a public hearing was duly held at the time and place as provided for in the notice of such public hearing and all interested persons were given opportunities to be heard on said

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GORMAN, TEXAS AS FOL

SECTION 1: That the budget presented by the City Secretary and reviewed during the public hearing is hereby approved and adopted for the fiscal year 2010 - 2011

SECTION2: That the City Secretary can be authorized to make intra and inter department fund transfers during the fiscal year as becomes necessary in order to avoid over expenditure of a particular account only when such authorization is given during a commission meeting.

SECTION 3: This ordinance shall take effect and shall be in full force and effect from and after its passage



Shop for Appliances This Weekend During ENERGY STAR® Sales Tax Holiday

This Memorial Day weekend's third-annual ENERGY STAR® Sales Tax Holiday is a great time for Texans to purchase a new, energy efficient air conditioner, refrigerator, dishwasher or other major appliance. During the three-day tax holiday, running May 29 – 31, shoppers do not have to pay state and local sales and use taxes on certain energy efficient products.

"If you've had your eye on a new appliance, or just want to stock up on light bulbs, you can save money by shopping this weekend," said Texas Comptroller Susan Combs. "We expect Texans to save about \$3 million overall in state and local sales taxes during this weekend's event."

The tax holiday begins at 12:01 a.m. on Saturday, May 29, and ends at 11:59 p.m. on Monday, May 31. The tax holiday applies only to the following appliances and household equipment bearing an ENERGY STAR label: air conditioners priced less than \$6,000, refrigerators priced less than \$2,000, ceiling fans, incandescent and fluorescent light bulbs, clothes washers, dishwashers, dehumidifiers and programmable thermostats, along with installation and delivery charges for these products.

Starting June 1st, Citations Will Be Issued Under New Texas Booster Seat Law

THE GORMAN PROGRESS

There has been some confusion about a new state law that requires all children younger than eight (8) years old, UNLESS taller than 4'9" to be in child passenger safety seat system. ("Child passenger safety seat system" includes traditional car seats with harnesses AND booster seats – both high-back and backless versions.)

The law also requires all safety seats and booster seats to be installed according to the instructions of the manufacturer of the safety seat system.

Because of the changes of the wording in the law (SB61), the following legal interpretation should be applied:

1. Once a child reaches eight (8) years old, they are not legally required to be in a child safety seat system.

2. If the child is younger than eight years old, BUT they are already 4'9" tall, they are not legally required to be in a child safety seat system.

3. If a child is eight years old or older, and not yet 4'9" tall, they are not legally required to be in a child safety seat system.

The law also requires that safety and booster seats be installed and used according to the manufacturer's instructions, including age, height and weight requirements and the placement in the vehicle. (Some manufacturers prohibit using their products on the front seats of vehicles.)

The other part of the law that may cause some confusion are the dates of when the law takes effect and when the enforcement phase begins.

The law will take effect September 1, 2009. Law enforcement officers may only enforce the new changes in the law with written or verbal warnings until June 1, 2010.

However, beginning on June 1, 2010, officers may then arrest or issue a citation/notice to appear to a person committing an offense. Also, please remember that starting Monday, May 24th through the Memorial Day weekend, Texas will be enforcing seatbelt and current child passenger safety laws during the Click it or Ticket campaign. Even though this new booster seat law want get you a ticket until June 1st, you can still be issued a ticket for unsecured child. This means, that if your child is required to be in a child safety seat or seat belt currently, they should be in them.

A fine of not more than \$25 can be assessed for a first offense and no more than \$250 for the second or subsequent offenses.

Vehicle manufacturers design their products for adults – not kids – and they support keeping kids in the appropriate safety or booster seat until the child can properly wear the adult safety belt... typically when they reach 4'9" tall.

Once your child has reached eight years old, to know when they can wear an adult seat belt properly without a booster seat, use this simple test:

Have your child sit on the vehicle seat, sitting all the way back, with their back straight against the back of the seat, and buckle the lap/shoulder belt over them.

1. Do their legs bend naturally at the knees over the edge of the seat?

2. Does the lap portion of the belt fit low over the hips and top of their thighs?

3. Does the shoulder portion of the belt fit across the center of their chest?

If the answer to any of these three questions is no, the child may be better protected in a booster seat.

A child in a poorly-fitting adult seat belt usually slumps down, allowing the seat belt to ride up into their abdomen or neck, which can cause severe injuries to the child's neck and internal organs during a car crash.

Although there is no law that prevents youngsters from sitting in the front seat of a vehicle, the safest place for a child in a car is in a rear seat, properly buckled into a child safety seat or a booster seat.

Air bags don't replace child safety seats and may increase the risk of serious injury to children. Children younger than 13 should never ride in the front seats of vehicles with active passenger air bags. If you do have to transport a child in the front seat in an emergency – make sure the front seat is moved all the way back on the track, placing as much room as possible between the deployment zone of the air bag and the vehicle seat...but NEVER place a rear-facing safety seat on a front seat.

A final, but very important note: please read and follow the instructions in both the safety /booster seat owner's manual AND the vehicle owner's manual. Not all safety or booster seats fit the same in all vehicles – so you may have to try several before finding a good fit for your child and vehicle.






