Panthers Edged By Menard; Go To Santo On Friday

The Gorman Panthers traveled to Menard on Friday night and had a bad night with 2 intercepted pass tries and 1 fumble and it sure hindered their offensive output. They were up 7-0 in the second quarter and 14-12 at the end of the second but failed to score in the second half and came out on the low end of a 23 to 14 score.

The Panthers played the Yellowjackets on even terms on the first possession, but were hurt by an interception. They got a break on an interception of a Jacket pass try and took the ball on the Jacket 28. They scored in 8 plays with Brandon Velasquez getting the honors of a 4 yard run with 6:25 left in the second. Flanary then booted the extra point for a 7-0 lead. The drive featured runs of 1, 7, 4 and 11 by B. J. Ramirez and runs of 3 and 2 by Matt Fox

The Jackets came right back following the kickoff and moved 65 yards in 8 plays with Jonathan Burgess scoring from 17 yards out with 2:16 left in the second. The kick try for points failed and the score was 7-6.

However the Panthers fumbled the following kickoff and the Jackets got the ball on the Gorman 37. They scored in 5 plays with Eliott Jones catching a 25 yard pass for the score with 1:03 left in the half. The run for 2 points failed and the Jackets had a 12-7 lead.

However, the Big Red came back on a drive of their own going the distance in 5 plays with B. J. Ramirez getting the final 7 yards on a run as time ran out in the first half. The drive featured a beautiful 54 yard run and a 5 yard run by B. J. Flanary booted the extra point and Gorman had a 14-12 lead at halftime.

The Panther Marching Band performed a nice routine at intermission and the Jackets had their Homecoming Activities.


The Jackets came back on their first possession following halftime and drove 68 yards in 9 plays with Grey Wagoner getting the final yard on a keeper play with 5:40 left in the third. Wagoner then added the 2 pointer on a run to make the score 20 to 14.

The Panthers then had a good drive on their next possession before having an interception by the Jackets on their own 26 and scored in 18 plays with their kicker booting a 28 yard field goal with 2:19 left in the game to up the score to 23-14. Ramirez led the Panthers with 170 yards on 17 carries. Velasquez got 42 yards on 7 tries. Flanary had 18 on


3 keepers and Matt Fox had a minus 2 on 5 tries. Wagoner led the Jackets with 95 on 15 keeper plays.

What good is food other than to feed the body and what good is Oxygen other than to fill our lungs? Food and air has no value other than to sustain our earthly bodies. State Grants for Renewable Energy Available to Rural Communities

AUSTIN-The Texas Department of Rural Affairs (TDRA) is offering grants through two programs that help rural communities use renewable energy to cut energy costs and develop new sources of drinking water.

The agency anticipates having up to \$681,500 available through its Renewable Energy Demonstration Pilot Program (REDPP). Priority for these grants is given to projects that use wind power or solar power to help provide electricity for water treatment or wastewater treatment plants.

TDRA also anticipates having up to \$3 million available in its Desalination Fund for projects that use wind power for desalination of brackish groundwater.

YELLOW PECAN APHIDS

The yellow pecan aphid occurs later in the season. Outbreaks of this species can cause defoliation and reduce yield and quality on most cultivars. Both species of yellow aphids have piercing sucking mouthparts for removing water and plant nutrients from leaf veins. As they feed, aphids excrete large amounts of excess sugars. This sticky material, called honeydew, collects

Honeydew serves as a food source for sooty mold, which can cover leaves when humidity is high. The shading effect of sooty mold can reduce photosynthesis. Studies have also shown that aphid feeding can reduce leaf efficiency; large, persistent infestations of the yellow pecan aphid, M. pecans, can defoliate trees. This leaf injury and loss can reduce current and subsequent yields and quality because of lower carbohydrate production. Yellow aphid eggs survive the winter hidden in bark crevices on twigs and tree trunks. Immature aphids, called nymphs, hatch from eggs in spring and begin to feed on newly expanded leaves. Nymphs mature in about a week and give birth to live young. All individuals are females that reproduce without males during spring and summer. In late September and October, males and females develop, and females deposit overwintering eggs.

Consider treatment when infestations of yellow pecan aphid exceed 25 per compound leaf, indicating the onset of an outbreak. Scouting the orchard on a 4- to 5-day schedule will determine if yellow pecan aphid numbers are increasing or decreasing and indicate the need for insecticide treatment. Do not base the need for treatment on the amount of honeydew alone, as infestations often decline rapidly ("crash") because of weather or physiological ef-

Insecticides do not consistently control either species of yellow aphids. Aphids may become tolerant to an insecticide used frequently in an orchard. An insecticide that is effective in one orchard may be ineffective in a nearby orchard. Studies have shown that in some cases, applications of pyrethroid insecticides (Asana , Ammo , Cymbush) to control casebearers or aphids may be followed by large increases in yellow aphids.

Adoption Schedule

Adopters must have a minimum 400 square foot per animal with access to shelter. A 6-foot fence is required for adult horses and a 5-foot tall fence for yearlings. All horses must be loaded in covered stock-type trailers with swing gates and sturdy walls and floors. BLM staff will be on hand to assist adopters through the short application process, to answer any questions, and load horses.

Adoption Fees

The minimum adoption fee is \$125 for un-trained animals and \$400 for trained horses. We accept cash, check, and all major credit cards.

\$500 Adoption Incentive

An adoption incentive program in which BLM pays a \$500 care and feeding allowance to adopters of horses 4 years and older. Younger or trained horses are not eligible for this incentive. The allowance is paid in full after one year when adopters receive official ownership title for their horse(s). All standard adoption conditions and fees apply. A limited number of eligible horses will be available for this incentive.

Wild horses - iconic symbols of America's western heritage - are renowned for their strength, endurance, agility and intelligence, characteristics bred into them in the wild make them ideal for work or recreation. Since 1973, the BLM has placed more than 220,000 of these "living legends" in approved homes across the country. The BLM periodically removes excess horses from the range to maintain healthy herds and to protect other rangeland resources. The adoption program is essential for achieving these important management goals.

Can Do With Canned Foods

According to research, the amount of time spent preparing meals at home continues to decline. Convenience is in high demand and, as a result, the number of meals we are eating out continues to rise. At the same time, however, people are becoming more interested in nutrition and the foods they eat. Is it possible to have convenience and nutrition in the kitchen? Yes, with a little planning, a variety of meals, snacks, and desserts can be prepared with canned foods that most of us already have at home.

The Canned Food Alliance consortium (http://www.mealtime.org/recipes/) Has developed hundreds of recipes, including Quick Goulash (see below) that can be made from canned foods. But how nutritious are meals prepared with canned ingredients? Researchers at the University of Illinois examined the nutritional composition of selected canned fruits, vegetables, legumes, poultry and fish. There results demonstrated that those foods were nutritionally equal and sometimes superior to the nutritional value found in the fresh and frozen varieties.

Nutrition is just one reason to give canned foods a second look. Other reasons include variety and quality. According to the Canned Food Alliance, there are more than 1500 different foods available in canned form. The high quality of canned foods, including legumes, fruits and vegetables, makes them a perfect substitute when fresh produce is not available or is too expensive.

Convenience is also another reason to use canned foods. For many canned foods, all you have to do is open, heat and eat. It really does not get much easier than that. Food safety rules still apply when using canned foods. When shopping, buy canned foods that are not dented especially if the dent is on the seam. If a canned food is leaking or if the ends are bulged, do not use it. Instead, return the unopened can to the place of purchase. After opening, refrigerate uneaten portions of canned foods immediately in a covered container. Remember, being thrifty should never come before food safety. Quick Goulash (Serves 6)

2 pounds ground beef 2 Tablespoons chili powder

2 teaspoons salt ½ teaspoon pepper

½ cup onion, chopped 1 green pepper, chopped

1 can (28 ounces) whole tomatoes 1 can (8 ounces) mushrooms, drained 1 can (15 ounces) tomato puree 1 pound elbow macaroni (cooked)

Preparation: Wash your hands. Make sure your cooking area is clean. Cook macaroni according to package instructions. In a large skillet, brown the ground beef along with chili powder, salt, pepper, green pepper and onion. Add tomatoes, mushrooms and puree, simmer for 3 minutes. Add the cooked macaroni and mix well. Preparation Time: 5 minutes Cook Time: 15 minutes

Are Your Kids Savvy About Internet Safety?

(NU) - The Internet is an important educational tool. With a click of a mouse, kids can find information on just about anything. Unfortunately, children who don't practice basic Internet safety may expose themselves and their parents to certain risks.

Children can easily stumble upon inappropriate content. Chat rooms have a reputation for encouraging Internet predation, but pedophiles can stalk victims from Web sites like Facebook as well. Many kids don't realize that anyone can read what they write on the Internet, so they post home phone numbers, addresses, their full names or the names of their schools.

Social networking sites may also expose children to bullying, as peers can send demeaning emails, instant messaging and text messages without attracting attention from parents or teachers. Finally, children may download pirated music or movies, or even computer viruses or spyware.

'The Internet is an important resource for kids, if they know how to use it," says John Goslin, chief technology officer of Boys & Girls Clubs of America (BGCA), a non-profit organization that strives to help young people realize their potential. Parents need to be aware of the potential dangers and create guidelines to help kids avoid

them.' CA Technologies, which serves as the BGCA's national information technology security partner through its global philanthropy program, CA Together IT, helps keep 56,000 BGCA computers secure. It starts off with se-

curity software, including antivirus, anti-spam and anti-spyware technology, and prevention measures that restrict unauthorized

"Software can help prevent viruses, spyware and inappropriate spam messages, and allow parents to monitor and help protect their children online," says George Kafkarkou, general manager of CA Technologies. "But parental supervision is the best security measure available to

Parents should know where their children go online and with whom they communicate. Placing computers in a family room can help you keep an eye on their activities. Parents should instruct children not to give out personal information online, even on sites like Facebook, and ask children to come to them if they encounter anything that makes them nervous or uncomfortable.

Tips to Help Kids Avoid the **Pitfalls of Sugary Snacks**

(NU) - Sugar can be difficult to pass up, especially when you're a kid. Today's children are regularly subjected to sugary diets and uninformed eating habits. Although, parents may not be giving their children foods that are high in sugar intentionally, there are steps that can be taken to help kids avoid the pitfalls of sugar, such as obesity and dental disease.

· Monitor snacking choices. Ration empty-calorie foods such as sugar-packed sweets. Instead, offer healthy alternative snacks such as fresh vegetables and fruits and low-fat yogurt with no added

 Beware of the juice box. Most fruit drinks are low in vitamins and high in sugar. And many contain less than 10 percent real fruit juice. Look for low- or no-sugar substitutes or provide water when kids are thirsty.

Use oral care probiotics. Sugars are going to find their way into young mouths eventually. In addition to regular brushing and flossing, incorporate an oral care probiotic, like EvoraKids (www.myevorakids.com) into their oral health routine. Oral care probiotics work by flooding the mouth with beneficial bacteria, which adhere to tooth surfaces, including pits and fissures in the chewing surfaces, leaving less room for the harmful bacteria that

feed on sugars to grow. Involve children in meal-time planning and prep. Take advan-

tage of meal preparation to help your child understand the importance of good food choices. Including them in the preparation process can be an important step for children who take more interest in hands-on activities.

 Keep a positive attitude. When your child makes healthy food choices, recognize his accomplishment. Be consistent with verbal praise and rewards when they make good choices. As is the case with many children, behavior is often repeated when there is a positive response.

 Be a role model. Probably the most important step is to practice what you preach. Most children learn by watching their parents. When you try to teach a child good behavior, incorporate these same principals into your own everyday actions. Words that conflict with your actions can be confusing to developing minds.


