Letter To The Editor

My name is Truman (Buz) Brown Jr. I graduated from Gorman High School, although I do not live there any longer. I remember, even back then, that if a member of your family passed and the funeral was at a church or funeral home in town, th...e funeral procession was provided an escort as a show of respect and safety for the family of the deceased. I cannot remember a single time that this did not happen. An escort was provided for my Grandfather, Grandmother, Uncle James, his son Jimmy, and many friends that also passed. On that note, I would like to bring attention to my family's recent situation.

My uncle "Corkey" John T. Brown passed. The funeral was Saturday November 17, 2012. Corky was born in Gorman, ran businesses in Gorman, lived, raised his family and finally died in Gorman. If anyone should have had a Police escort, you would think that he, at the very least would have qualified. The family was apparently told that providing this escort would cut into overtime pay and the request was denied. Who are your Law enforcement officers and how long have they lived and worked in Gorman? I may be wrong about this, but I would bet they did not live there most of their lives and I would also bet that when they pass, they will surely have a Police escort for them.

Now I do not wish to come down on the whole department, because it may be that the deputies did not know that the person, (who owns this poor decision), was even asked about it or had denied it. The trip from Higginbothams Funeral Home lasted about 15 minutes. I was raised to have respect for the funeral procession, even to pull over while they pass by. I guess money has become more important than good manners, good sense and safety. It truly would have been nice for the family to see this respect extended even if it cut into overtime pay. I know that the crime rate in Gorman is not that bad, although it does exist. I am suspicious that he was not exactly run over in the biggest crime wave ever to hit town on a Saturday morning. If I had found out in time I would have paid for, this minor but necessary service myself. My family and I are very disappointed in the decision that was made not to provide the escort. I guess the next time you see an escort for a funeral in your town, you might ask yourself, IS THAT CUTTING INTO OVERTIME PAY?! Now that sounds pretty sad, when you say it out loud doesn't it?

I would like to thank Corky's grandsons for providing the escort and stopping traffic on the highway while the procession passed. It probably would have been safer with the flashing lights on the police car. (Although, I know Corkey would have been very proud.)

One Person Killed and One Injured **In Fatal Crash Tuesday Night**

One person was killed and one was injured in a one vehcile crash three miles east of Gorman, in Eastland County. The crash occurred Tuesday at 6:00 p.m. on Farm Road 8 and is being investigated by the Texas Department of Public Safety (DPS).

Thomas Roy Seay (deceased) W/M 66 years of age from Gorman, was driving a 2004 Chevrolet Trail Blazer eastbound on Farm Road 8 when he drifted off of the roadway to the right. Seay overcorrected to the left and entered the north barrow ditch. The vehicle overturned several times, ejecting both occupants. Judge Walker pronounced Seay dead at the scene. The body was taken to Higginbotham Funeral Home in Gorman. The seat belt was not worn. The next of kin have been notified.

Vicki Trout Seay (injured) W/F 64 years of age from Gorman is listed in critical condition and was taken to Farris Hospital in Fort Worth. The seat belt was not worn.

The weather was clear and the roadway was dry. Texas Highway Patrol Trooper Russel Reid is investigating this crash.








COMANCHE ELECTRIC COOPERATIVE ANNOUNCES \$4,000 YOUTH VIDEO CONTEST

Comanche Electric Cooperative, in conjunction with Texas Co-op Power magazine, announces the launch of the 2013 Co-op Teens Power Texas video contest. For the fourth consecutive year, Comanche Electric Cooperative and Texas Co-op Power will award up to \$4,000 in cash prizes for winners of the competition.

Students in grades 6 through 12 whose parents or legal guardians are current members of an electric cooperative in Texas can participate. This year, students are asked to create a five to 10 minute video interviewing someone who remembers the era when the lights came on, when electricity first came to their home. The video will serve as an oral history of the time before the interviewee received electricity and how life was changed afterwards. All videos have the potential to be included in a full-length documentary to be produced by Texas Co-op Power at a later date.

The grand prizewinner will receive \$1,500 and be profiled in Texas Co-op Power magazine. If a school is involved as a sponsor of the first-place winner it will receive \$1,000. The second-place winner, determined by the most YouTube views, will receive \$500. Four runners-up will each receive \$250 for best performance in one of four judging categories: creativity, educational value, video editing and technical quality.

The contest opens November 1 and ends April 1. Winners will be announced April 23.

The only thing a family should put in the paper after a funeral is the Thank You notice. Instead, the family of Corkey Brown has been forced to write a Letter to the Editor. We are writing this letter in regards to the actions of an officer of the Gorman Police Department on Saturday, November 17, 2012. We were told to be at the funeral home ready to be escorted to the church. When we arrived at the funeral home, about 10-15 minutes before the service was to begin, we were told that we would NOT have a police escort from the funeral home to the Church of Christ. There would be no one to stop traffic for us on our way to the church. This is probably less than a half mile. We might have had 10 cars in the procession. The total time might have been 15 minutes. When we asked why we would not be getting an escort, it was relayed to us that after calls to dispatch requesting the escort, the officer on duty called the funeral home and said he would NOT be there for THAT funeral...it was not approved and this would be overtime; the department was over budget... Hummm so I wonder...was this the same reason, that the same officer would have used in assisting a vehicle. At about 10:15 a.m.that same morning, the same police officer who refused to do the escort for the family did not stop and assist my son and his pregnant wife who were having vehicle issues on Highway 6. After all, he passed them twice; once as they pulled off the highway, with hazard lights on and again when they got out of the vehicle. My son told me the officer passed them twice but never stopped to see if they needed help. Would that have been overtime too? Is assisting a vehicle not approved as well? Was it because they were not in the officers's jurisdiction? If that's so, then why was the officer outside the city limits? What has happened to "PROTECT and SERVE"? The Brown family has been slapped in the face by the Gorman Police department. We have been made to feel we are not worthy of their time. Never in our lives have We ever known this to happen to anybody in this town or any other town for that matter. This is a disgrace to our town and our community. Wonder what the people who were stopped thought about our town when two U.S.ARMY soldiers were stopping traffic rather than a police officer and patrol car with lights on. What about the safety of those two soldiers? They were released to attend their grandfather's funeral NOT to do the job of the Gorman police officer. Something as simple as an escort or to block traffic for the family of a deceased person, should never ever be a question, it should never need an approval...it should be done out of respect and just common courtesy shown to the family. Our questions are: Does it matter if it is a memorial or does the hearse make it a funeral? Who makes these decisions? Is it many people or is the decision of one or two people? Is it councilmen or one councilman? How do they choose who gets escorted for funerals and who doesn't? Do approvals have to be made for our athletes from the school to be escorted out of town when they are in the playoffs? How about an ambulance coming to pick up a sick or injured person? This has hurt us deeply. If and when this is read by city councilmen and members of the police department it may mean nothing to them. They may even have a good laugh. To some this may be trivial, but to us it was about a wonderful dad, a great husband, a terrific Paw Paw and a man that loved his family and the people of Gorman. Dad always said, "The decisions you make, good or bad, will affect you the rest of your life." We made the decision to let others know how we have been treated. What's done is done and nothing can change that. We hope and pray that this never happens to another family in the future.




Rules for County Pecan Show Exhibition:



Spicing up Cold-Weather Desserts With Spirits

(NU) - Talk about a dessert that hits the spot - especially as the weather turns chillier.

You've heard of "pairing," right? Well, in shaking up the concept's traditional definition matching wines to dishes they most complement - innovative chefs are now using spirits like cognac to create even more tempting culinary experiences.

Cognac's spicy and aromatic characteristics have always made for perfect drinking this time of year. But when Camus VS Elegance cognac (www.camus.fr) specifically is used as one of two "surprise ingredients" in this recipe for Coconut Snowballs, well, now you've got something really spe-

"Camus pairs well with the creaminess of the coconut and actually enhances its flavor and the overall fruitiness of the dessert," Joshua Gripper, the executive pastry chef at the trendy W Hotel and Resort in Miami Beach, Florida, says of his creation, which he likes to serve after duck. "It gives a nice flow to the senses, and can also be enjoyed while sipping a Camus VS cognac on the rocks.

Oh, the other surprise ingredient? Ladyfingers, which - covered over as they are by the coconut add their own "hidden dimension, flavor and texture."

Coconut Snowball

Servings: Makes I snowball

Custard ingredients: 1 1/4 cups coconut milk 2 1/2 tablespoons sugar

2 egg yolks Combine all the ingredients in a small pot, stirring until the sugar is dissolved. Cook on mediumlow heat while stirring constantly until the custard thickens slightly.

Mousse ingredients: 2 cups heavy cream (whipped)

14 ounces white chocolate 1 ounce Camus cognac

2 gelatin sheets

Whip the heavy cream with a whisk until it forms medium-stiff peaks. Melt the white chocolate over a double boiler. Soak the gelatin sheets in ice water until it's softened (5 minutes), and strain the gelatin to remove any excess liquid. 1 tablespoon olive oil (garnish) Combine 4 ounces of pineapple juice with I ounce of Camus cognac. Cut 3 ladyfingers in half and dip quickly in the pineapple juice. Using a 4-ounce scoop, position the mousse onto a sheet of parchment paper. Place the ladyfingers in the middle of the mousse. Place the mousse in the freezer for 30 minutes (or until

When the mousse is firm but pliable, roll it into a ball, and coat it in shredded coconut. Place the snowball in the refrigerator and start the final plating - positioning the snowball in the middle of an attractive plate or bowl, garnishing the dish with diced pineapple, cilantro leaves, coconut milk and a little olive oil.

Violence in the Middle East

Within the past week, Palestinian militants fired missiles at Israeli targets and Israel has responded with strikes of its own in parts of the Gaza Strip. A missile attack on Jerusalem on Friday marks the first attack on the holy city in decades. I pray for the victims of these attacks and for a peaceful resolution to the crisis. I continue to stand firmly by Israel as it works to promote and secure democratic values in a region ravaged by violence and political unrest. Congratulations to the 7th Operations Support Squadron (OSS) at Dyess Air Force Base for being recognized at the Global Strike Challenge, an annual security forces competition with units participating from Air Force Global Strike Command, Air Combat Command, Air Force Material Command, Air Force Reserve Command and the Air National Guard. The 7th OSS was recognized as the best B-1B squadron for the third consecutive year. The 7th Bomb Wing as a whole was recognized as the runner-up for the overall best bomb wing. I'm proud of the men and women at Dyess, who have committed themselves to protecting the freedoms Americans are blessed to enjoy.

Report on Missing Customer Funds from MF Global

Last week, my staff on the Financial Services Committee released the results of a year-long investigation into the collapse of MF Global. When the firm went bankrupt last year, \$1.6 billion in customer funds were lost. And while MF Global served about 36,000 customers, some of those clients represented farm co-ops that were comprised of thousands of individuals. Its impact was devastating to rural America. After an exhaustive review, we determined that MF Global's CEO Jon Corzine put customer funds at risk and caused the company's bankruptcy. We also found that there was a breakdown in communication between the government regulators responsible for monitoring MF Global's activities. That lack of coordination, combined with the fact that MF Global was not straightforward with the public about the risks it was taking, meant that no one had a complete picture of MF Global's health.

My goal with this report was not only to give customers answers about what went wrong, but also to prevent something like this from ever happening again. To this end, we propose a number of potential solutions, including improving coordination between regulators to make it easier to identify potential problems with financial firms. I'll keep working to ensure strong, healthy financial markets so customers can invest with confidence.
