DANIEL KEEPING WINS THE MBR World Finals In Las Vegas

On Tuesday, October 23, 2012 Daniel Keeping age 13 of Gorman, Texas flew to Las Vegas, NV to compete in the Miniature Bull Rider's World Finals. The MBR was held during the Professional Bull Riders World Finals in the PBR Fan Zone at the Mandalay Bay Hotel, October 23rd, 24th, 25th and 26th.

Ten riders in each of the two age groups were invited based on their yearend standings in the association. Dan had only competed in two of the four events and still placed fourth in the year end standings which qualified him to compete.

The competition started on Wednes-

day with Dan drawing the bull Gambler. Gambler would not stand in the chute and reared and jumped banging Dan around and giving the judges cause to call for another bull. Dan rode that bull for a 74 point ride placing him in third place for the opening round. Only four boys rode that day. On the second round Dan drew the bull he had as a re-ride from the day before and scored a 72 placing him in second place for the day and moving him to first in the average and only three boys had gone two for two.

On the third day Dan again drew a bull that was keyed up for the event and was jumpy in the chute. Dan worked with bull and was able to get out on him, however when the chute opened the bull stumbled down to his chest throwing Dan forward into his horns which struck Dan in the throat and caused him to buck off. The judges granted Dan a re-ride and Dan pulled himself together and made that ride. He again placed third in the round and remained in first in the average. There were now only two riders that had gone three for three.

On the final day the boys were able to select the bull they wanted to ride based on their overall standings. Dan had the first choice and drew Black Duck a bull he had previously gotten an 86 point score on. Dan was the last rider to go in the round and was the only one who had a chance at going four for four. While Black Duck did not have the out he did previously Dan still placed third in the round and won the finals. He finished third overall for the season.



Keeping Athletes Safe on and off the Field

(NU) - Basketball and bicycling rank highest for injuries among recreational sports, causing 1.5 million accidents per year. Baseball, soccer and softball follow, each with almost half a million injuries yearly, according to the U.S. Consumer Product Safety Commission.

Whether you're upping your own practice schedule or you're a parent of a student athlete headed back to school, heeding a few precautions goes a long way.

Here are some tips from osteopathic physician Marcel Fraix, member of the Fellow of the American Academy of Physical Medicine and Rehabilitation (FAAPMR) and assistant professor at Western University of Health Sciences. Fraix is also a staff physician at Casa Colina Centers for Rehabilitation in California, where he specializes in sports-related disorders.

• Start with a check-up when possible. Physical stress on a young body can be harmful when coupled with an underlying medical condition or heart problem. Likewise, get an exam before stressing the heart if you're middle-aged and mostly sedentary.

Pre-conditioning programs for specific sports help. Injuries usually occur at the beginning of the season, when you are most likely to be out of shape. Building hamstrings and inner quadriceps muscles helps prevent knee injuries. • Diligently use the proper safe-

ty equipment, e.g., mouth guards, safety goggles, helmets and elbow and knee pads. Don't forget to apply sunscreen SPF 15 or higher.

Stay adequately hydrated with

water or a water-electrolyte drink. Replacing fluid lost from sweating is essential to maximize athletic performance and prevent heat exhaustion, especially during warm weather.

• Treat injuries on the spot. Keep a first aid kit ready for cuts and scrapes, allergic reactions, insect bites and eye irritations. Most importantly, be prepared to treat muscle pain at the first sign before it sidelines you. There are safe, natural and unscented pain relievers available.

Look for a homeopathic medicine like Arnicare Gel (www.Arnicare.com), which works with the body instead of just masking pain. Try it on legs stiff from running or cycling, or on shoulders aching from too many tennis racket swings. It also helps with pain from strained ligaments or bumps and bruises from hard-fought basketball games.

• Limit practice and playing time. Nearly half of all injuries suffered by children are results of overdoing it. Consider allowing a child to take three months off per year and limiting practice to 12 hours per week for one sport, and 20 hours for multiple sports.



Kyl, Hutchison Propose Achieve Act Addresses Legal Status of Undocumented Young People

WASHINGTON, D.C. – U.S. Senators Jon Kyl (R-Ariz.) and Kay Bailey Hutchison (R-Texas) have introduced legislation they believe will provide a basis for compromise on the status of children brought to this country illegally.

The ACHIEVE Act, under development for more than a year, would provide legal status for eligible young people. The bill addresses the special circumstances of children who were brought into this country without following proper immigration procedures and who, for the most part, know only the United States as their home.

Specifically, the proposal would put in place a special visa system for young people who intend to pursue a technical or college degree, or serve in the U.S. military.

"Many young people in this country are here illegally through no fault of their own. Relegating a potentially productive portion of the population to the shadows is neither humane nor good economic or social policy.

Only individuals who have abided by our nation's laws, while residing within its borders, would be eligible for continued legal status, and there is no automatic path to citizenship.

We have attempted to accommodate those with the ambition to pursue a useful educational degree, or serve in the U.S. military. Moreover, our proposal prohibits the awarding of additional federal benefits," Kyl and Hutchison said.

"While this legislation addresses a single facet of our nation's complex immigration problem, it is nonetheless a step forward in addressing a time-sensitive issue."

Achieve Act in Detail

W-1 Status: Those with a W-1 nonimmigrant visa would attend school to earn a bachelor's, associate's, vocational/technical, or advanced degree, or serve in the U.S. military. A W-1 visa holder would have 6 years to get a degree or enlist to serve four years in the military. **To be eligible:**

There are four recommended vaccines that preteens should get when they are 11 or 12 years old. If you have an older kid like a teen, they'll need a booster dose of one of the shots. It's also not too late to get any shots they may have missed. You can use any healthcare visit, including sports physicals or some sick visits, to get the shots your kids need. The vaccines for preteens and teens are:

• HPV vaccine for both boys and girls, which protects against the types of HPV that most commonly cause cancer. HPV can cause cancers of the cervix, vulva and vagina in women and cancers of the penis in men. In both women and men, HPV also causes mouth/throat cancer, anal cancer and genital warts.

• Tdap vaccine, which is a booster against tetanus, diphthe-

ria and pertussis. Pertussis, or whooping cough, can keep kids out of school and activities for weeks. It can also be spread to babies, which can be very dangerous and sometimes deadly.

 Meningococcal vaccine, which protects against meningococcal disease. Meningococcal disease is caused by bacteria and is a leading cause of bacterial meningitis – a serious infection around the brain and spinal cord.
Influenza (flu) vaccine, be-

cause even healthy kids can get the flu, and it can be serious. All kids, including your preteens and teens, should get the flu vaccine every year.

Talk with a doctor, nurse or clinic about the vaccines for preteens and teens. Even though they may not realize it, your kids still need you for more than a ride somewhere. They need you to continue protecting their health by getting them these important and life-saving vaccines.

HUMAN INTEREST One Family, One Veteran, Two Heroes

(NU) - From the perspective of many veterans, their military service is merely a duty. They were doing their job. They don't look in the mirror and see a hero. When wounded Air Force sergeant Tom Marcum returned home from Iraq, he was his family's hero every day. But his wife April would soon step up to become the second hero in the Marcum family.

Tom's injuries were extensive, and the impact on April and their two sons was enormous. In two years, Tom endured four separate mortar explosions. He faced a traumatic brain injury (TBI), hearing loss, vision problems and posttraumatic stress disorder (PTSD).

April faced a whole new reality. Her days were a flurry of doctor appointments, therapy and home healthcare, not to mention raising two boys. For 18 months straight, she was the sole nurse, driver, maid and mother to three. She had to meet her husband – a friend since grade school – all over again.

"I missed the help my husband



The Marcum family coped with impossible change, becoming a family of heroes.

"I made some deep, emotional connections with several women," April says. "It was just the right thing at just the right time. I came home ready to get back into the fight again. I was re-energized and happy when I came home."

Both Tom and his sons, Gabe and Jared, saw a positive change in their mom after the retreat. Slowly but surely, the family knit itself back together through love,

- Applicant must have lived in the United States for five years prior to enactment;
- Applicant must have entered the country before the age of 14;
- Applicant must have good moral character;

- Applicant must not have committed a felony, must not have committed more than one misdemeanor, must not have committed a crime of moral turpitude, and must not have a final order of removal pending;

Applicant must have knowledge of the English language, of American history, and of principles moo of U.S. government;

- Applicant must be 28 or younger at the time of application (unless applicant is under 32 and possesses a bachelor's degree from a U.S. college at the time of application);

Applicants pay an application fee;

- Applicants complete a medical exam and submit biometric and biographic data as part of a background check.

To maintain W-1 visa status, visa holders:

Must check in every six months with the DHS, and be compliant with program requirements;

Must not access public welfare benefits;

Must not access federal student loans, or other federal benefits, but may work while in school Do not have access to a green card while here on the W-1 visa.

W-2 Status: After completing all W-1 education/military service requirements, a recipient can obtain a W-2 visa, which is a four-year nonimmigrant work visa (also allowed, study toward a master's degree or higher).

Criteria for obtaining W-2 status:

Recipient must have earned a bachelor's, associate's, or vocational/technical degree in the U.S.
while here on the W-1 visa or have served four years in the U.S. Armed Forces;

- Pay an application fee;
- Continue to meet W-1 criteria (no criminal record, check in with DHS, etc.).

W-3 Status: After completing four years of work while holding a W-2 visa, a recipient can then apply for a (permanent) nonimmigrant (no special pathway to citizenship) visa. **Criteria/conditions:**

- Must have complied with all requirements/eligibility standards for W-1 and W-2 status;
- No eligibility for public welfare benefits;
- W-3 status renewable every four years;

 No new green cards are added in the Act, but a W-3 visa recipient could apply under current law to obtain one and get in line.

A Weekly Newsletter from Congressman Randy Neugebauer Over 47 Million Americans Now Participate in the Food Stamp Program

Earlier this month, the U.S. Department of Agriculture reported that over 47 million Americans take part in the Supplemental Nutrition Assistance Program (SNAP), formerly known as the food stamp program. A recent study found that the number of individuals on food stamps exceeds the populations of 24 states and the District of Columbia. As more people are added to the program every day, this system is becoming increasingly expensive to taxpayers, costing \$72 billion in fiscal year 2011.

SNAP is a valuable program for people who have fallen on hard times and need help feeding their families while they get back on their feet. However, government benefits must be reserved specifically for our most vulnerable citizens. We must ensure that taxpayer dollars are only going to those truly in need of assistance. Congress is expected to pass a new Farm Bill before the end of the year, about 80 percent of which is now focused on food stamp policy. I am working to ensure this bill will reform this program to close loopholes and stop abuse and inefficiencies.

Supreme Court Will Consider DOMA This Week

On Friday, the U.S. Supreme Court will review five cases that seek to overturn the Defense of Marriage Act (DOMA), which defines marriage as a legal union between a man and a woman and became law in 1996. These meetings will be held to determine whether or not to put these cases on the court's schedule in 2013. I believe in the traditional definition of marriage, which consists of a union between a man and a woman. The institution of marriage has proven vital to the existence of society and to raising and protecting children. I hope the Supreme Court upholds the Defense of Marriage Act, which I will continue to fervently support if this issue should come to the House Floor.

USC's Golden QBs Are Losing Their Shine

(NU) - If Matt Barkley is fortunate enough to squash Notre Dame's national championship aspirations in his home finale next Saturday, the senior quarterback should diverge slightly from the routine formula of snatching up Tommy Trojan's sword and leading the marching band in their traditional victory song "Conquest."

Instead, the Trojans golden boy

Back in 2009, Sanchez was in the midst of leading the New York Jets on their first improbable run to the AFC Championship Game as a rookie. Matt Cassel, who graduated from USC as the Tito to Leinart and Palmer's Michael and Jermaine, was in the first year of his six-year, \$62.7 million contract. Meanwhile, Matt Leinart was still considered the successor to Kurt Warner's throne and Carson Palmer still had Ocho Cinco on the other end of his passes in Cincy.

Flash-forward three years lat-

The last time USC had a string of quarterbacks swing through was in the early '90s when the quartet of Rob "Robo-sack" Johnson, Todd "Robo-QB" Marinovich, Sean Salisbury and Rodney Pete strode through campus. None of them became the franchise quarterbacks they were groomed to be.

Most disappointing out of the trio was Marinovich, football's Diggy Simmons, who was given the pedigree and training from birth to be a Hall of Fame gunslinger but was hindered by his relentless drug habit. Barkley is a clean-cut kid by all accounts but in a few months he'll have to leave the sunny state he's called home for 22 years. Numbers-wise Barkley can boast that he belongs in the same class as RG3 and Andrew Luck. However, NFL scouts who have Geno Smith rated ahead of him have qualms with his inability to make plays once the pocket collapses. Not to mention his lack of athleticism and average arm strength. USC annually recruits the top teenage quarterbacks in the nation, but the NFL is full of late bloomers who weren't as close to reaching their peak at 17.

EPA denies request to waive RFS standard; Continues to artificially inflate corn prices despite nationwide shortage

Fort Worth, Texas - The U.S. Environmental Protection Agency (EPA) today denied the request by U.S. ranchers, including the Texas and Southwestern Cattle Raisers Association (TSCRA), to waive the current Renewable Fuels Standard (RFS). The request for a waiver was made in light of corn shortages and soaring feed costs across the country.

"It's truly unbelievable that a government agency would ignore the fact that we are facing a dire corn shortage in this country," said Joe Parker Jr., rancher and TSCRA president. "By continuing to mandate that 40 percent of the very small U.S. corn crop go directly toward ethanol production, the government is escalating an already dire situation by bolstering an artificial market that will further push some ranching families out of business."



Parker says that as long as corn supplies continue to tighten across the U.S., the current RFS standard will only compound the situation by reducing the already extremely limited amount of corn available for feed. This situation is particularly severe in Texas, the leading cattle producing state in the nation.

"The EPA had an opportunity to show their support, in some regard, of the U.S. cattle industry," continued Parker. "Instead, they continue to put our food and fuel in competition with one another by giving one commodity a leg-up at the expense of another. Chalk this up to another instance in a long line of examples that demonstrates that the government, particularly the EPA, does not support the cattle industry or the free market."

should pull a Devon Miles and ask them if they can play some Asher Roth, because in no other locale can Roth's summer anthem 'I Love College', have more profound meaning than on the USC campus.

That's where USC's (cardinal and) golden boy has called home for the past four years. It's also where Barkley decided to return for his senior season rather than brave the harsh world outside the confines of the McKay Center, Heritage Hall and the L.A. Coliseum.

During the Pete Carroll years, being the Trojan's starting quarterback was considered a mark of future greatness. At least that was the perception. Three years ago, the USC Trojans were college football's preeminent destination for high school quarterbacks seeking to prep for the pros at a QB Ivy League.

In 124 years of college football, 15 Trojan quarterbacks have started at least one NFL contest. That's more than any other program in the nation. Carson Palmer, Matt Leinart and Mark Sanchez parlayed their years choreographing the Trojan prolific offense into guaranteed early first round guap.

er and the script has been flipped. Of the four active starting NFL

signal callers, none are expected to make the postseason and by the time Barkley takes his first pro snap, Palmer may be the only one still left standing as a starter. Meanwhile, Sanchez is the most inaccurate passer in the league and Cassel is barely surviving a quarterback controversy with Brady Quinn for the league's worst team. Palmer is the lone, somewhat success story and even he has vastly underperformerd. He is just 53-64 as a NFL starter.

Barkley, once believed to be the No. 1 prospect in the Class of 2012, isn't even considered the best prospect on his offense anymore. That honor belongs to sophomore receiver Marquise Lee. Barkley remains a first-round prospect, but the shine that accompanied him when many believed he could win the Heisman as a freshman has dimmed a few shades.

In truth, reality is finally catching up to the USC quarterback illusion. In 2014, phenom David Sills, who committed to USC at 13, will attempt to become the Trojan's latest can't-miss NFL quarterback prospect. Like most college grads, life is about to get real for Barkley

And if Barkley looks around and takes a look at how his predecessor's careers have fallen short at the next level, he'll take his time and ask himself the same question as a hungover Roth did:

"Do I really have to graduate? Or can I just stay here for the rest of my life?"

WE CAN'T AFFORD TO GO OVER THE FISCAL CLIFF

You can't turn on the news these days without hearing about the looming "fiscal cliff." The stock market goes up and down daily as some small bit of good or bad news is reported about avoiding the economically catastrophic tax increases and automatic spending reductions that are set to occur at year's end.

I believe Congress and the White House can come together and reach the necessary bipartisan agreements that are needed to avoid the fiscal cliff and put America's economic house in order again. The stakes for our economy and our future are enormous. According to the Congressional Budget Office, the impending tax hikes and across-the-board spending reductions in most programs (known as sequestration) would drag America back into recession and push unemployment back above 9%.

Going over the fiscal cliff would also mean higher interest rates on credit cards, personal debts, and new mortgages. Fewer of our children would be able to find work, and hopes for rejuvenating our economy would be dashed.

The underlying problem is out-of-control deficits. For the fourth consecutive year, our budget deficit is over \$1 trillion. Total debt now exceeds \$16 trillion, and our country will be financially crippled if we don't deal with deficits.

Several bipartisan solutions have been put forward, including a plan from the President's Simpson-Bowles Commission. The President has said repeatedly that taxes must be raised on those who make more than \$200,000. But if every millionaire in America were taxed at 100%, it would put only a small dent in our enormous budget deficits.

Although going over the fiscal cliff would raise taxes on everyone, the big threat is to middle class families. If action isn't taken by year's end, middle class families, small business owners, and retirees are going to take it on the chin in their 2013 taxes.

More than 31 million middle class taxpayers will face something called the "alternative minimum tax" for the first time. The AMT was enacted years ago to assure that the wealthiest people paid a certain amount of tax. Thanks to inflation and bracket creep, the AMT is about to affect married couples whose joint taxable income is \$45,000.

Uncertainty about taxes has small businesses stuck in neutral. Three-quarters of small businesses pay taxes at individual rates. Until they know what their tax rates for 2013 will be, the businesses that account for almost two-thirds of new job creation are standing still - and more than 20 million Americans who are looking for work will be on hold, too.

Senior citizens who saved for retirement are at financial risk, too. Taxes on dividends are set for huge increases on January 1 - to as much as 40%. Retirement planning and financial security will go out the window for millions who did all the right things throughout their working lives. Also at risk if we don't avoid the fiscal cliff are my two top tax priorities. First, in states like Texas, which don't have an income tax, the deductibility of sales taxes for federal income taxes assures fairness with other states. If state sales tax deductibility isn't renewed by year's end, millions of Texas taxpayers will see their federal income tax bills swell by an average of \$500 next year.

My second priority is renewing tax relief for middle class married couples. Before my amendment was made law in 2001, 25 million married couples were forced into higher income brackets and paid an average of \$1,400 more than they would have as single people. This marriage penalty is, well, un-American, and my fix must be renewed.

There is still time for Congress and the White House to come together on a comprehensive long-range fiscal plan - to avoid punishing tax increases that will kill our weak economy, assure longterm Social Security and Medicare solvency (without cutting current benefits), and lock in prudent spending limits that will pare back deficits. The first step is for Congress and the White House to agree before year's end on a tax and spending framework that will avoid the fiscal cliff and put our country back on the right track.
