

My Journey by Ina Smith

I have now passed my 3rd month of my implant being turned on. Things are getting better, I am now hearing more sounds. I am able to recognize some words but not the whole sentence.

The last few weeks I have really put my implant to the test. We have had 2 family reunions at our house. Normally by the end of the day all the different sounds have gotten to me. This year they did not. I was able to understand more conversations and block out some of the sounds that usually bother me.

I want to thank everyone for being so helpful and patient. I know they get tired of me asking "what is that noise?". Just Saturday evening Johnny and I were sitting on the patio and I heard a noise and ask him what I was hearing, He had to listen a second and then smiled, "it is a cricket". "Oh wow!" I said and like a kid at Christmas I had to text my kid, and tell them. Amy first as she has said so many times, "I can't wait til Mom hears a cricket and can't find it".

I came to realize I am not making as much progress as I would like. I think in part it is due to my wearing my hearing aid in my right ear and depending on it to hear. So part of the time now I will only wear my cochlear audio processor.

There are 3 different types of hearing loss: Sensorineural, which is the most common type(which I have) and affects the inner ear. Conductive loss affects the ear canal, ear drum and tiny bones of the middle ear. And Central hearing loss which is issues in the Central nervous system, and can cause processing of auditory stimulus to breakdown. You may hear but may have a hard time understanding. There are different levels of hearing loss: Slight, mild, moderate, moderately severe, 4 X 8 paver severe, and profound. I am considered profound deaf.

The cochlear implant system that I have is the Med-El Maestro. It has two main parts: the 8 X 8 paver internal(implant) which consist of the housing and the electrode array and the external (audio processor) which consist of the control unit that contains the microphone and the electronics that process 6 X 12 paver sound, the cable and transmitting coil and battery pack.

Sound is picked up by the microphone of the audio processor, the audio processor analyzes 12 X 12 paver and converts sound into special codes. This code is sent to the coil and transmitted across the skin to the implant. The implant interprets the code and sends electrical pulses to the electrodes in the cochlea. The auditory nerve picks up this signal and sends it to the auditory center in the brain. The brain recognizes these signals as sound. (This is where my brain and I are learning what I am hearing.) The coil which has a magnet in it attaches to the implant under my skin. The audio processor fits behind my ear like a hearing aid. All voices sound alike. I can not tell the difference between a female and a male voice. I was told that someday I might be able to identify Johnny's voice. Also I found out that if I have a cochlear implant on my right ear, I will have to go through the same learning process as I am the left ear.

I by accident found out that my coil will leave my implant for another source of metal if I get too close. I was removing groceries from the bottom of the shopping cart the other day and my audio processor left me. We finally located it hanging on the side of the shopping cart.

Following surgery I had good bit pain in my left jaw and sweet and salty foods just didn't taste right. The jaw pain was due to the muscles in my temporomandibular joint area being stretched and the implant placed under the muscle this also effected the nerve that controls the sweet/salty taste buds on my tongue. The jaw pain is gone and some of my taste is coming back.

Not all hearing impaired people are alike. I am 90% lip reader and any extra sounds going on makes it extremely hard for me to understand conversations also I do not like going places by my-

self for the first time, I dislike

group discussions as I can not keep up with the conversation.

I do not enjoy going to the mov-

ies because 80% or more of the

conversation takes place with the actors not looking at the

camera. And one thing I refuse

to do when by myself is go to

a drive thru window. Someone

needs to invent a close caption for those speaker boxes. Some

other things that bother me is when I do not understand a

conversation and ask someone

to please repeat, they only re-

peat one or two words. I need

the whole thing repeated just

like it was said the first time.

Also please do not say "never

mind" when asked to repeat. If

it was important enough to be

said the first time it should be

repeated. When someone says

never mind, it makes me feel

like I am not important enough

given the chance to have the

Economic and Personal Finance Resources for the Visually Impaired

All consumers need to understand the economy and personal finance, but it's particularly important for people who are visually impaired. That's where the National Library Service for the Blind and Physically Handicapped (NLS) and its affiliate, the Texas Talking Book Program (TBP)—part of the Texas State Library and Archives Commission—can help. NLS provides audio-books and Braille books free of charge to qualified patrons through a network of libraries in each state, including the Texas Talking Book Program.

Recent books on personal finance available to NLS/TBP users include "Ordinary People, Extraordinary Wealth" by Ric Edelman and "Jim Cramer's Getting Back to Even." NLS also produces books that have special relevance to its users, such as "Estate Planning for People with a Chronic Condition or Disability." Books in Spanish-such as "Repare Su Crédito Hoy" ("How to Fix Your Credit")—and magazines including Money, Kiplinger's Personal Finance Magazine, and The Economist are also available.

Thomas Galante, a vice president at the Bank of New York Mellon Corporation and registered NLS user, says, "People sometimes say to me, 'I'm not working-why do I need to know about personal finance?' It's in everybody's interest to understand personal finance," Galante says. "It's even more important for people who have fewer resources."

"One way the NLS program has helped me is by providing popular business books the self-help books, the management books," Galante says. "These are books my peers are reading, so it helps just in terms of being conversant with colleagues."

Ardis Bazyn, an inspirational speaker and business coach, is also an NLS user. "I believe it is very important for blind individuals to read as much as possible in order to compete in this global economy," she says.

Since 1931, the Texas Talking Book Program has provided reading materials, free of charge, for the visually impaired and physically handicapped. Texas residents who are blind, have low vision, or cannot hold a book or turn its pages because of a physical disability are eligible. Veterans are given priority status.

The Talking Book Program provides digital audio-books and Braille books by mail; users return them by mail, postage free. Playback equipment is loaned free of charge to qualified applicants. Patrons with computers and Internet service may download books through the NLS Braille and Audio Reading Download (BARD) service.

NLS awarded the Texas Talking Book Program its Library of the Year Award for 2011. For more information or to request an application for service, visit www.texastalkingbooks. org or call toll-free in Texas (800) 252-9605.

GORMAN ATHLETIC BOOSTER CLUB PAVERS





Cow-Calf Management Clinic Scheduled


