Lady Panthers Volleyball Team Outlasts Ranger Lady Bulldogs

The Lady Panthers volleyball team beat the Ranger Lady Bulldogs on their home court last uesday in five sets 25-20, 15-25, 26-24, 21-25, 15-12. Gorman volleyball coach Jim Wood knew this was going to be a tough match as well as an important one.

"Ranger always gets fired up when they play us and it was no different this time. We had a great crowd and this match had a playoff atmosphere to it," Wood said. "We also knew the importance of this match in the district standings. After losing to Albany, I didn't want to get two games down in district."

In game one, it was really close most of the way. With the score tied at 17-17, Gorman started to distance itself from Ranger to take to take the first set 25-20. Game two was very different as Ranger jumped out to a quick lead, and continued to build on that lead throughout the game to win it 25-15.

But the Lady Panthers bounced back in game three and took leads of 17-9 and 22-17. That's when Ranger went on a 7-1 run to get game point on the Panthers 24-23. A hitting error by Ranger and two kills by Gorman ended the Bulldog rally and the Lady Panthers took the third game 26-24. The fourth game belonged to Ranger as they took an early lead and held onto that lead throughout the game. Gorman would cut into those leads several times to tie the score or pull within a point or two, but could never get ahead and lost the game 25-21.

Despite trailing 12-10 in game five, the Lady Panthers then mounted a furious comeback with a 5-0 run to win the game 15-12, and the match. The win puts Gormans record on the season at 15-12 and 2-1 in district. Ranger drops to 1-1 in district.

Lady Panthers Volleyball Team Down Moran Lady Bulldogs

Gorman beat the Moran Lady Bulldogs in straight sets this past Saturday 25-13, 25-6, 26-24. The win puts the Lady Panthers in second place at the halfway mark in the District 9-A volleyball standings.

"I was a bit nervous coming into this match after our win against Ranger," Coach Jim Wood said. "Moran has a new coach, they (Moran) have some big girls and I just didn't know what to expect from them. They lost to Ranger but they took them to 5 games last week so I knew they were much improved from last year."

However, Coach Wood could quickly put those fears to rest as the Lady Panthers came out firing on all cylinders. In the first and second games, Gorman put on a serving clinic, recording 15 aces in game one and 13 aces in game two.

Both bands did great performances at the intermission and then joined together to enteretain the fans and did a superb job of playing together. Good Job Bands!!







A Letter To The Editor By Henry A. Buchanan



SLOW COOKER SAFETY

It is 5:30 p.m. What's for dinner? Each day, millions of people are faced with this question. Without a plan, takeout meals and fast food starts to look pretty goo. Although eating out occasionally is okay, eating out too often can put a bulge in our waistline and a dent in our wallet. So, what's the solution for a time-restricted, nutrition-conscious, budget-minded individual? Look no further than the slow cooker. ASlow cookers are great because they basically do the cooking while you are away,@ says Dr. Jenna Anding, Associate Professor and Nutrition Specialist with Texas AgriLife Extension Service. Alt is almost like having your own personal chef.@ In addition to preparing great tasting meals, a slow cooker can help save money. Compared to an oven a slow cooker uses less electricity. In addition, slow cookers do not heat up your house like an oven (an added bonus during those hot summer months). Finally, slow cookers are a great way to prepare inexpensive, lean cuts of meat. The moist heat generated by the slow cooker makes these cuts of meat more tender compared to other cooking methods. AAnother great feature of slow cookers is the ease of use,@ notes Anding. For the most part, all one has to do is place the ingredients in the slow cooker, plug it in, and turn it on. However if important food safety recommendations are ignored, food prepared in a slow cooker could cause a foodborne illness. To reduce the risk of foodborne illness, Anding recommends the following tips:

1. Start with a clean cooker, utensils and work area; wash your hands before and during food preparation;

2. Refrigerate perishable foods until preparation time. If you chop meat and vegetables in advance, store them separately in the refrigerator in covered containers;

3. Never place frozen meat or poultry in the slow cooker;

4. In the past, it was not recommended that large pieces of meat or a whole chicken be cooked in a slow cooker. However, recent research suggests that the newer models of slow cookers are safe for cooking large pieces of meat and poultry. Follow the instructions and recipes that come with your slow cooker. If you do not know the age of your slow cooker, be on the safe side and cut the meat and poultry into smaller pieces and place them in the cooker with the right amount of liquid.

5. Fill the slow cooker between 2 and 2/3 full. Root vegetables cook slower than meat or poultry so place them on the bottom. Add the meat, and then fill the slow cooker almost to the top of the food with liquid (broth or sauce). 6. Do not peek! Each time the lid isremoved, it can take 20 minutes to regain the lost heat. This increases the cooking time.

7. If you are not home during the ENTIRE slow-cooking process and the power goes out, throw out the food, even if it looks done!

8. Use a food thermometer to make sure meat and poultry dishes have reached a safe internal temperature.
