ABSENTEE VOTING:

## The folowing persons, and no others, may also vote by mail:

Qualified electors who because of sickness or physical disability cannot appear at the polling place on the day of the election. The elector shall state in his application the address to which the at which he is temporarily living.

An elector desiring to vote absentee SHALL MAKE WRITTEN SWORN APPLICATION for BY THE ELECTOR or by a witness at the direction of said elector in case of the latter's inability解 round on which the applicant is entitled to vote absentee and in case of an application by mail shall ive the ene in the applicant is entitled to te by mail. Such application shall be accompanied by the poll tax receipt or exemption certificate f the elector, or, in lieu thereof, his affidavit in writing that same has been lost or mislaid. If the
 OR ACCREDITED CHRISTIAN SCIENCE PRACTITIONEER certifying as to such sickness or physical disability shall accompany the application.

ANY PERSON who requests a physician to execute a certificate for another person without havgeen directed by such other persons to do so, and any PHYSICIAN WHO KNOWINGLY EXEuest of someone at the voter's direction, and any physician who EXCEPT BY DELIVERING IT TO THE VOTER IN PERSON OR BY MAILING IT TO THE VOTER AT HIS PERMANENT RESIDENCE ADDRESS OR THE ADDRESS AT WHICH HE IS TEMPORARILY LIVING shall be guilty of a misdemeanor and upon conviction shall be fined not more than Five Hundred Dollars ( $\$ 500$ ) or imprisoned in the county jail for not more than hirty (30) days, or both so fined and imprisoned
