



LAWTON, Mich., Dec. 23 .- A bigned statement accusing Joseph Virgo of performing an illegal operation upon Maud Tabor has been made here by Mrs. Maud I. Tabor, 80 years old, mother of the brilliant linguist whose body was found in a trunk in the basement of her home here, according to Assistant Presecutor Glenn Warner today

The statement, which is in di-rect contradiction to the story told by the aged woman at the inquest, covers thirty pages and was made to him, Warner declared, in the jail at Paw Paw, near here, short-

ly after midnight. Mrs. Tabor charges Virgo, who was married to Miss Tabor about a year before her disappearance in 1916, took her to a deserted farm house in the neighborhood of Lawton, kent her there three days and brought her home when she died.

The statement adds that Virgo crammed the body of his wife into what was to have been her "hope chest" and covered it up in the cellar after he had been prevented from shipping the trunk out of the state. Virgo has been held in the jail

RANGER LOOKS CHIEF TO

Ranger is to have a new fire chief, according to rumors current in the city today.

Although there is no official confirmation of the report, as yet, it is reported that the administration has wearied of the inefficient leadership of an otherwise capable department and is casting about for a man to take the place of Ed S. Smith.

Several men at present with the department, which has undergone many changes in personnel under Smith's control, are mentioned as successors to the present chief, and according to those in close touch with the department, any one of them would make an able fire chief. Three of them in particular command the respect of the firefighters and are well acquainted with the administration of a civic fire-fighting organization.

Smith's removal has been a matter of rumor several times since the department was organized, with him at the head. On one occasion, his alleged impersonation of an officer, with a resulting official tangle, nearly was the reason for his forced resignation. At another time, when the department was depleted through wholesale resignations because of

Smith, he was warned that the next time a large number of men quit, he would be among the number. City Manager Turner this morning would not confirm the report. He said he had heard nothing of it. Evidently anticipating the result of the series of blunders he has made, Smith recently attempted to cast dis-


