

RANGER HIGH SCHOOL DEDICATION TODAY

U. S. ENTRY INTO NATIONS LEAGUE NOW SUGGESTED

President Harding and Cabinet Giving Serious Consideration to Participation.

WASHINGTON, April 12.—Possibilities of American membership in the League of Nations are being seriously considered by officials of the Harding administration, a member of the cabinet today told the United Press.

Two points which administration officials are discussing are:

- (1) Should the United States join the league to carry out the administration's pledge of an association with other nations to prevent war?
- (2) On what terms should the United States enter?

The administration is taking the position that participation in the league is only a partial step towards prevention of war. The administration is pledged to do all within its power to carry out and any opportunity to carry out that pledge will be seized.

Some of the changes regarded as essential in the League of Nations pact before U. S. entrance includes the separation of the covenant of the league from the Versailles treaty; rearrangement of the voting power of the league members. This would include the abrogation of Article ten.

More Week-Day Instruction In Religion Urged

OMAHA, April 12.—The Sunday School bureau has outlined its usefulness and is without a future after more than 100 years of Christian work, according to the Rev. William Gardner, executive secretary of religious extension of the Protestant Episcopal church, who said in an address here today:

"We need to recognize that the Sunday school has no future because it is doomed to fail in appeals to the rising generation. I do not mean that there will be less religion for children. On the contrary, there will be more religion and better systematic character than possible under present limitations. We can give our best attention to furthering plans for week-day religious instruction."

NEW RECORD FOR CONTINUOUS DANCING MADE IN CLEVELAND

CLEVELAND, Ohio, April 12.—Miss Helene Mayer, 21, at noon today had established a new record for continuous dancing of 50 hours and 25 minutes and was still dancing. She said she would continue until she had danced 60 continuous hours, at least. Tuesday morning in an effort to beat the record of 50 hours and 2 minutes made in New York a few days ago by Miss Alma Cummings of San Antonio, Texas. She has worn out six male partners and three pairs of dancing pumps.

Two other girls, Madeline Gettschick and Gertrude Walker, who started dancing yesterday morning, dropped out after dancing about 28 hours.

Three-minute rests were allowed each seven hours and when a girl got hungry she ate a sandwich or drank malted milk while dancing. When shoes were worn out the new pair would be brought in and the girl would hop on one foot while an attendant changed the shoes.

Miss Mayers stopped dancing at 1:51 o'clock today, after dancing a total of 62 hours and 16 minutes.

Petitions placing Ford's name on the Nebraska primary ballot were filed yesterday with the secretary of state at Lincoln.

TEXAS LIONS TO SEIZE PARIS NEXT SPRING

Col. Louis C. Perry of Terrell Is Elected District Governor.

WACO, April 12.—Col. Louis C. Perry, of Terrell, was elected district governor by the Texas Lions clubs in session here yesterday, succeeding Clyde A. Sweeton of Greenville.

R. D. Green of Abilene was unanimously elected deputy district governor.

Paris was chosen as the 1924 meeting place over Amarillo and Galveston.

Perry, who is the founder and president of the Terrell Military college, defeated W. K. Wingfield of Temple. Green was nominated for district governor, but at his request, his candidacy was withdrawn by T. N. Carswell of Abilene. After the election of district governor, Green's name was then put in as a nominee for deputy district governor. Green is superintendent of education at Abilene.

Tells of Big Convention.
In making the report on the plans for the international convention at Atlantic City, Judge Seward of Fort Worth at the noon luncheon said the committee in charge has recommended that all Texas delegates wear sombrero and arm bands and that they be attired in white trousers and blue coats.

Official route for Texans to attend the international convention was adopted as presented by the transportation committee, of which E. D. Henry of San Antonio is the chairman. It calls for the trip to be made by way of Memphis, Chattanooga and Washington with stops at the last two named places.

Returning the delegates can go by way of New York and Norfolk or by way of Montreal, Niagara Falls and Chicago. Recommendations that Lions clubs stand for better public schools, improvement of highways, installation of playground equipment, and for community singings was made by A. G. Mayse of McKinney, chairman of the committee on club activities. His report was adopted.

A. M. Jameson, Leslie H. Hagaman and A. N. Larson were delegates from Ranger attending the convention.

HARDING'S PLAN FOR INTERNATIONAL COURT ENDORSED BY WOMEN

DES MOINES, April 12.—A resolution endorsing President Harding's stand for urging United States participation in the international court of justice was introduced today by Miss Ruth Mathews, chairman of the committee for prevention of war, at the convention of the National League of Women Voters.

The resolution will lay in the hands of committee on resolutions for 24 hours before being acted upon.

HEAVY RAINS FALL IN SOUTH PART OF COUNTY

FORT WORTH, April 12.—Heavy rains fell last night at Desdemona, Eastland county, and water stood several inches deep in the streets in the business section this morning. Rising Star was struck by a small tornado, according to dispatches, doing some damage. Water stood inches deep in the streets of Rising Star today, following the heavy rain that fell last night.

E. A. Bills of Eastland Deputized to Conduct Masonic Ceremony. Programs for Afternoon and Evening.

E. A. Bills of Eastland has been deputized by Mike H. Thomas of Dallas, Masonic grand master of Texas, to conduct the dedication exercises for the new Ranger High school, he was to begin the ceremony at 3 o'clock this afternoon.

The Scottish Rite delegation expected from Dallas, headed by Judge Hiram W. Lively, was prevented from coming by threatened train delays on account of washed-out culverts and bridges.

The Ranger school board considered for a little time this morning the advisability of postponing the dedication exercises until better weather prevailed, but it was decided that as all arrangements had been made it would be better to carry out the program.

The Ranger band under the leadership of "Pop" Endicott will play a number of selections before the regular program and will play at intervals throughout the afternoon. The Rev. L. A. Webb, pastor of the Methodist church, is to give the invocation this afternoon and addresses will be made by M. H. Hagaman, president of the Ranger school board, and Miss Ulala Howard, county school superintendent.

The evening program will begin at 8 o'clock in the new auditorium with an invocation by the Rev. Dr. A. N. Stubblebine, followed by the singing of "America." Dr. L. C. G. Buchanan will speak on behalf of the Rotarians. Dr. W. C. Palmer for the Lions, B. F. Bennett for the Chamber of Commerce, and Mrs. C. C. Chenoweth for the women's clubs. Benediction will be offered by the Rev. W. H. Johnson.

Two songs will be given by a sextette composed of Mesdames J. M. Dodson, T. J. Holmesley, Roger Fenlaw, C. E. Maddocks, A. L. Leake and W. J. Roland. Mrs. Dodson will also sing "In An Old-Fashioned Town." The High School Choral club will also give several selections.

Following the night program a reception will be held and those who wish to do so may inspect the school building.

Equipment of Building
Description of the high school building, exterior and interior, was entered into by a half page article in the "Progress Edition" of The Times, Jan. 31, but the amount and cost of equipment therein had not been fully determined at that time. It can now be thoroughly described.

Of the \$250,000 in bonds authorized by a vote of the citizens of Ranger, Jan. 22, 1921, more than \$20,000 has been used in buying articles for the manual training department, for the class rooms, the laboratories, gymnasium, auditorium, offices, etc. The general construction work done by Henegar and Chambers of Dallas, was originally contracted for \$110,000, to which \$15,000 was added for excavation of rock on the grounds, and the additional sum of \$9,500 for face brick. The plumbing cost \$17,000 and the electric wiring 1,700. The First Methodist church was paid \$21,000 for a lot 140x110, and the Fleming lot cost an additional \$12,000. The latter was 140x90 feet.

The gym equipment costing approximately \$1,210, includes dumb bells, horizontal bars, mats, Indian clubs, pulleys, trapezes, etc. Shelving for the library and book room cost \$341. A sum of \$672.50 was expended for window shades, and \$271 for window guards. A moving picture outfit caused the

ROY MITCHELL, UNDER SENTENCE OF DEATH, APPEALS ALL CASES

WACO, Texas, April 12.—Roy Mitchell, negro, convicted of five murders and given the death penalty in each case, gave notice of appeal in all cases when brought into court for sentence this morning. "I don't think I got a square deal," he told the court when asked if he had anything to say why sentence should not be passed on him. Judge Monroe said that the law gives Mitchell the right to appeal and added: "While I do not delight in human misery, you are one man I will take perfect delight in sentencing to be hanged." The prosecuting attorney said he would try to get the Court of Criminal Appeals to advance the appeal on the docket and get action as quickly as possible.

WIND STORM DAMAGES LOUISIANA SAWMILL TOWN

ALEXANDRIA, La., April 12.—Several persons were injured and fifteen houses wrecked and other damage was done by a small wind storm which struck Meridian, La., early today. It is a small sawmill town about 30 miles south of this place.

OKLAHOMA MAN WOUNDS WIFE AND KILLS SELF

CARDIN, Okla., April 12.—G. B. Jackson was dead today and his wife, Mrs. Hattie Jackson, was near death in a Miami hospital as a result of a quarrel last night in which Jackson shot his wife and then killed himself. Jackson called at the home of his wife last night in an effort to effect a reconciliation after she had filed a suit for divorce. She refused to recall the divorce proceedings or to return to him, whereupon he fired two shots into her body and then fired a bullet into his own head.

EXPORTS AT GULF GALVESTON, APRIL 12

January exports from ports in the Galveston district reached a grand total in value of \$37,297,343, a decrease of \$10,493,557 when compared with December figures of \$47,790,903, according to figures received here from the bureau of customs statistics at New York. January exports through Texas ports were as follows: Galveston, \$25,723,672; Houston, \$11,469,815; Freeport, \$103,858. The cotton exports totalled 186,512 bales during January and was valued at \$25,343,467.

MURDER CHARGE FOLLOWS DEATH FROM FLOGGING

Investigation of Convict Leasing System in Florida Begun.

MADISON, Fla., April 12.—Walter Higginbotham, "guard" at a convict camp of the Putnam Lumber company at Clara, Fla., faced trial today for the murder of Martin Tabert, a North Dakota boy, who died last December following a flogging given him at the camp.

The grand jury investigated the convict leasing system in Florida in connection with the death of Tabert, the latter being demanded by the legislature of North Dakota, and returned the indictment against Higginbotham, who has been released on \$10,000 bail. His trial has been set for May 14.

Witnesses who testified before the grand jury said Tabert died several hours after being whipped. Tabert had been leased with other prisoners to the Putnam Lumber company and the flogging was given to him, according to the testimony given, because he had stolen a ride on a freight train.

CONFEDERATE VETERANS COME TO DIVISION ON ELECTION OF OFFICERS

NEW ORLEANS, April 12.—Amid shouts of "no railroad" against the rules, the election of officers for the Sons of Confederate Veterans was postponed from this morning to this afternoon session.

The delegates report a sharp division on the Ku Klux Klan issue said to have been injected into the sessions. The klan and anti-klan followers are reported as fostering separate tickets.

Memorial services under the auspices of the Southern Memorial association were held this morning. The reading of the roll call of members of the association was followed by routine business.

Balloting for the next convention city and the election of officers is set for this afternoon.

MEXIA, April 12.—Soft tracks, following a rainfall of about 3 inches last night, caused the overturning of two coaches near Groesbeck early today. None was injured, but the wreck caused the detouring of other trains.

VALERA FREED AFTER CAPTURE SAYS REPORT

Irish Authorities Said to Have No Desire to Hold Him Prisoner.

LONDON, April 12.—The mystery of the capture of Eamon de Valera by Free State troops at Clonmel yesterday remains unexplained today. Dublin dispatches said the Free State troops were still searching the mountains for the erstwhile president of the Irish republic and his lieutenant Dan Breen.

Many correspondents, however, openly aver that Valera was taken captive by the Free State troops and later set free. The Manchester Guardian's Dublin correspondent said that Valera had been turned loose as soon as his identity was discovered, as the authorities preferred to have the rebel at large rather than hold him as a prisoner.

The Free State government has given out no statement except that the former president of the republic has not been captured.

Identification of Dead Man Leads to Arrest Being Made

DALLAS, April 12.—Identification of the bullet-ridden body of the man found Sunday near Sulphur Springs as that of Sam Clay of Dallas is reported in a telegram received by the sheriff here this morning from Hopkins county.

Clay was engaged in the transfer business here and has been missing since March 31, according to relatives. His wife told the sheriff that her husband left Dallas for Paris, Texas, in company with a man who is being held by the police for investigation.

MISS LEXIE CRAGIN, SOCIAL LEADER TO BE 'LADY BRECKENRIDGE'

BRECKENRIDGE, April 12.—Miss Lexie Jane Cragin will be "Lady Breckenridge" at the pageant of the West Texas Chamber of Commerce convention at San Angelo in May, it was announced yesterday by Dr. B. A. Swinney, chairman of the entertainment committee of the Breckenridge Chamber of Commerce.

Miss Cragin is the daughter of Mr. and Mrs. F. E. Cragin, and prominent in the social activities of Breckenridge.

GOVERNMENT TO SEND DISABLED VETERANS TO KERRVILLE HOSPITAL

WASHINGTON, April 12.—Decisions on vital affairs in the Veterans' bureau hospitalization program for disabled ex-service men were announced today by General Frank Hines, director of the bureau, after a two days' conference with the federal board of hospitalization.

The plans included: Lease by the Veterans' bureau of the American Legion sanatorium at Kerrville, Texas, until June 30, 1923. The lease of the American Legion sanatorium at Kerrville was obtained on "very favorable terms," Hines announced.

Occupancy of the sanatorium will begin June 1. Announcement of the directors will be made May 1. The sanatorium will have a capacity of 480 tubercular patients.

The decision of the bureau to lease the plant will entail the removal of all the patients at Houston to Kerrville.

SCHOOLBOY DIES FROM STAB WOUND IN FIGHT

WICHITA FALLS, April 12.—Albert Caples, aged 15, died in a local hospital today as the result of a stab wound which officials say was inflicted Wednesday at Thornbury, near here, in a fight between school students.

FORD PROPOSES IN FUTURE TO MINE OWN COAL

DETROIT, April 12.—Coal strikes of the future will not retard manufacture of Ford products, under plans already adopted by Henry Ford.

Coal properties, acquired during the past two years by the Ford Motor Company, have been placed under direction of the Fordson Coal Company, recently incorporated under the laws of Delaware. These properties, according to a conservative estimate of Ford engineers, consist of a coal reserve of about 600,000,000 tons and about 700,000,000 feet of timber. The largest timber holdings were obtained with the purchase of the Peabody coal lands in Southern Kentucky, where, it is estimated, there is about 500,000,000 tons.

Orders for the construction of more than 1,000 coal cars of 55 ton capacity already have been issued by the new company. These cars will be operated directly between the Ford mines and the automobile plant over Ford's railroad, the Detroit, Toledo and Ironton.

The recent purchases of the coal and timber lands is in accordance with Ford's plans to gain control of the basic raw material to the delivery of the finished product and thereby gain the highest quality at the minimum production cost.

The First Purchase.
Among the first coal properties purchased by the Ford Motor Company were the Dexcar coal mines at Twin Branch, W. Va. This property was bought last November and thereby gave the company nearly 18,000,000 tons of high quality coal, adaptable to both by-product and steam purposes. These mines employ about 450 men and have a daily capacity of about 2,000 tons.

Next, the Ford Company purchased the Pond Creek properties in eastern Kentucky, near Williamson, W. Va. It is estimated there is about 300,000,000 tons of available coal at these mines which are operated through eleven openings. About 7,000 tons of coal are produced daily at these mines, by about 1,000 men.

Purchase of the Banner Fork mine added about 12,000,000 tons of high volatile by-product coking coal to the company's interests. This mine employs about 400 men and has a daily production of 3,000 tons.

The Nuttallburg mine at Nuttallburg, W. Va., now owned by Ford, has a daily production of 1,000 tons and employs about 250 men.

BRITISH GOVERNMENT CAPITULATES TODAY TO THE OPPOSITION

LONDON, April 12.—The British government in the house of commons today capitulated to the demands of the opposition that aid be not extended to the ex-service men by the government.

The combined votes of the Asquithan, Lloyd Georgians and labor groups rejected the resolution introduced by Stanley Bosworth. After a cabinet meeting it was decided to capitulate to the opposition.

This session was quiet today and the commons was not marked by the wild scenes that marked yesterday's session.

ENGINEERS INQUIRE REGARDING COST OF PAVING IN RANGER

Two engineers, one representing the state and the other the federal government, were in Ranger today to get figures on city paving, including the number of square yards of paving and costs.

They were F. D. Nash, division engineer of the state highway department, and F. P. Sexton, highway engineer of the United States Bureau of Public Roads. Both men operate out of Fort Worth.

The two engineers have been making an inspection of roads in Eastland county, which have been extended state and federal aid. According to Mr. Sexton, the brick pavement between Eastland and Cisco is completed except for two and one-half miles, approximately, just east of Cisco.

HIGHWAYMEN BEING SOUGHT FOR MURDER

Reported to Have Operated Near Ranger But Nothing Known of It Here.

FORT WORTH, April 12.—Two motor car bandits killed Albert Smith, a salesman, and assaulted R. B. Lacy, on a county highway in the neighborhood of Ranger, according to reports that have reached this city. Robbery is said to have been the motive. The reports reaching here are very meagre and do not indicate in what county the attack took place or if any arrests were made.

Police of Ranger and the sheriff's deputies here have no information about the death of Smith and assault of Lacy and know nothing about the arrest of any motor car bandits, it was stated at 2 o'clock this afternoon. Unless the tragedy occurred in Eastland county, however, they would not be called on to act except in the event that the bandits attempted to escape through this county. It was said that the reported attack on Smith and Lacy did not take place in Eastland county.

PECAN TREES SACRIFICED TO STRAIGHTEN STREETS HOUSTON, Texas, April 12.—Sixteen pecan trees, said to be more than one hundred years old, were condemned by the city council of Houston and will be cut down for the purpose of straightening and paving a street in the southwest section of the city.

Many protests, it is said, have been made by lovers of old trees and landmarks against the council's action in ordering that these trees be cut down.

Woman Legislator Keeps Three Vows; Would Be Sheriff

JEFFERSON CITY, Mo., April 12. Mrs. Melcene Smith, of University City, one of the first women to be elected to the Missouri Legislature, came to the sessions this year with three resolves, all of which she kept.

"One was that I would not miss a session," she said; another that I would not mar the desks in the house by placing my feet thereon, and the third that I would not expectorate tobacco juice on the floor. At the close of her first session, Mrs. Smith observed that there is no reason why the average woman, with some little experience in public affairs, should not be as efficient a legislator as the average man.





