GANG OF YOUNG SNEAK THIEVES FOUND

OIL WELL FIRE SNUFFS OUT LIFE OF 13 WORKMEN

New Gusher Near Powell Ignited By Spark. Two Persons Missing.

MEXIA, May 10.—Sixteen men were killed as the result of the explosion at the Hughes-McKie well in the Powell field yesterday afternoon, according to officials of the company here.
The dead are said to be the same as in the list of dead given out at Corsicana. A brother-in-law of Allen, the company's field superintendent, whose name was unknown and two other names unknown have been added to the death list.
It was said at the company's office that the death list might be greater.

CORSICANA, Texas, May 10.—Thirteen known dead and possibly two more is believed today the total of casualties attending the oil gusher of the J. K. Hughes Development company on the McKee lease, near Powell, which started late yesterday afternoon. No reliable information is obtainable relative to the number of men working at the well when the fire was started by a spark caused by a cable or a hammer striking a new control head. Gas and oil ignited immediately and the men were enveloped by flames before they could move.

The well had come in a few hours previously and was reported flowing more than 5,000 barrels of oil and 20,000 cubic feet of gas when the fire started. It is the third completed in the new field from a sand that lies between 2,942 and 3,000 feet deep.
Seven bodies are in the morgue, charred skeletons can be seen through the flames at the well and two persons are missing. It may be several days before the dead are definitely known, and then only after relatives and friends begin inquiring for missing men.

Steam will be used to put out the flames. It was turned on today, but will be several days, it is stated, before the flames can be brought under control. The fire is being fed constantly, both by the oil and gas that continues to pour from the well.

MURDERERS OF WOMEN, CHILDREN AND AGED MAN TO BE HANGED

IDAHO, Okla., May 10.—John Pope, confessed slayer of his wife, her father and mother and two children, and Aaron "Red" Harvey, his confessed accomplice, were today in district court here sentenced to death.
Pope and Harvey were brought plying his father and Harvey to the house where the killing took place, was sentenced to the penitentiary for life.

SLAYER OF HIS BUDDY AT SAN ANTONIO MEETS DEATH IN SAME MANNER

SAN ANTONIO, May 10.—Harold Ricker, 23, was shot to death last night within a few feet of where, four months ago, he shot and killed C. T. Stahl, a soft-drink stand proprietor and his buddy in the world war.
W. O. Stevers, 39, a soft-drink proprietor, was arrested and placed in jail. He said he acted in self defense, making the same plea as did Ricker after shooting Stahl.

DISHWASHER CUTS COOK IN FIGHT OVER EINSTEIN THEORY

SAN FRANCISCO, May 10.—Einstein's theory was reported to have been the cause of a battle with butcher knives between a cook and a dishwasher in a restaurant here. Steve Shesko, the cook, in upholding Einstein relatively, suffered severe lacerations and was removed to a hospital, while James Riley, the dishwasher, insisting on the soundness of Newton's doctrine of gravitation, is in the county jail charged with assault with a deadly weapon.

WHY SINGLE OUT MOVIE HOUSES? ASKS PALMER

Public Sentiment in Ranger Shown Favorable to Sunday Amusements.
"Why should the moving picture houses be singled out for prosecution when the law lays that cigarettes, cigars, candies and other things must not be sold on Sundays," said W. B. Palmer, manager of the Lamb and Liberty theatres, relative to the court action pending against him in the county court at law in Eastland.
Mr. Palmer said he would fight the six warrants issued against him by County Attorney W. J. Barnes for operating his two theatres last Sunday. Warrants were issued against his moving picture operator and ticket seller at both playhouses and two against himself as manager of both amusement places. He was compelled to put up a total of \$1,500 in bonds. The case comes up for jury trial on May 14.
"If the county prosecutor is insistent on enforcing this law why shouldn't he be impartial about it?" Mr. Palmer said. "Why take a part of the statute and enforce it and ignore the rest of it?"
"If public sentiment were against it here or evenly divided, I would not attempt to keep the theatres open. A year and a half ago, I sent out questionnaire cards, the names taken from the Ranger Gas company's list, and 862 were for Sunday shows and 34 against."

Mr. Palmer and the managers of Eastland theatres are circulating petitions today, which will "request" and "demand" that if the county prosecutor enforces the Sunday law against moving picture shows, that he also "exercise the same energy" he exercises in closing the moving picture shows in Eastland and Ranger in the enforcement of the Sunday law as against any and all persons in every locality of the county who may engage in labor, who may sell cigars, tobacco, cigarettes, cold drinks of any kind, excepting only the statutory exceptions, and that such prosecutions be filed in the county court at law.
The petition, as written up by attorneys for the moving picture men, declares it to be their belief that the matter of Sunday moving pictures is purely a local one and "should be handled by the local authorities for each community."

DR. COOK BARRED FROM USE AND BENEFIT OF POSTOFFICE SERVICE

WASHINGTON, May 10.—A fraud order, designed to curtail oil stock activities of Dr. Frederick A. Cook, of North Pole fame, today was issued by the postoffice department.

PANHANDLE CATTLEMAN IS CLAIMED BY DEATH

CHILDESS, May 10.—G. M. Klutts, prominent Panhandle cattleman, was found dead in his automobile, six miles north of Childress, this morning. Death was due to apoplexy.
Klutts was driving alone from Spearman last night. A passing autoist saw his lights burning as the car stood on the road but did not stop to investigate.

HOUSE WANTS EXPLANATION BY YOUNGBLOOD

Would Know Meaning "Rabbit Chasers" and "Hill Billies."

AUSTIN, May 10.—By adopting a resolution this morning, the house ordered Hull Youngblood of San Antonio brought before the bar of the house at 8 o'clock tonight for the purpose of explaining his alleged remarks made before the Salesmanship club of San Antonio. In these remarks he is alleged to have called the legislators a bunch of "rabbit chasers" and "hill billies."
It is further alleged that he referred to corruption.
By an order of the court of Criminal appeals, Youngblood was released from a 20-day sentence in the Travis county jail last Tuesday.

BRITISH WARSHIP SENT TO MURMANSK TO WATCH RUSSIANS

LONDON, May 10.—A British gunboat, the Harebell, has been ordered to Murmansk to prevent Russian interference with British vessels outside the three-mile limit, with orders to "use force if necessary," Ronald McNeill, under secretary of state for foreign affairs announced in the House of Commons today.

CHIROPRACTOR BILL TO COME UP TODAY

AUSTIN, May 10.—The senate passed finally the Pollard bill requiring bonding of private employment agents and the Rogers bill changing time of holding court in Collin and Grayson counties. The McMillin bill for licensing chiropractors and creating a board of chiropractic examiners will probably be reached during the afternoon.

West Texas May Adopt Emblem for Exclusive Use

SAN ANGELO, May 10.—West Texas may have a flag, all its own. The West Texas Chamber of Commerce will be asked at its fifth annual convention here, May 21, 22 and 23 to adopt an emblem which has just been designed by W. E. Blanton of San Angelo.
The design is an oblong, the upper half of blue and the lower of red with an orange semi-sun rising just above the dividing line of the field colors, the radiant beams sparkling into the blue background.
The model was exhibited to convention committee heads at a mass meeting at the courthouse and received enthusiastic recommendations. Many of these flags will be made for the convention, to be used to decorate public and private business houses. An unusually large replica will adorn the walls of registration headquarters.

LEGISLATURE GIVES THANKS TO RANGER FOR HOSPITALITY

AUSTIN, May 10.—A resolution expressing appreciation to Ranger and Eastland and other towns of Eastland county and to Fort Worth and Waco for courtesies extended during a recent junket trip to the oil fields was adopted today by the house.

DUPONT RESIGNS FROM GENERAL MOTORS CORP.

NEW YORK, May 10.—General Motors corporation today announced the resignation of Pierre S. Dupont as president of the executive board. Alfred Sloan Jr., was elected as his successor.

LEGISLATURE TO BE CALLED SOON AGAIN, FORECAST

Senate Unable to Pass All Appropriation Bills. Governor Silent.

AUSTIN, May 10.—The Texas legislature will be called into another session next Wednesday, the day after the present session ends, Senator A. E. Wood, chairman of the finance committee said today. It will be impossible to complete the appropriation measures at this session if nothing else, Senator Wood said.
Representative J. E. Quaid, chairman of the appropriations committee, said there is a possibility that the house will complete its work. He said the house must work in record time if another session is not called.
Governor Neff has not yet made known his attitude towards a third called session of the thirty-eighth legislature.

SUGAR FUTURES MAY FINALLY BE TAKEN TO U. S. SUPREME COURT

NEW YORK, May 9.—Federal Judge Mayer denied the government's petition today to restrain the New York Coffee & Sugar exchange from dealing in sugar futures.
WASHINGTON, May 9.—The refusal to restrain the New York Coffee & Sugar exchange from dealing in sugar futures may result in a direct appeal to the supreme court, it was said today at the attorney general's office.

CHINA PARLEYING WITH BANDITS FOR CAPTIVES' RELEASE

WASHINGTON, May 10.—China has not stopped punitive measures against the Shantung bandits and is attempting to obtain release of Americans and other foreign prisoners by peaceful means to prevent injury to the captives, the state department was officially advised today.

COUNTY-WIDE ASSOCIATION OF MERCHANTS PLAN

Proposal Meets With Favor And to Have Further Consideration.

EASTLAND, May 10.—Karl E. Jones, secretary of the Retail Merchants' association of Ranger, is expected tonight at a meeting in the city hall to complete organization of a retail merchants' association in Eastland.
At the same time further consideration will be given to the proposition made by Mr. Jones at a meeting here last night, when he suggested a county organization to include Ranger, Eastland and Cisco, illustrating his idea by using a chart to show how such an organization would work.
Ranger, with her four years' experience and with a functioning association, would be made the headquarters of a county organization, with clerks, files and offices in each of the two cities. Mr. Jones stated that Ranger had several thousand dollars worth of equipment which would be at the disposal of the three cities jointly.
To finance such an organization, it was suggested that Ranger pay 50 per cent of the expense, Eastland 25 per cent, and Cisco 25 per cent.

SCHWAB TESTIFIES BEFORE GRAND JURY

NEW YORK, May 10.—Charles M. Schwab was called before the grand jury yesterday to testify relative to the charge against Mrs. Myrtle B. Hayes, Boston business woman, who is alleged to have forged the iron master's name to a note for \$25,000.
It is claimed that Mrs. Hayes never had a chance to make anything out of the alleged forgery.

BOSTON WOMAN INDICTED ON CHARGE OF FORGERY

Mrs. Myrtle B. Hayes, Boston business woman, now living in this city, today was indicted on a charge of forging the name of Charles Schwab to a \$25,000 note in connection with the erection of a hotel in Boston.
Although the indictment is only on one charge, it is alleged that she negotiated 17 notes totalling \$325,000 of notes, using the name of the iron master as the endorser.

EASTLAND'S NEW CITY COMMISSION ORGANIZED

EASTLAND, May 10.—The new city commission of Eastland has been organized with Virgil T. Seaberry, Calvin Brown and N. N. Rosenquest succeeding Allen D. Dabney, F. L. Parker and John Matthews. The hold-over members are J. A. Beard and L. Perkins.
Virgil T. Seaberry was elected chairman of the board.
The resignation of Police Chief Woods was accepted, effective May 12, and J. R. Gilbreath, recently elected constable of precinct No. 1, was chosen chief of police.

TEXAN INVITED TO MEXICAN POULTRY SHOW IN JUNE

COLLEGE STATION, May 10.—Invitation to assist in conducting a poultry show and poultry and dairy short course at Mexico City in June, has been received by C. M. Evans, of the extension service of the Agricultural & Mechanical college. Exhibits for the show, it is said, will be furnished by American breeders chiefly. A committee of Mexicans is expected to be in this country soon to purchase a carload of poultry for the show also. The short course will be similar to those conducted in Texas, Dr. Evans says.

SEVEN YOUTHS UNDER ARREST, OTHERS SOUGHT

Police Seek Hiding Place of Stolen Auto Accessories and Other Articles.

With seven youths, ranging from 13 to 18 years of age behind the jail bars, and a half dozen others under surveillance, police officials are confident that the gang of thieves that has been operating "carte blanche" in and around Ranger for the last few months has been broken up. Two of the youths under investigation are under suspended sentences, the police claim.
County Attorney Barnes was sent for at 11 o'clock this morning by Justice of the Peace Roger Fenlaw to take charge of the investigation.
The depredations committed by the youths operating in gangs of two, three and four each, reached a climax the first of this week when three automobiles, including a Pierce-Arrow, Velie and Buick, at the Export Refining company plant at Tiffin were severely damaged in the boys' hunt for brass and automobile accessories.

Cars Are Maulled.

The Pierce-Arrow, the property of B. B. Walker, president of the refinery, was damaged to the extent of \$500 to \$600, according to a report made by Officer Wade Swift. The Buick and Velie were also much damaged. Rocks were used by the boys in ripping and knocking the metal loose from the automobile. The cars were stripped when none of the company men were at the plant.
Harry Britton, foreman at the plant, will come to the police station this afternoon to tell of the damage done.
A confession was obtained from two of the arrested youths by Assistant Chief Leonard Davenport this morning after four of them spent part of the night in the jail following their roundup at 2 o'clock this morning by Officer Jim Ingram. They were routed out of bed in a Ranger rooming house and brought to the station.
Some of the boys are yet under the age for compulsory education. They didn't seem to mind the reformatory sentences staring them in the face if convicted. Whenever a visitor approached the cell doors there was an immediate cry for cigarettes, or a "stump" of a cigarette if the visitor didn't have a whole one.

Two More Arrests.

Later in the morning Officers Daniels and Swift caught up with two youths carrying a gunny sack up the Texas & Pacific railroad tracks near the T. & P. boiler house. They were told to halt. An investigation of the sack revealed a quantity of joints and valves and also a "yellow dog" used by drillers.
The two boys told a reporter they had been told by a T. & P. railroad employe they could have the metal if they gave him half of the proceeds.
Seeking Hiding Place.
Late this morning none of the arrested boys would tell the police the hiding place of other things believed by the police to have been stolen by them or their confederates. Tires, motorometers, spot lamps and cushions, stolen promiscuously from automobiles on the street and in the garage have not yet been located. Police believe these things are concealed in brushwood or a dugout in the Ranger vicinity. Some of it probably has been disposed of, they say.
A visit to the yard of a Ranger junk dealer this afternoon is planned by the police. Besides the railroad metal recovered, a fire extinguisher and 250 feet of electric cord were found by Officer Ingram when making the arrests at the boarding house. One of the boys confessed to selling 90 pounds of stolen lead this week, officers said. He told the officers where he sold it.
Auto Driver Arrested.
The trip to Tiffin to strip the three autos of anything with a market value was made in a Hudson super-six, borrowed by one of the boys from a friend, telling him, according to Assistant Chief Davenport, he was going for a "ride." The ride to Tiffin. The gang paid the 18-year-old driver the sum of \$1.20 as "service car fare" one of the boys said.
On this information, the 18-year-old boy was brought to the station and lodged in jail. Still others will be implicated in the series of thefts

In the Community, in the Home, Forbid Every Day in the Week All Pleasure Wrong on Sunday

County Attorney Barnes has explained that he is seeking to close the moving picture houses in Ranger at the request of the people of Cisco.

If the majority of the people of Cisco do not want Sunday movies, or the sale of cigars, soft drinks, gasoline and the like in Cisco on Sunday it is their privilege to bar them and the people of Ranger have no objection. Therefore if a majority of the people of Ranger wish it otherwise in Ranger the people of Cisco should have no objection.

Ranger agreed to support Cisco as the location for the Texas Technological college, but was asked to do so. When Ranger wishes to have Cisco's help in bettering her morals Ranger will not hesitate to ask. When Ranger, some time ago, thought to send a delegation to Cisco to aid in forming a good government club, Cisco wired asking Ranger not to do so, insisting she was capable of looking after her own affairs, and the delegation did not go.

If Cisco wants moving picture shows closed there on Sunday it is her privilege to have them closed, but let Cisco look after her own morals. Other communities in the county are fully able to look after their conduct without the aid or advice of Cisco. If Cisco does not need or wish Ranger's help to get the Texas Technological college located there, Ranger has no intention of forcing her aid on Cisco.

The Sunday closing law in Texas was enacted at a period when saloons were kept open, and in many places vaudeville theatres were conducted as a business aid for the saloons. These were vicious shows, lured young people from the path of virtue and were not justified on Sunday or any other day in the week. The Sunday law was in-

tended to close them and also to close the saloons. The law finally closed the saloons every day in the week and even before that had frowned so heavily on the low class of vaudeville adjuncts of the saloons that most of them suspended operations.

When the Sunday closing law was amended to stop the sale of gasoline on Sundays, efforts were made in many places to enforce it, but a ruling that gasoline, being necessary to the transportation of many public necessities, comes under the head of a transportation facility, has made that portion of the law inoperative as contrary to public policy.

Sunday blue laws were enacted when it was the accepted custom of the people to devote the sabbath entirely to religious devotion. It was the belief of a majority then that any pleasure on the Sabbath was wrong and so they prohibited everything that seemed likely to give pleasure. The "Sunday closing laws" are a modification of the old blue laws, and in enforcing them the wishes of a majority of the people should prevail.

The people do not now, as formerly, believe it wrong to enjoy the Sabbath day, but they do not all agree on the latitude that may be permitted for such enjoyment. It is right that vicious amusements should be barred, but there is no justification in a few persons insisting the majority shall abide by the wishes of a very small minority in putting up bars against innocent and proper amusements. And many, perhaps a majority of the people, believe today that what is right for a weekday pleasure is proper for Sunday and what is improper for Sunday should be barred also every other day in the week.
Moving pictures, baseball and other innocent amusements oc-

cupy the people at times when they have an interval between work and sleep for recreation, change of thought and action and pursuit of pleasure. They have more leisure on Sunday than any other day; with many it is the only day for rest and amusement, for their work endures during the week from walking to sleeping. This is especially true of people living in the country; Sunday is the only day when they may enjoy a moving picture show. And young people, having more leisure, need proper amusements to keep them out of mischief.

A little more than a year ago the people of Ranger voted through the Ranger Daily Times on the question of closing the moving picture shows on Sunday and a little more than five to one voted in favor of the Sunday movies. They are open on Sunday in every large city in Texas and in every large city in the nation. Yet, because Cisco wants to be the Poo Bah of Eastland county, the people of Ranger and other communities in the county must bow to the wishes of Cisco.

God asks the people to worship Him every day in the week. The Sabbath was made for man and it is man's privilege to determine how it may best be used for man. Man is told not to work on the sabbath day, but is not forbidden to get recreation both for body and mind. God should be worshipped on the Sabbath, as on other days and even more, for worship of God is recreation, but the enforcement of blue laws is not synonymous with worship. The moving picture shows have agreed to close their doors on Sunday during the prescribed hours of worship, but Cisco is insisting her standard shall prevail rather than the wishes of a majority. Shall Ranger be ruled by Cisco?

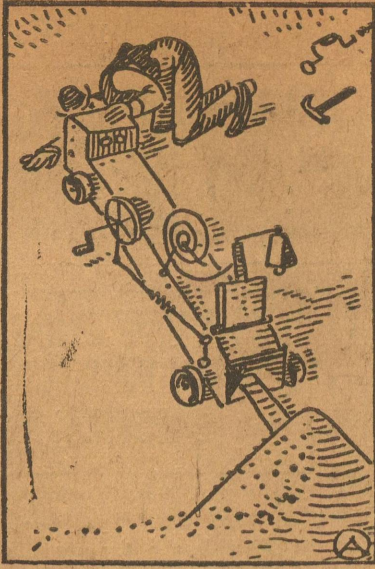
MRS. BRASHER HOSTESS TO KING TUT LUB

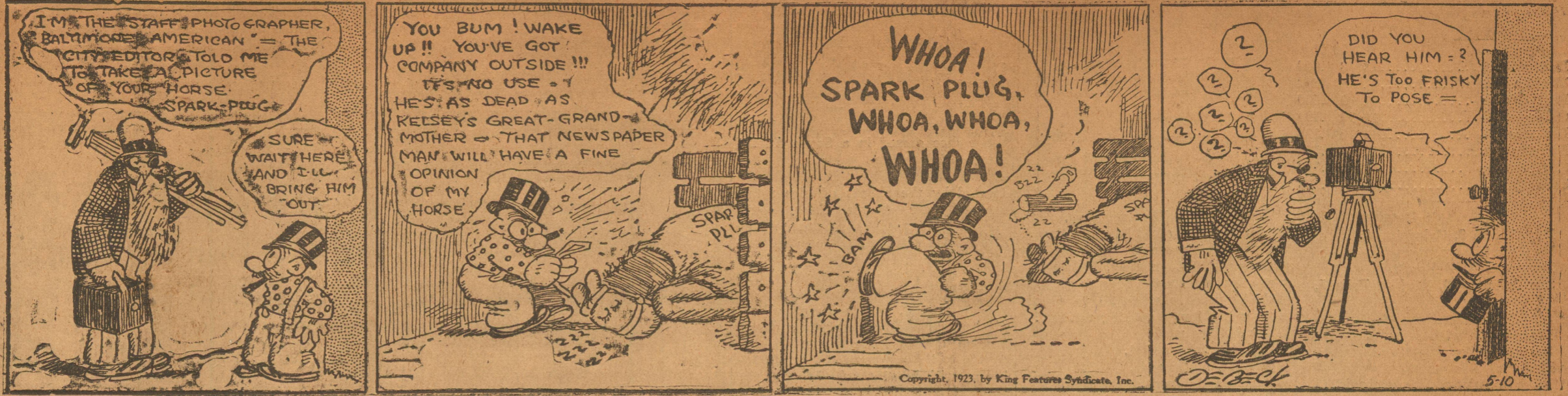

Texas Woman Urges Women of Country To Do Their Duty

ATLANTA, May 9.—Devote the coming year to a crusade that shall convince women that citizenship means an appreciation of that solemn responsibility and glorious privilege of voting, was the plea made here last night by Mrs. Pervy V. Pennybacker of Austin, Texas, before the biennial convention of the General Federation of Women's clubs.

"The women of our land have not availed themselves of the privilege of voting as they should," said Mrs. Pennybacker. "There is much to be said in extenuation, but we progress more rapidly if we deal not in excuses, but measure ourselves by strict standards. It is a disgrace that at our last general election in 1920 not 50 per cent of our voters went to the polls. I favor every club calendar printing in crimson the dates for poll tax payment, the dates for the primary and for the fall election, thus reminding the forgetful."

Mrs. Pennybacker made an appeal for the observance by the public of all laws, stressing particularly the eighteenth amendment. "Our duty is plain," she said. "If we even by our silence have countenanced the breaking of this law, the time has come for us to 'about face,' and take our full share in trying to arouse public opinion at the necessity of observance of the law. We should not only abide by the law ourselves but permit no jest to pass our lips concerning its violation by others. It has been well said: 'If a law is bad, the ideal way to secure its repeal is to enforce it.' Into the hands of women has been given the ideals of the race."

In speaking of the great desire of all to abolish war, Mrs. Pennybacker

said: "I wish we might study and prepare ourselves for a great referendum on this question, one that should have no entangling alliances. I do not know how it could be brought about, but if we want a thing bad enough, if we work diligently and pray fervently, the way will be open."

BUY IT IN RANGER

RANGER POLICE SHOW VIGILANCE, HERE IS PROOF

Seventeen Arrests in one Night Net Large Amount In Fines.

He marshalled them all to the police station. The six men "paired off" in paying fines of \$20.70, two of which were paid promptly. The third will pay today, he said.

Officer T. C. Weeks while walking his beat on Main street saw a driver "sweep down" Main street without regard to the safety of others. Catching up with him later, he brought the automobile law violator to the station. The man paid his fine and was released.

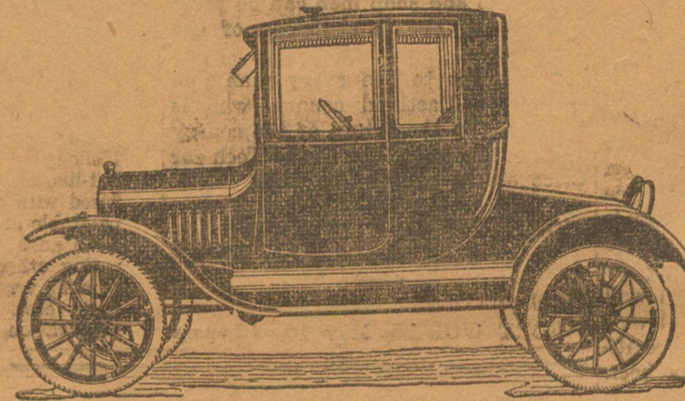
